

CARS Data Dictionary for Final Data File (as of September 30th, 2011)
Paid CARS Transactions

This data file contains transaction information entered electronically for each of the 677,238 CARS transactions that were paid by the conclusion of the program for a total of \$2,851,092,000. Please note that confidential commercial information concerning dealers and privacy information concerning consumers have been redacted. The redacted information includes banking information and identification (franchise) codes for dealers; names, home addresses, telephone numbers, and State identification numbers for consumers; and the last six characters of the new vehicles' vehicle identification numbers (VINs).

The data file is being provided in two formats: comma delimited text (ASCII) with a quotation mark (“) as a text qualifier and Microsoft Access. The comma-delimited file can be read into most standard statistical and database software. The comma-delimited file also has the field names in the first row. The comments section below notes whether each field is numeric or text. All fields that sometimes contain text should be treated as text fields to avoid errors during importing. The Microsoft Access file is readable with the appropriate Microsoft Access software. Both files contain the same 42 fields, which are described below.
