After each mobilization, the data including crashes, citations, and other citations will be analyzed and compared to address successes and the need for improvements, if applicable. The DPW-OHS together with GPD-HPD, the GIAA-APD, and PAG-PPD will conduct high-visibility "publicized" enforcement activities with strong occupant restraint use throughout the fiscal year. For the past five years, traffic fatalities have occurred in the central part of Guam and have been identified as high-crash areas. They are: Routes 1 and 14 (Tamuning, Tumon, and Harmon); Route 4 (Sinajana and Chalan Pago); Route 8 (Mongmong, Toto, and Maite); and Route 16 (Barrigada). DPW-OHS are guided by the NHTSA Countermeasures That Works (2020, 10th Edition.)
