Mission Statement

To reduce the number and severity of traffic crashes in Indian Country by supporting Education, Enforcement, and Engineering, as well as safe tribal community programs.

Vision Statement

To create a safe tribal community environment where roadways in Indian Country are safe for all.

Introduction

According to the 2010 U.S. Census, the United States is home to 308,745,538 people. Of these individuals, approximately 2,932,248, 0.9%, identify themselves as American Indian and/or Alaska Native. Consistent with the general population in the United States, the largest age group for American Indian/Alaska Natives is 35-44 years of age. These American Indians/Alaska Natives represent over 560 Tribes throughout the country.

Despite their small ethnicity numbers, American Indians/Alaska Natives continue to be killed and injured in traffic crashes at rates that are 2 to 3 times that of other ethnic groups and that of the national average.

Because the Tribes that comprise the Indian Nation are geographically spread throughout the United States, it is extremely difficult to affect change in motor vehicle deaths in each of them. Each Tribe is unique in its heritage, language and lifestyle. The lack of motor vehicle crash data and Tribal reporting are areas of continual struggle.

The FY13 Request for Proposal (RFP) was mailed to the Tribal Leaders of all federally recognized Tribes in the United States in February 2012. Prospective applicants were required to submit proposals no later than May 1, 2012. The IHSP received 43 tribal project proposals for FY13.

A Selection Committee met in May of 2012 to review and score all proposals. This Selection Committee was comprised of representatives from the National Highway Traffic Safety Administration, Bureau of Indian Affairs Indian Highway Safety Program, Indian Health Service, Office of Justice Services, and a representative from the New Mexico Highway Safety Office. 34 Tribal highway safety projects were included in the FY13 Highway Safety Plan submitted to NHTSA for final approval. NHTSA approved 34 Projects for funding. One additional Police Traffic Services project was funded in February of 2013. The approved IHSP projects for FY13 consisted of 34 enforcement grants, for Tribes in 11 different states, in the program areas of Police Traffic Services and Overtime enforcement. The IHSP also issued one grant award for an Impaired Driving Court grant. These Tribes included some of the largest Tribes in the country. All data provided is based upon statistics submitted from 35 Tribal projects.

The IHSP functioned during FY13 with a Program Director, Program Coordinator, a Finance Analyst, and one (1) Law Enforcement Assistant. In June of 2013, a Law Enforcement Liaison and a Law Enforcement Assistant were hired by the IHSP

FY13 Required Reports

In FY13, the IHSP staff was tasked with managing 35 Tribal projects throughout the year. Each month, the Tribal projects were required to submit a narrative report on the progress of their individual Performance Measures/Targets as well as a Request for Reimbursement.

FY13 IHSP 402 Expenditures

The IHSP expended a total of **\$3,109,941.54*** in FY13 for Tribal Highway Safety Projects, BAT Mobile operation and maintenance costs, and Planning and Administration.


IHSP Targets for FY13

Overall Program Target:

To reduce death and injury rates resulting from traffic crashes among Indian Tribes and on the reservations within the United States.

To reduce the number of fatalities on reservations in Indian Country by 5% from the 2009 FARS number of 172 to 163 by the end of FY13.

According to the FARS numbers, MVC fatalities (total number of deaths) among American Indians/Alaska Natives decreased significantly from **531** in 2009 to **438** in 2010. MVC fatalities "On Indian Reservation" for 2010, declined from 172 in 2009 to 102 in 2010.



In FY13: 34 Tribes reported a total of **80** motor vehicle crash (MVC) fatalities on their reservations. **47 (58.75%)** involved alcohol, **33 (41.25%)** involved excessive speed and **47 (58.75%)** of the people killed were not wearing seat belts.

In FY12: There were **63** reported MVC fatalities from the 26 Tribes funded by IHSP. In FY11: **68** MVC fatalities were reported from 33 Tribes.

In FY13: The 3 Tribes with the highest number of MVC fatalities reported (total of 25) were:


Cheyenne River Sioux Tribe (South Dakota) - 10 fatalities

Rosebud Sioux Tribe (South Dakota) -Salt River Tribe (Arizona) - 8 fatalities7 fatalities

These 3 Tribes accounted for 31% of the total of 80 fatal MVCs reported to the BIA IHSP.

In FY12: The 3 Tribes with the highest number of MVC fatalities in FY12 (total of 27) were:




These 3 Tribes alone accounted for 36% of the 68 motor vehicle crash fatalities.

In FY11: The 3 Tribes with the highest number of MVC fatalities accounted for 42% of the 63 MVC fatalities.


These 3 Tribes accounted for 42% of the 63 motor vehicle crash fatalities.



In FY13: The 34 funded Tribes reported a total of **4,012** motor vehicle crashes, of which **945** (23.53%) were injury crashes. **531** of the crashes involved alcohol and **285** were speed involved.

In FY12: The 26 funded Tribes reported a total of **3,012** motor vehicle crashes, of which **709** were injury crashes.

In FY11: 33 funded Tribes reported a total of **3,727** motor vehicle crashes, of which **905** were injury crashes.



Planning & Administration:

The Target of the BIA IHSP is to effectively administer highway safety funds, offer technical assistance to all Tribes requesting assistance and monitor funded projects.

The BIA IHSP planned to initiate highway safety related projects with not less than 35 Tribes by the end of FY13.

The BIA IHSP awarded 35 project grants in FY13. During the fiscal year, services and technical assistance were provided to approximately 75 Tribes throughout the country. This was accomplished by providing media materials for the impaired driving and safety belt mobilizations.

Impaired Driving:

The BIA IHSP planned to reduce the incidence of impaired driving by increasing DUI/DWI/OWI arrests by all funded traffic activity within the participating Tribes by 15% from the FY11 total of 1,053 to 1,211 by the end of FY13.

34 Tribes funded in FY13 reported **5,145** DUI/DWI/OWI arrests. This Target was substantially exceeded.


Performance Measure to be tracked: Number of fatalities involving a driver or motorcycle operator with .08+ BAC.

In FY13: 34 funded Tribes reported a total of **30** *fatalities (37.5%) with drivers with .08+ BAC. In FY13: 34 funded Tribes reported a total of* **47** *fatalities (58.75%) that were alcohol related.*

In FY12: 26 funded Tribes reported a total of **26** fatalities (41%) with drivers with .08+ BAC. *In FY12:* 26 funded Tribes reported a total of **40** fatalities (63%) that were alcohol related.

Occupant Protection:

The BIA IHSP planned to increase safety belt usage rates in Indian Country from the "National" Indian Country rate of 68.5% to 71% by the end of FY13.



In FY12, Preusser Research Group, Inc., shared the safety belt estimate for the "Indian Nations" report with IHSP staff. The overall safety belt use had increased to **68.8%**.

Preusser Research Group, Inc., has completed the FY13 safety belt survey and the results will be released after the beginning of 2014.

The BIA IHSP planned to increase the number of Tribes participating and reporting in the *Click It or Ticket* national mobilization from 30 to 50 by the end of FY13.

40 Tribal and BIA police agencies signed up to participate in the **Click It or Ticket** national safety belt mobilization and reported statistics on activity reports.

Performance Measure to be tracked: Number of seat belt citations issued during grant-funded enforcement activities.

In FY13: The 34 Tribes funded by the BIA IHSP reported issuing a total of **5,166** *safety belt violations and* **907** *child passenger safety violation citations throughout the project year.*

In FY12: The 26 Tribes funded by the BIA IHSP reported issuing a total of **3,173** safety belt violations and **696** child passenger safety violation citations throughout the project year. **Police Traffic Services:**

The BIA IHSP planned to reduce the number of speed related fatalities on Indian Reservations by 10% from the FY11 total of 38 to 34 by the end of FY13.

In FY13: The 34Tribes funded by the BIA IHSP reported a total of **33** speed-related motor vehicle fatalities on their reservations during the project year.

In FY12: The 26 Tribes funded by the BIA IHSP reported a total of **14** speed-related motor vehicle fatalities on their reservations during the project year.

The BIA IHSP planned to increase the number of citations issued for speed by 10% from the FY10 total of 33,802 to 37,182 within the participating Tribes by the end of FY12.

In FY13: 34 Tribes funded by the BIA IHSP reported **32,754** *speed citations being issued during the project year.*

In FY12: 26 Tribes funded by the BIA IHSP reported **31,037** *speed citations being issued during the project year.*

The BIA IHSP planned to increase the number of citations issued for other moving violations (excluding speed and DUI) by all funded traffic activity by 10% from the FY11 total of 11,522 to 12,674 by the end of FY13.

In FY13: 34 Tribes funded by the BIA IHSP in FY13 reported **34,705** traffic violation citations, substantially exceeding the target.

In FY 13: Number of motorcyclist fatalities reported by the 34 funded Tribes was 2. In FY13: Number of un-helmeted motorcyclist fatalities was 2.

In FY12: Number of motorcyclist fatalities reported by the 26 funded Tribes was **4***. In FY12: Number of un-helmeted motorcyclist fatalities was* **3***.*

Performance Measure to be tracked: Number of drivers age 20 or younger involved in fatal crashes.

In FY13: **12** fatalities involving drivers age 20 or younger were reported by the Tribes In FY12: **6** fatalities involving drivers age 20 or younger were reported by the Tribes. In FY11: 14 fatalities involving drivers age 20 or younger were reported by the Tribes.

Performance Measure to be tracked: Number of pedestrian fatalities.

- In FY13: Number of pedestrian fatalities reported by 34 Tribes in FY13 was 14.
- In FY12: Number of pedestrian fatalities reported by 26 Tribes in FY12 was 7.
- In FY11: Number of pedestrian fatalities reported by 33 Tribes in FY11 was 8.

Traffic Records:

The BIA IHSP planned to establish TR systems, collecting all traffic crash data on not less than 10 reservations and to update and implement the goals of the multi-year Traffic Records Strategic Plan, as submitted to NHTSA, based on the Section 408 application and to conduct an Indian State Traffic Records Assessment by the end of FY13.

The BIA IHSP will continue coordination with the IHSP Tribal Traffic Records Coordinating Committee, which is represented by the IHSP, NHTSA, CDC, Federal Highways Administration (FHWA), Indian Health Service and Tribal agencies to develop a multi-year Tribal Traffic Records Strategic Plan.

IMPAIRED DRIVING Program Area

The BIA Indian Highway Safety Program has over the years funded many projects aimed at reducing the high rates of drinking and driving on the reservations. We also remain committed to providing training, educational materials and equipment necessary to assist tribal law enforcement officers and police departments in their efforts to remove drunk drivers from the roadways.

All funded projects in FY13 signed a commitment to participate in all national traffic safety campaigns. Tribes were also required to participate in, and report on, the *"Don't Shatter the Dream"*, Indian State Impaired Driving Mobilization. Funded Tribes participated by conducting checkpoints, saturation patrols and/or enhanced enforcement. Extra funding was added to each project budget for high visibility enforcement throughout the year.

Each of the tribal projects funded in FY13 had an alcohol related performance measure.

Impaired Driving Program Area Target:

The BIA IHSP planned to reduce the incidence of impaired driving by increasing DUI arrests within the participating Tribes by 15% from the FY11 total of 1,053 to 1,211 by the end of FY13.

In FY13: 34 Tribes funded by the BIA IHSP in reported 5,145 DUI/DWI/OWI arrests.
In FY13: 34 Tribes reported conducting 224 checkpoints.
In FY13: 26 Tribes reported conducting 1,316 saturation patrols.

In FY12: 26 Tribes funded by the BIA IHSP in reported 4,056 DUI/DWI/OWI arrests.
In FY12: 26 Tribes reported conducting 213 checkpoints.
In FY12: 26 Tribes reported conducting 1,610 saturation patrols.

In FY11: Funded Tribal projects (33) reported conducting **216** checkpoints. In FY11: Funded Tribal projects (33) reported conducting **1,460** saturation patrols.

The White Earth, Leech Lake, and Upper Sioux Tribes in Minnesota and the Shoshone-Bannock Tribe in Idaho could not conduct sobriety checkpoints as state law does not permit but did participate in the saturation patrols.

Note:

For each Tribal project, the Reservation Population and Land Base information is from *Tiller's Guide to Indian Country*, updated with 2010 Census data with the exception of the Ramah-Navajo and Upper Sioux Tribes.

AL-13-02 – BIA OJS (Office of Justice Services)

Obligated Amount: \$100,000.00 Amount Expended: \$32,171.04

Target:

To provide support for the continued operation and maintenance of the Breath Alcohol Testing (BAT) Mobiles purchased for use in Indian Country which will result in decreased alcohol related motor vehicle crash injuries and fatalities within the participating Tribes.

The BIA IHSP purchased four (4) BAT Mobiles for Tribal use in FY10. It was a collaborative effort between the BIA IHSP and BIA OJS District II (Muscogee, OK), OJS District IV (Albuquerque, NM) and District V (Billings, MT – 2 BAT Mobiles).

At the beginning of FY13, one of the BAT Mobiles from District V-Billings was moved to OJS District I (Aberdeen, SD). This allowed for a total of approximately eighty (80) Tribes to have access to the BAT Mobiles in these four OJS Districts.

The purchase of these BAT Mobiles has allowed Tribes to more effectively combat drunk drivers on the reservations and to decrease alcohol related motor vehicle crash injuries and fatalities within the participating tribes in OJS Districts I, II, IV and V.

The BAT Mobiles were utilized in the four BIA OJS Districts at sobriety checkpoints and were made available for viewing to Tribal community members and school students during health fairs and public safety days.

The BAT Mobiles in Districts I and IV were out of service because of mechanical issues for part of the project year. This is felt to be due to the age of the BAT Mobiles.

AL-13-03 – Menominee Tribe (Wisconsin)

Grant Award: \$185,000.00 Amount Expended: \$40,285.14 Reservation Population: 3,141 Land Base: 235,523 acres Road Miles: 528

This project was funded to establish an Operating While Intoxicated (OWI) Tribal Court on the Menominee Reservation.

PERFORMANCE MEASURES/TARGETS:

- 1. By the end of the 2013 fiscal year, establish an OWI dedicated court.
- 2. During the 2013 fiscal year, monitor and evaluate the number of OWI related offenses to determine an estimated number of candidates for the OWI program.

Final Report on Performance Measures/Targets:

Members were recruited in October and November of 2012 to participate in the OWI Court Steering Committee/Stakeholders.

An OWI Court and Outreach Coordinator was hired on March 11, 2013.

The OWI Court Policies and Procedures were approved by the Steering Committee in mid-July and forwarded to the Supreme Court for approval.

The Steering Committee drafted a resolution to the governing body which was accomplished in July 2013. The resolution was never sent or forwarded to the Tribal Legislature because the grant ended on September 30, 2013.

This Tribe was not funded for the OWI Court in FY14.

OCCUPANT PROTECTION Program Area

Motor vehicle crashes are the leading cause of death and injuries to Native Americans in the United States. Native Americans are killed at rates at least twice that of all other ethnic groups in this country. These high death rates can be attributed to a number of factors including the low and non-use of safety belts and child passenger safety restraint usage on the reservations.

Occupant Protection Program Area Target:

The BIA IHSP planned to increase safety belt usage rates in Indian Country from the "National" Indian Country rate of 64.8% to 67.8% by the end of FY12.

In November 2012, Preusser Research Group, Inc., shared the preliminary estimate for the "FY12 Indian Nations" report with IHSP staff. The overall safety belt use has increased to **68.8%.**

The safety belt rate for Indian Country has been steadily increasing. In 2006, the first baseline tribal reservation safety belt use rate was 55.4%. Indian Country is now at 68.8%, a 13.4% increase! While we are still lower than the national rate, there has been progress made in Indian Country.

Preusser Research Group, Inc., has completed the FY13 safety belt survey and the results will be released after the beginning of 2014. There were several factors that affected the release of the FY13 seat belt usage rates, including the government shutdown of several weeks in October 2013.

Child Passenger Safety

For several years, the BIA IHSP has collaborated with the Indian Health Service in providing child passenger safety seats for Native American children and child passenger safety support safety materials for clinics, checkpoints and fitting stations for those Tribes working with their respective Indian Health Service Injury Prevention Specialists.

In FY13, the BIA IHSP awarded four (4) Child Passenger Safety grants to the following Tribes:

- 1. Leech Lake Tribe (Minnesota) Amount Expended: \$8,000.00
- 2. Shoshone-Bannock (Idaho) Amount E

Amount Expended: \$ 9,994.27

- 3. Fort McDowell (Arizona)
- 4. Yurok Tribe (California)

Amount Expended: \$14,822.87 Amount Expended: \$2,816.96

The BIA IHSP expended a total of **\$35,634.10** on child safety seats in FY13.

POLICE TRAFFIC SERVICES Program Area

The BIA Indian Highway Safety Program has remained committed to providing the necessary tools and training that Tribal law enforcement departments need in order to effectively enforce traffic laws and ordinances.

All Tribal law enforcement agencies funded in FY13 signed commitments to participate in all national mobilizations as well as enhanced enforcement at other times of the year. Additionally, extra funding was added to each project so they could conduct high visibility enforcement throughout the year.

As we have for many years, the BIA IHSP staff depends on the NHTSA Region 6 Media Consultant to provide Public Information &Education information so information may be distributed to Tribes nationwide. It is invaluable during the national mobilizations the Tribes are required to participate in.

The BIA IHSP hired a Law Enforcement Liaison (LEL) in June of 2013. Duties include providing law enforcement technical assistance to tribes, site visits to monitor progress, training assessments, providing outreach to some of the largest Tribes not already being funded by the BIA IHSP, and assisting with reconciling the monthly tribal requests for reimbursements.

Although a majority of the LEL's time was spent assisting with reconciling requests for reimbursement, site visits were accomplished to four (4) current project Tribes in Montana. The site visits assisted the Tribes immensely in managing their highway safety grants.

In FY14, the LEL will focus on guiding project Tribes to meet their performance measures/targets as well as completeness and accuracy in their monthly requests for reimbursement.

Police Traffic Services (PTS) Program Area Target:

To reduce the number of speed related fatalities on Indian Reservations by 10% from the FY11 total of 38 to 34 by the end of FY13.

The 34 Tribes funded by the BIA IHSP in FY13 reported a total of **33** speed-related motor vehicle fatalities on their reservations during the project year. This Target was met.

To increase the number of citations issued for speed by all funded traffic activity by 10% from the FY11 number of 9,809 to 10,790 by the end of FY13.

34 Tribes funded by the BIA IHSP in FY13 reported **32,754** speed citations being issued during the project year. This Target was substantially exceeded.

To increase the number of citations issued for other moving violations (excluding speed and DUI) by all funded traffic activity by 10% from the FY11 total of 11,522 to 12,674 by the end of FY13.

34 Tribes funded by the BIA IHSP in FY13 reported 34,705 traffic violation citations, substantially exceeding the target.

To decrease the number of AI/AN motorcyclist fatalities by 5% from the 2009 FARS number of 26 to 24 by the end of FY13.

Number of motorcyclist fatalities reported by the 34 funded Tribes was 2. Number of un-helmeted motorcyclists was 2.

To decrease the number of AI/AN pedestrian fatalities by 5% from the 2009 FARS number of 82 to 78 by the end of FY13.


Number of pedestrian fatalities reported by 34 Tribes in FY13 was 14.

The Fort Peck Highway Safety project reported a decrease in motor vehicle crash fatalities from the FY11 number of 3 to 0 during FY13.

24% of the 59 crashes were injury crashes. Injury crashes did decrease from 19 in FY12 to 14 in FY13.

This tribal project underwent many project personnel changes throughout the fiscal year and may account for the reduction in DUI arrests and total number of traffic citations being issued during FY13.

LOOKING TO THE FUTURE

Overall, FY13 was a challenging and successful year for the Tribes funded by the Indian Highway Safety Program. We will continue to be dedicated to working closely with the Tribes and strive to remain in close partnership with all our traffic safety partners.

Motor vehicle crash fatalities increased dramatically within the projects funded by IHSP in FY13. Alcohol involved and non-seat belt use in the fatal crashes was 58.75%. Increased efforts in these areas will be made in FY14.

Participating tribal law enforcement programs worked overtime to aggressively enforce traffic safety and impaired driving laws in FY13. The Highway Safety Officers funded under this grant are some of the most dedicated law enforcement officers in the country and we proudly support them.

We plan to continue making dedicated efforts to meet and surpass the Performance Measures/Targets outlined in our FY14 Highway Safety Plan. With the hiring of additional IHSP personnel in FY13, we are well prepared to meet the targets and challenges in the coming year.

We will make a renewed effort in FY14 to improve the collection of traffic data as we realize this is the cornerstone of our program. Sharing of traffic statistics among all stakeholders will enable all of us to save lives.

As always, we appreciate the guidance and assistance of the NHTSA Region 6 staff. We would also like to acknowledge and thank all of our traffic safety partners.
