## Updates to Triennial HSP

### Adjustments to Countermeasure Strategies for Programming funds:

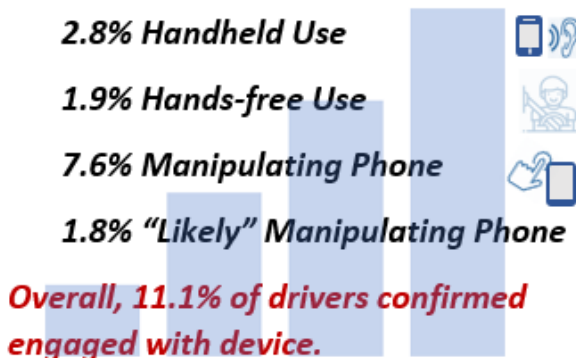
With the Triennial Highway Safety Plan (3HSP) established in FY24, there are minor adjustments to countermeasures strategies for programming funds listed below:

### Program Area: Distracted Driving Program

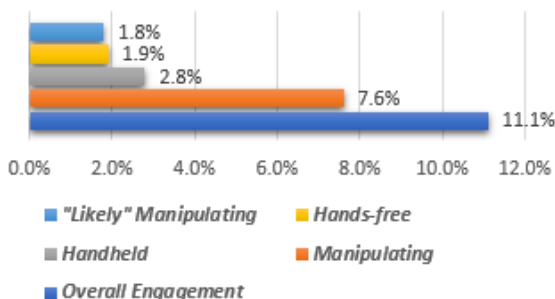
#### Description of Highway Safety Problems

The Arizona Legislative passed and the Governor signed a bill to prohibit Distracted Driving including texting, and cell phone use that took effect on January 1, 2021 statewide. In May of 2023, Preusser Research Group, Inc. (PRG) conducted an observational survey that measured driver phone distraction at 86 sites spread across the State of Arizona, specifically in the following counties: Coconino, Maricopa, Pima, Pinal, and Yavapai. Observations were completed between the hours of 7 A.M. and 6 P.M., and all sites were surveyed for 45 minutes each day, for all seven days of the week. PRG observed a total of 19,509 drivers. Drivers were counted as either: **Handheld Use** (on a call; phone on or near ear), **Hands-free Use** (on a call, but not holding phone), **Manipulating/“Likely” Manipulating Phone**<sup>1</sup> (e.g., Texting, Dialing, Scrolling). Data were explored by individual category and combined<sup>2</sup>.

#### Were there differences in usage by county?

Types of cell phone usage while driving differed by county. Handheld usage was lowest in Coconino (1.7%) and highest in Pinal County (4.6%). Hands-free usage was lowest in Yavapai (0.6%), and highest in Pima County (5.1%). Phone manipulation was observed at much higher levels in Pinal (12.8%) and Pima (11.1%) counties, thus contributing to their comparatively higher overall usage. Also, manipulation was observed far more than handheld or hands-free use regardless of county (with the exception of Yavapai, where overall usage was lowest).

<sup>1</sup> “Likely” refers to phone not seen, but manipulation or reading a message was likely based on body “language.”

<sup>2</sup> Phone use, whether handheld or hands-free, was at times paired with manipulation. For instance, drivers could be engaged in BOTH handheld use and manipulation when using a handheld cell phone on speaker mode.

### *Who used phones more?*

Female drivers were using phones at a higher rate (12.6%) than male drivers (9.9%). Van drivers, who only make up 5% of the sample, were using phones at a higher rate (13.7%) than drivers of other vehicle types. Estimated age of driver was also recorded. **The youngest drivers (judged to be under 25 years of age) were observed using a phone the most (16.8%)** and the oldest drivers (judged to be 60 or older — making up only 17% of the observed drivers) had the lowest use (3.3%). Drivers judged to be between 25 and 59 were observed using a cell phone 11.8% of the time. The youngest drivers were observed with their phone to ear 2.8% of the time and manipulating 12.5% of the time. Those aged 25-59 were seen with a phone to ear (3.4%) about as often as the younger drivers were but were seen manipulating less frequently (8.0%). The oldest age group were seen with a phone to the ear 0.8% of the time and manipulating 1.8% of the time.

### Countermeasure Strategy: Cell Phone Laws

**Program Area:**      **Distracted Driving Program**

### Countermeasure and justification

Arizona has made significant progress in enacting a statewide hands-free law, but behavioral compliance remains low compared to national averages. Observational studies and self-reported survey data suggest that Arizona drivers are using handheld devices at rates significantly higher than drivers nationwide. This countermeasure above prioritizes this issue by creating a clear, measurable benchmark to track the

effectiveness of educational outreach, enforcement, and policy initiatives. Unlike fatality-based metrics (e.g., C-1), this measure provides a behavioral indicator that can show early trends in distracted driving habits and inform more immediate interventions. 2024 Observational Data (AZ): 9.5% of drivers observed using handheld devices. 2024 Survey Data (AZ): 62% of drivers self-reported using a handheld phone while driving in the last 30 days. According to NHTSA's 2023 report, the national average for observed handheld device use among drivers was 5.7%. Arizona's rate of 9.5% is approximately 67% higher than the national average, indicating a critical area of concern for the state.

Cell Phone Laws is a 2-star countermeasure in CTW and was informed by the uniform guidelines issued in accordance with 23 U.S.C. 402(a)(2). These guidelines served as a framework for identifying effective countermeasures based on evidence-based research and best practices. By aligning the countermeasure strategy with the uniform guidelines and drawing on the insights from NHTSA-facilitated programmatic assessments, GOHS ensures that its approach is well-informed, evidence-based, and in compliance with federal regulations. This collaboration with federal guidelines and assessments strengthens the overall effectiveness and impact of the state's traffic safety initiatives.

- CTW Section 5 Distracted Driving – Cell Phone Laws (2 stars) – Several studies have examined the effectiveness of laws prohibiting texting while driving. One study evaluated the effect of a texting ban in Michigan (Ehsani et al., 2014); another examined insurance collision claims in States with texting bans compared to neighboring States without such bans (HLDI, 2011). Both studies found small *increases* in various types of crashes and collision claims following enactment of texting bans. One possible explanation is that texting drivers attempt to avoid detection by hiding their phones from view, which may result in more time with drivers' eyes off the roadway. Crash increases were also found in a study of crash data in New Jersey (Maher & Ott, 2013). While crashes declined statewide, cell phone-related crashes increased after a cell phone and texting law was enacted. In contrast to these studies, another study of 16 States found a 4% reduction in motor vehicle-related emergency department visits in States that had texting bans (Ferdinand et al., 2019).

These considerations will include 1) Public Engagement to gather community input and understand their concerns regarding traffic safety. This will help GOHS identify specific needs and priorities of the community being served and ensure funded projects align with their expectations; 2) Traffic Safety data to analyze crash data, traffic volume, and historical trends, identify high-risk areas, prevalent traffic violations, and patterns of unsafe behaviors. This data-driven approach will help prioritize projects based on the severity and frequency of incidents; 3) Directly affected communities impacted by traffic safety issues. Understanding the unique challenges different communities face will guide the countermeasure strategy; 4) Areas such as intersections, highways, or neighborhoods that experience a higher volume of crashes or unsafe behaviors. ## Countermeasure Strategy: High-Visibility Cell Phone Enforcement

**Program Area:**        **Distracted Driving Program**

### Countermeasure and justification

Arizona is behind the national curve on distracted driving behavior, despite having a strong legislative foundation. This performance measure gives the state a quantifiable, behavior-based benchmark **that** can drive enforcement, education, and funding decisions. By focusing on driver actions rather than crash outcomes alone, creates opportunities for early intervention, with HVE acting as a scalable strategy to influence compliance statewide.

### Arizona Hands-Free Law Overview

- SB 1165 (effective January 2021): Prohibits the use of handheld mobile devices while driving statewide.
- Enforced as a primary offense—law enforcement can stop and cite a driver solely for this violation.
- Penalties include fines ranging from \$75 to \$250, depending on offense count.

### Feasibility of High Visibility Enforcement (HVE):

- Arizona’s legal environment supports HVE for distracted driving, thanks to the statewide hands-free law and its primary enforcement status.
- HVE campaigns (similar to Click It or Ticket or Drive Sober or Get Pulled Over) are legally permissible and logistically feasible.
- Law enforcement agencies have already conducted HVE in collaboration with GOHS for impaired driving and seat belt use—this model is readily transferable to distracted driving with appropriate funding and public messaging.

### Recommended HVE Integration Steps:

- Partner with local police and DPS to schedule high-visibility operations.
- Coordinate with media outlets for advance and concurrent campaign messaging.
- Use data from this countermeasure to identify hotspot locations for enforcement.
- Include uniformed patrol and unmarked vehicles to observe and cite violations.

High-Visibility Cell Phone Enforcement is a 4-star countermeasure in CTW and was informed by the uniform guidelines #4 issued in accordance with 23 U.S.C. 402(a)(2). These guidelines served as a framework for identifying effective countermeasures based on evidence-based research and best practices. By aligning the countermeasure strategy with the uniform guidelines and drawing on the insights from NHTSA-facilitated programmatic assessments, GOHS ensures that its approach is well-informed, evidence-based, and in compliance with federal regulations. This collaboration with federal guidelines and assessments strengthens the overall effectiveness and impact of the state's traffic safety initiatives.

- CTW Section 5 Distracted Driving– High-Visibility Cell Phone Enforcement (4 stars) – Results from the NHTSA HVE program suggest handheld cell phone use among drivers dropped 57% in Hartford and 32% in Syracuse (Chaudhary et al., 2014). The percentage of drivers observed manipulating a phone (e.g., texting or dialing) also declined. Public awareness of distracted driving was already high before the program, but surveys suggest awareness of the program and enforcement activity increased in both Hartford and Syracuse.

When determining which projects to fund for implementing the countermeasure strategy, GOHS will consider several key factors. These considerations will include 1) Public Engagement to gather community input and understand their concerns regarding traffic safety. This will help GOHS identify specific needs and priorities of the community being served and ensure funded projects align with their expectations; 2) Traffic Safety data to analyze crash data, traffic volume, and historical trends, identify high-risk areas, prevalent traffic violations, and patterns of unsafe behaviors. This data-driven approach will help prioritize projects based on the severity and frequency of incidents; 3) Directly affected communities impacted by traffic safety issues. **Program Area:** Police Traffic Services

**Countermeasure Strategy:** Teen Safety Program

### Countermeasure and justification

Implementation of comprehensive teen driver education and outreach initiatives, including evidence-based curriculum delivery, peer-to-peer safety campaigns, and interactive community engagement focused on reducing risky driving behaviors among young drivers aged 15–19. Teen drivers (ages 15–19) remain disproportionately involved in motor vehicle crashes across Arizona. According to the most recent Arizona Crash Facts Report, drivers aged 15–19 accounted for over 8% of all crashes, despite representing a smaller percentage of licensed drivers. Contributing factors often include inexperience, distraction (especially mobile phone use), and low seat belt usage. The proposed teen safety program will address these risks through targeted education efforts in schools, community centers, and online platforms. By increasing awareness, promoting safe driving habits, and engaging youth through relatable messaging, this program aligns with GOHS goals to reduce fatalities and serious injuries among young drivers. Data-driven strategies and partnerships with schools, law enforcement, and local organizations will ensure impactful and measurable outcomes.

Youth Programs is a 1-star countermeasure in CTW and was informed by the uniform guidelines in accordance with 23 U.S.C. 402(a)(2). These guidelines served as a framework for identifying effective countermeasures based on evidence-based research and best practices. By aligning the countermeasure strategy with the uniform guidelines and drawing on the insights from NHTSA-facilitated programmatic assessments, GOHS ensures that its approach is well-informed, evidence-based, and in compliance with federal regulations. This collaboration with federal guidelines and assessments strengthens the overall effectiveness and impact of the state's traffic safety initiatives.

This countermeasure supports the development and implementation of teen-focused traffic safety programs aimed at reducing risky behaviors and preventing motor vehicle crashes among young drivers. Programs are designed to engage youth through education, peer leadership, and positive reinforcement strategies that address key safety issues such as distracted driving, speeding, seat belt use, impaired driving, and passenger safety. Rather than relying on fear-based messaging, these initiatives promote positive role models, reinforce safe driving norms, and offer teens meaningful alternatives to dangerous behaviors behind the wheel. Activities may include peer-to-peer campaigns, interactive simulations, school-based presentations, and community outreach events.

### *Changes to performance plan:*

With the Triennial Highway Safety Plan (3HSP) being established in FY25, GOHS set a 5-year rolling average targets for C-1 Core Performance Measure (Number of Traffic Fatalities), C-2 Core Performance Measure (Number of serious injuries) and C-3 Core Performance Measure (Fatalities/VMT.)

#### **The C-1 Core Performance Outcome Measure**

**Number of Traffic Fatalities** – GOHS set a 5-year rolling year target at 1,242.1. Based on the State 5-year rolling average actuals for 2020-2024, Number of Traffic Fatalities was 1,229.4. The projected target is on track to meet.

#### **The C-2 Core Performance Outcome Measure**

**Number of serious injuries in traffic crashes** – GOHS set a 5-year rolling average target at 3,547.2. Based on the State 5-year rolling average actuals for 2020-2024, Number of serious injuries was 3,675.8. The projected target is not on track to be met.

#### **The C-3 Core Performance Outcome Measure**

**Fatalities/VMT** – GOHS set a 5-year rolling average target at 1.69. Based on the State 5-year rolling average actuals for 2020-2024, Number of serious injuries was 1.67. The projected target is on track to be met.

#### **The S-1 Core Performance Outcome Measure**

**Reduce handheld device usage by 2 percentage annually** - GOHS will develop an annual performance measure target by conducting a statistical forecasting analysis of yearly state survey data. The projected target is still undetermined as the FY 2025 survey data is not available until December 2025 to foresee the projected target to be met.

GOHS will actively seek feedback to expand our partnerships with non-traditional organizations such as school districts, faith-based organizations, older driver communities, tribal, and military to ensure that our ongoing collaboration with stakeholders leads to the implementation of research-based policies at the state level.

The new Strategic Highway Safety Plan (SHSP) signifies a significant shift towards a Safe System Approach, promoting a unified Safety Culture throughout Arizona. Through these comprehensive strategies, GOHS aims to engage the community and inspire lasting behavioral change. GOHS will fund Highway Safety Plan (HSP) program areas through enforcement, public awareness, public participation and engagement, and education, while also providing more grants.

All highway safety programs—including occupant protection, pedestrian and bicycle safety, motorcycle safety, impaired driving, distracted driving, speed and reckless driving, traffic records, crash investigation, emergency medical services, and roadway safety—will be enhanced using a more robust data-driven analysis.

GOHS will collaborate with the Arizona Department of Transportation (ADOT) and the Federal Highway Administration (FHWA) to identify critical program areas where fatalities are most prominent, enabling strategic resource allocation. Our new public participation and engagement philosophy ensures that programs now focus on community-specific traffic safety needs, all supported by data-driven analysis.
