PLANNED ACTIVITY DESCRIPTION: Funding will support the delivery of science-based distracted driving presentations to Delaware teens in their schools. Data shows that in Delaware, between 2018 and 2022, there were 9,860 crashes, 90 serious injuries, and 25 fatalities involving distracted driving on our roadways. Nationally, according to NHTSA, nearly 32,483 people died in distraction-affected crashes over the ten-year period from 2011 to 2020. In 2020, there were 3,142 deaths linked to driver distraction, or 8% of all motor-vehicle crash fatalities. In 2023, the collaboration between EndDD.org and Delaware OHS resulted in 1,775 teens seeing a presentation at 7 different schools with a total of 23 presentations being given. An effort will be made to have high school students also read a K-2 distracted driving picture book in elementary schools to determine if doing so will positively affect students. The goal is to improve the number of students and presentations given over the previous two years, aiming for at least 28 presentations.

- Marketing Specialist II: Manages media relations contracts and affiliated paid/earned media for various programs. Acts as the OHS Public Information Officer.
- Community Relations Officer: Will work with the Marketing Specialist II to establish partnerships with a variety of stakeholders and engage with affected communities. Could act as PIO.
- Program Support Specialist: Aids Program Managers with planning functions and supports staff, assists with compiling and entering data, and preparing the required reports.

INTENDED SUB-RECIPIENTS: State Agency: OHS | Law Enforcement Agencies: Clayton PD, Dagsboro PD, DNREC-Natural Resources Police, Division of Alcohol and Tobacco Enforcement, DRBA Police, Dover PD, Laurel PD, Milford PD, Milton PD, New Castle City PD, New Castle County Division of Police, Newark PD, Ocean View PD, Smyrna PD, University of Delaware PD, Wilmington PD, any Law Enforcement Agency that joins the program, and Delaware State Police.

PLANNED ACTIVITY DESCRIPTION: Funds to support all aspects of the Drug Recognition Expert (DRE) program:

- Funds will be used for all associated training costs for new and current DRE's, and all associated equipment that assists with training and enforcement evaluations, and replacement of that equipment. Also, overtime costs for DRE's to respond to callouts to conduct enforcement evaluations, and other

administrative work that is related to enforcement evaluations. The funding will include staffing coverage lost due to officers attending DRE training.

- Funds will be used to cover the DRE tablets and the licensing fees for the ITSMR DRE database. This will cover replacement tablets.
- To strengthen our state's DRE program, grant funds will support online access for DREs, DRE candidates, and supporting forensic toxicologists to a specialized learning and resource platform at DrugImpairment.com. This platform delivers advanced training on drug impairment and toxicology topics through a continually expanding catalog of online courses taught by recognized experts. Participants can complete this training at their own pace, without the time and expense of travel-based instruction. Beyond courses, users will have access to additional resources designed to support the daily operational needs of DREs and toxicologists. These include expert-built Drug Resource Guides with information such as pharmacological effects, therapeutic ranges, symptom patterns, drug interactions, and supporting literature. This helps DREs and toxicologists ensure accuracy and credibility in their evaluations and courtroom testimony. Users may also consult directly with experts through a built-in "Ask an Expert" feature. For candidates preparing for DRE school, the platform includes digital study tools that make matrix practice and content review more efficient and effective than traditional handwritten methods. Interactive flashcards using spaced repetition support knowledge retention, helping candidates prepare more thoroughly in less time. This access supports recruitment and retention by offering practical ways to deepen knowledge, expand expertise, and stay engaged with developments in the field. Learning integrity features ensure participant engagement, and each course completion is documented through certificates that verify learning hours, supporting compliance with training and continuing education requirements. The cost for the upcoming grant year is \$119.99 per user, providing annual access to the training library, all resource guides, and newly added materials. For 65 users, the total investment is \$7,799.35. This approach provides cost-effective, flexible learning and reference support for the DRE and forensic toxicology community, helping maintain high program standards and strengthening the capacity for accurate, defensible evaluations statewide.
- Funds to purchase membership to the IACP DRE section member group. This will be for identified DRE's that are in a leadership type position, such as the law enforcement agency coordinator, the assistant State DRE coordinator, and the State DRE coordinator.

FY26 IMPAIRED DRIVING FORENSIC SCIENCE INSTRUMENTS

PRIMARY COUNTERMEASURE STRATEGY: Decrease impaired driving arrests and crashes by providing instruments to assist in data analysis by receiving up-to-date and accurate results

INTENDED SUB-RECIPIENTS: State Agency: Delaware Division of Forensic Science

PLANNED ACTIVITY DESCRIPTION: OHS routinely funds requests for impaired driving enforcement instruments, and maintenance of the instruments. Instruments purchased are used to support OHS enforcement initiatives. Instruments for the Toxicology Unit of the Division of Forensic Science (DFS) supports lab work completed for evidentiary purposes. DFS needs funding to purchase new instruments which will allow them to screen for a larger number of substances. The agency tests 100% of the DUI/D cases for all law enforcement in the State of Delaware. The agency also conducts testing for alcohol and drugs for fatality involved crashes. It is imperative that the Toxicology Unit functions properly to support law enforcement with DUI/D investigations. The new instruments will also assist in data analysis by receiving up-to-date and accurate results. This will also assist in effective adjudication in pending court cases.

The division is requesting to purchase two LC-MS/MSs (Liquid Chromatographs with Tandem Mass Spectrometers). The agency is also requesting funding to purchase four (4) Positive Pressure Extraction Manifolds (PPM). The following is a description of each:

Liquid Chromatographs with Tandem Mass Spectrometers (LC-MS/MSs): The sensitivity requirements to fully meet National Safety Council (NSC) Tier 1 drug testing recommendations. DFS is seeking funding to cover the cost of each of the two instruments and associated equipment, tax, shipping/handling, and installation. The new LC-MS/MSs are sensitive, selective instruments capable of quantitation and characterization of drugs at very low limits of detection in complex matrices such as blood and urine that are collected from DUI/D investigations. The instruments are needed to create and validate a comprehensive drug confirmatory panel for DUI/D-related blood specimens that meet the NSC and American Academy of Forensic Science Standards Board (ASB) published standards. The new instruments will be able to test for additional cannabinoids—in addition to Delta-9-Tetrahydrocannabinol (THC), 11-Hydroxy-THC, and Carboxy-THC, they will also be able to test for Cannabidiol (CBD), Cannabinol (CBN), and Cannabigerol (CBG). One new instrument will be used to replace an aging LC-

MS/MS that has its end of support with the vendor quickly approaching on December 31, 2025, and one will be used as a backup for the unit's THC/cannabinoid confirmatory method, which will ensure that they can keep up with their caseload with acceptable turnaround times even if one unit should go down. As such, the following drugs/drug classes will be confirmed with these instruments: cannabinoids, amphetamine-type stimulants, bupropion, antidepressants, antihistamines, and cyclobenzaprine. All of these have impairment potential and are thus relevant for an commonly seen in DFS's DUI casework. Having these two new instruments will increase the Toxicology Unit's instrument capabilities, thereby positively impacting highway safety and our motoring public in Delaware. The instruments will assist with cannabis-impaired driving, which is expected to increase since recreational sales of marijuana will begin in Delaware on August 1, 2025. DFS has the staff and technical expertise required to complete this project but lack sufficient instrumentation with the sensitivity requirements of the NSC standards. These ideal instruments come with the following components: (1) LC-MS/MS with heated IonSpray probe (2) multi-year warranty protection plan (3) Nitrogen generator (4) Personal Computer with LC-MS/MS operating software (5) All sub-components needed for installation (6) installation. Agilent Technologies has given a quote for each unit of \$1,009,325.00. There is a discount price for the purchase of two units, and it is \$912,961.86, for a total cost of \$1,108,688.14.

Positive Pressure Extraction Manifolds (PPMs): These manifolds are mechanical workstations that are used to facilitate the process of sample separation using solid phase extraction (SPE) cartridges. The equipment extracts the drugs from the blood for the testing that is completed by the LC-MS/MSs. UCT, LLC is the manufacturer of this equipment and they are an American company. The Division's current instruments are version 1.0, and the company is no longer making replacement parts. The new units updated (version 2.0) technology will come with collection racks, an installation kit, and other associated parts for a total cost of \$28,651.00.

3. The Recipient will insert the clauses of appendix A and E of this Assurance (also referred to as DOT Order 1050.2A)^[i] in every contract or agreement subject to the Acts and the Regulations.
4. The Recipient will insert the clauses of appendix B of DOT Order 1050.2A, as a covenant running with the land, in any deed from the United States effecting or recording a transfer of real property, structures, use, or improvements thereon or interest therein to a Recipient.
5. That where the Recipient receives Federal financial assistance to construct a facility, or part of a facility, the Assurance will extend to the entire facility and facilities operated in connection therewith.

4. The penalties that may be imposed upon employees for drug violations occurring in the workplace;

4. The State's highway safety program provides adequate and reasonable access for the safe and convenient movement of physically handicapped persons, including those in wheelchairs, across curbs constructed or replaced on or after July 1, 1976, at all pedestrian crosswalks. (23 U.S.C. 402(b)(1)(D))
5. As part of a comprehensive program, the State will support a data-based traffic safety enforcement program that fosters effective community collaboration to increase public safety, and data collection and analysis to ensure transparency, identify disparities in traffic enforcement, and inform traffic enforcement policies, procedures, and activities. (23 U.S.C. 402 (b)(1)(E))
6. The State will implement activities in support of national highway safety goals to reduce motor vehicle related fatalities that also reflect the primary data-related crash factors within the State, as identified by the State highway safety planning process, including:

- Participation in the National high-visibility law enforcement mobilizations as identified annually in the NHTSA Communications Calendar, including not less than 3 mobilization campaigns in each fiscal year to—
 - o Reduce alcohol-impaired or drug-impaired operation of motor vehicles; and
 - o Increase use of seat belts by occupants of motor vehicles;
 - Sustained enforcement of statutes addressing impaired driving, occupant protection, and driving in excess of posted speed limits;
 - An annual statewide seat belt use survey in accordance with 23 CFR part 1340 for the measurement of State seat belt use rates, except for the Secretary of Interior on behalf of Indian tribes;
 - Development of statewide data systems to provide timely and effective data analysis to support allocation of highway safety resources;
 - Coordination of triennial Highway Safety Plan, data collection, and information systems with the State strategic highway safety plan, as defined in 23 U.S.C. 148(a); and
 - Participation in the Fatality Analysis Reporting System (FARS), except for American Samoa, Guam, the Commonwealth of the Northern Mariana Islands, or the United States Virgin Islands
7. The State will actively encourage all relevant law enforcement agencies in the State to follow the guidelines established for vehicular pursuits issued by the International Association of Chiefs of Police that are currently in effect. (23 U.S.C. 402(j))
 8. The State will not expend Section 402 funds to carry out a program to purchase, operate, or maintain an automated traffic enforcement system, except in a work zone or school zone. (23 U.S.C. 402(c)(4))


