# Annual Grant Application Overview

This Annual Grant Application (AGA) is outlined in accordance with Code of Federal Regulations Title 23 Chapter III Part 1300 Section Subpart B.

Hawaii's AGA provides project-level information on the State's highway safety program and demonstrates alignment with Hawaii's 3HSP FFY 2024-2026, and Strategic Highway Safety Plan.

- 4) Subrecipient(s) (including name and type of organization, e.g., county or city DOT, State, or local law enforcement, non-profit, EMS agency, etc.).

# Understanding the Traffic Safety Crisis in Hawaii

Based on NHTSA's 2019 report and Hawaii's 2024 traffic fatality data and using the per capita economic cost as a broader indicator of all crash-related expenses, Hawaii likely spends approximately \$1.48 billion each year on traffic crashes.

## Top Three Contributing Behavioral Factors for Traffic Fatalities in Hawaii (2024 & 2025)<sup>1</sup>:

Based on the latest data provided from crash records, the common and most frequent contributing factors across both years for all traffic modes appear to be:

1. Speed
2. Impairment (Suspected Impairment/Alcohol/DUI)
3. Failure to Yield / Improper Crossing / Illegally in Roadway

## Addressing the Issue:

The Federal Fiscal Year 2026 Annual Grant Application will focus on several NHTSA Countermeasures That Work Strategies<sup>2</sup>, including high-visibility enforcement, community engagement, motorcycle safety, and adjudication. To reduce speed and impaired driving, the plan includes sustained high-visibility enforcement campaigns, public awareness initiatives like the #HIGOSAFE campaign, and support for adjudication and prosecution. Enhancing motorcycle safety involves expanding basic rider education, targeted enforcement, and a dedicated motorcycle safety campaign. For vulnerable road users, the plan includes focused enforcement, community-specific #HIGOSAFE campaigns, and specialized education programs to improve pedestrian and bicyclist safety.

# Executive Summary

Here's a summary of the program areas and core projects proposed for 2026, categorized by the key themes requested:

## I. Program Areas and Core Projects:

The 2026 plan encompasses a wide range of traffic safety initiatives across several key program areas:

- **Planning and Administration:** Covers the overarching administrative, fiscal, and research aspects of highway safety programs.
- **EMS (Emergency Medical Services):** Focuses on enhancing post-crash care and prehospital services through equipment upgrades and program management.
- **Impaired Driving:** Aims to combat impaired driving through increased enforcement, public awareness, education, and strengthening prosecution capabilities. A significant focus is on establishing and supporting forensic toxicology testing.
- **Motorcycle Safety:** Primarily focused on increasing the capacity and availability of Basic Rider Courses and promoting motorcycle safety education and outreach.
- **Non-motorized Safety:** Concentrates on improving safety for pedestrians and bicyclists through education, community engagement, enforcement, and public awareness campaigns.
- **Occupant Protection:** Dedicated to increasing compliance with seat belt and child restraint laws through enforcement, education, and community outreach.
- **Preventing Roadside Deaths:** Aims to raise awareness and foster a safer driving culture, specifically regarding Hawaii's Move Over laws.
- **Safe System:** Encompasses broad strategies to promote safer road users and roads, including selective traffic enforcement, distracted driving, speed management, and vulnerable road user safety.
- **Traffic Records:** Focused on improving the timeliness, accuracy, completeness, uniformity, integration, accessibility and interoperability of traffic crash data, citation, and adjudication data systems.

## II. Key Project Themes:

### A. Paid Media:

- **Impaired Driving Media Campaign (ID26-S-PM):** Comprehensive statewide impaired driving media campaign utilizing traditional, OTT, streaming, and social media.
- **Occupant Protection Paid Media (OP26-S-03):** Coordinate media campaigns and paid advertising for "Click It Or Ticket," Child Passenger Safety Week, and Heatstroke Awareness.
- **Highway Safety Grants (Pedestrian Safety Month) (NM26-S-01):** Paid advertising to educate the public on pedestrian and bicycle safety, including driver behavior messaging.
- **Distracted Driving, Speed, Police Traffic Services, e-bike, etc. Media (SS26-S-02):** Paid advertising and media to support Hawaii's new #HIGOSAFE campaign, which is dedicated to reinforcing key traffic safety behaviors, and National Mobilizations such as Distracted Driving Awareness Month, Click It or Ticket, e-Bike Safety, and other traffic safety issues.

### B. National Mobilizations:

- **Hawaii Police Department Impaired Driving Grant (ID26-H-01), Kauai Police Department Impaired Driving and Youth Deterrence (ID26-K-01), Maui Police Department Impaired Driving (ID26-M-01), Honolulu Police Department Impaired Driving (ID26-O-01):** Participation in coordinated national mobilizations like "Drive Sober or Get Pulled Over."
- **Hawaii Police Department Occupant Protection Grant (OP26-H-01), Kauai Police Department Occupant Protection Enforcement and Community Engagement (OP26-K-01), Maui Police Department Occupant Protection Enforcement and Community Engagement (OP26-M-01), Honolulu Police Department Occupant Protection (OP26-O-01):** Participation in national mobilizations such as "Click It or Ticket" and Child Passenger Safety Week.

- **Maui Prosecutor's Office – Impaired Driving (ID26-M-02):** Prioritizing efforts in prosecuting OVUII and OVUII-related offenses with a goal to maintain a high conviction rate.
- **Judiciary DWI Court (ID26-O-06):** Supporting the operation of the DWI Court Program to improve outcomes, reduce recidivism, and substance use disorders.
- **Judicial Education (ID26-S-05):** Providing funding for judges to attend national and state judicial training sessions on evolving case law and statutory requirements for OVUII cases.
- **Honolulu Police Department Traffic Records (TR26-O-01) & Maui Police Department Traffic Records (TR26-M-01):** Support improvement and integration of traffic-related data systems, including the expansion of E-citation programs for efficient issuance and transmission of citations to court systems.
- **Maui Prosecutor's Office - Traffic Records (TR26-M-02):** TSRP gaining knowledge on collecting and analyzing traffic records and crash data to support legal arguments and effectively handle evidence in court.

**Goal**


To improve timeliness, accuracy, completeness, uniformity, integration and accessibility of data in the state and counties to identify priorities for state and local traffic safety programs.

- Identify problem areas, provide recommendations for problem resolution, develop and implement action plans for the resolution of identified problems, and provide follow up to ensure that identified problems have been resolved.
- Identify and prioritize projects/project activities.

- Determine the projects/project activities funding levels for a multi-year financial-constrained Hawaii Traffic Safety Information Systems (TSIS) budget.
- Ensure TSIS projects/project activities are on schedule and targeted deadlines are met.
- Ensure measurable progress is made toward achieving the goals and objectives of the TSIS projects/project activities.
- Review, comment and approve the multi-year Hawaii TSIS Strategic Plan.
- Review and evaluate new technologies to keep the highway safety data and traffic records systems up to date.
- Represent the interests of the agencies and organizations within the traffic records system to outside organizations.
- Encourage and provide for the sharing of data amongst all members, owners, users and collectors and collaborate on interagency projects.
- Provide for adequate communication and review between members of all changes or modifications to systems, regulations, collection procedures, or usage and analysis needs.
- Approve annually the membership of the TRCC, the TRCC coordinator, any change to Hawaii's multi-year Strategic Plan, and performance measures to be used to demonstrate quantitative progress in the accuracy, completeness, timeliness, uniformity, accessibility or integration of a core highway safety database.

Whereas previous paperwork brought about such problems as illegible documents and untimely data processing, HEMSIS produces legible patient care charts that document necessary elements, are readily available and is easily accessible.</p> <p>There is a need for knowledge, measures and tools for pre-hospital services research. EMS reports provide improvements in those regards but have no information on hospital treatments, length of stay and associated medical charges. These data sources need to be linked to provide the optimal level of information to examine the causes of crashes, and the technical and medical interventions that mitigate the related injuries.</p>

Project Description	<p>From 2020-2021, Hawaii participated in the National Governors Association's <i>Learning Collaborative on State Strategies to Strengthen and Leverage Data to Address Impaired Driving</i>. As part of the learning collaborative process, Hawaii's multi-agency team worked with the TRCC to identify and leverage impaired driving data to create strategies and action plans. What we learned is that there are significant gaps in Hawaii's impaired driving data (such as which groups are affected by impaired driving), as well as deficiencies in data sharing, data access, data integration and timely reporting. The TRCC and the Hawaii team also identified key data sources, including court monitoring and Driving While Intoxicated Court, that contain invaluable, underutilized impaired driving information. We believe that this scenario would be similar in other program areas.</p> <p>In addition, there is a need for better data reporting systems that capture information about the homeless who are involved in traffic crashes. According to preliminary state data for calendar year 2024, there were six homeless persons fatalities out of a total of 51 traffic fatalities – five were pedestrians and one was a cyclist.</p> <p>The TRCC will continue to identify significant data gaps in Hawaii's traffic records systems, discuss potential solutions and work to address these gaps.</p>

**Account Title 'MOTORCYCLE/MOTOR SCOOTER OPRTRS EDUC FND':** This is the title of the fund assigned based on HRS 432:10G-107 as cited in Appendix B- Certifications, which states: Drivers education fund underwriters' fee; motorcycle and motor scooter operators education fund. (a) The commissioner shall assess and levy upon each insurer and self-insurer a driver's education fund underwriters' fee of \$2 a year on each motorcycle or motor scooter insured by each insurer or self-insurer. This fee shall be due and payable on an annual basis by means and at a time to be determined by the commissioner.

(b) There is created in the treasury of the State a special fund to be known as the motorcycle and motor scooter operators' education fund. The commissioner shall deposit the fees collected under this section into the motorcycle and motor scooter operators' education fund.

(c) The fees deposited for each fiscal year into the motorcycle and motor scooter operators' education fund, when appropriated, shall be available to the Department of Transportation for the administration of a driver's education program for operators of motorcycles or motor scooters.
