EXECUTIVE SUMMARY

The format of this annual grant application for Kentucky will be straight forward. This is the third iteration (2026) of the Annual Grant Application tied to the triennial highway safety plan (3HSP) for 2024-2026. Minimal adjustments were made versus the 2024 application.

Following is a reference listing of the strategies from the 3HSP where an abbreviation is assigned to each. This list is how the individual projects are associated with the corresponding 3HSP strategy.

The projects are grouped in the same program areas and in the same order as the 3HSP. Each project is in its own grid.

COUNTERMEASURE STRATEGY FOR PROGRAMMING FUNDS

The strategies listed below tie to the corresponding portion of the Triennial Highway Safety Plan (3HSP). The individual projects for FFY2026 are grouped by program area.

OVERVIEW AND ADJUSTMENTS

As this is the second iteration of the Annual Grant Application tied to the Triennial Highway Safety Plan, there are minimal adjustments or additions. Distracted Driving funding (405e) was awarded as a program area in 2024. The 3HSP already included countermeasure strategies and performance measures for Distracted Driving and no additional performance measures or strategies were added.

The Strategic Highway Safety Plan (SHSP) serves as an umbrella guide to increase coordination, communication, and cooperation among federal, state, and local agencies, non-profit organizations, and other highway safety advocates. The SHSP stakeholder group, led by the University of Kentucky Research Foundation, will conduct two workshops that include leaders representing all the emphasis areas. The workshops will build on the continuous success of the plan by establishing measurable goals and evaluating them consistently and comprehensively. The emphasis areas of the Kentucky Strategic Highway Safety Plan (SHSP) for 2020-2025 are:



The study showed that in cases where court monitors were present, the conviction rates of DWI/DUI offenders were higher by 10%, and the case dismissal rates were lower by 70%.</p> <p>Studies have not only indicated that monitored cases produced higher conviction rates and stiffer sentences than unmonitored cases, but court monitoring has also proven to be a highly effective method of creating ongoing productive discussions between citizens and the judiciary. This dialogue often serves to advance improvements such as identifying shortcomings in the system, recommending solutions, and advocating for change in the court's system and procedures.</p>






