

# ***OVERVIEW***

---

Aloha!

Safety continues to be the top priority for the Hawaii Department of Transportation (HDOT). Our goal is simple: to reduce the number of fatalities and injuries from traffic-related crashes in Hawaii. With this goal in mind, the HDOT will implement road safety projects that support national highway safety priorities.

During calendar year 2006, 161 people died on Hawaii's roadways, an increase of 15% from 2005. Unfortunately, many of those fatalities and the thousands more who were injured in collisions could have been prevented if drivers had obeyed traffic laws, used seat belts, elected to wear helmets, driven within the speed limit, and not driven under the influence of drugs or alcohol.

Throughout the upcoming federal fiscal year, Hawaii will continue to support and participate in national mobilization efforts in both occupant protection and alcohol countermeasures. Besides the mobilization efforts, the four county police departments will continue to enforce statutes addressing impaired driving, occupant protection, pedestrian safety and driving in excess of posted speed limits.

## **Highway Safety Office**

At the HDOT, our Highway Safety Manager, Gordon Hong, and Law Enforcement Liaison Sgt. Robert Lung with the Honolulu Police Department, continue to provide strong leadership and safety expertise across the state by helping communities and organizations target their problems and empowering them to find solutions.

The Highway Safety Office staff now includes:

- Lee Nagano, who coordinates the pedestrian and occupant protection programs, in addition to coordinating media campaigns;
- Lianne Yamamoto, who coordinates the alcohol programs and processes reimbursement requests, in addition to also coordinating media campaigns;
- Karen Kahikina, who coordinates the speeding and traffic data records programs;
- Robert Norton, who coordinates the Driver Education/GDL program;
- Scott Haneberg, who is the FARS Analyst and provides fatal data reports for the HDOT; and
- Marjorie Kazama, who is in charge of Hawaii's motorcycle programs.

The Highway Safety Office will continue to work with other departments within HDOT to further highway safety issues.

## **New Laws**

The HDOT and its partners were very successful during the last two legislative sessions. The following bills were signed into law by the Linda Lingle administration:

- **Intoxicating Liquor Violations Involving Minors**
  - Act 203 requires judges to suspend for 180 days the driver's licenses of licensed drivers under the age of 21 when the drivers have been convicted of illegal possession of liquor and if the defendant does not yet have a driver's license, to postpone eligibility until the defendant is 17 years of age or for 180 days, whichever period is longer. Also allows a judge the discretion to permit limited driving for those with a suspended license for employment or educational purposes. Effective date: June 19, 2006.
- **Booster Seat Law**
  - Act 175 requires child safety seat or booster seat usage for children over four years by less than eight year; defines "restrained." Effective date: January 1, 2007.
- **Speeding Penalties, Excessive Speeding**
  - Act 129 established the offense of excessive speeding, which is defined as 30 miles per hour or more over the speed limit or 80 miles per hour or more irrespective of the speed limit. Effective date: January 1, 2007.
- **Intoxicants, Wilson Bill**
  - Act 64 requires police to inform a person arrested for driving under the influence of intoxicants of the sanctions for refusal to submit to breath, blood, or urine test only if person withdraws consent to testing implied by operation of a vehicle on public highway or waters of the State. Effective date: January 1, 2007.
- **Use of Intoxicants While Operating a Motor Vehicle (OVUII)**
  - Act 201 increases sanction for driving with a high blood alcohol level. Effective date: July 1, 2007.

## **Alcohol Countermeasures**

During 2006, of the 161 fatalities on Hawaii's highways, 79 or 49.1% of them died in alcohol-related traffic crashes. In addition, out of 144 fatal crashes, 47 or 48.6% of them were alcohol-related.

To combat the high number of alcohol-related deaths, the HDOT, along with the county police departments, implemented a "52/12" enforcement program by increasing the frequency of sobriety checkpoints to every week. That means 52 weeks of enforcement coverage during the 12-month federal fiscal year. There is a minimum of 52 sobriety checkpoints per year in each county, which provided total statewide coverage of DUI enforcement. All four county police departments are currently participating in the "52/12" enforcement program, and will also implement checkpoints and/or saturation patrols on at least four nights during the National impaired driving campaign, August 17 – September 3, 2007.

Besides the enforcement efforts, the HDOT will continue to air a paid television and radio media campaign to raise the awareness of the program and to discourage drunk driving. During federal fiscal year 2007, we changed our slogan to the national slogan of "Drunk Driving. Over The

Limit. Under Arrest.” A new media campaign was developed and launched in time for the National crackdown that began on August 17, 2007. We will continue to air the television and radio spots through the holiday season.

In addition to our “Drunk Driving. Over The Limit. Under Arrest.” enforcement media campaign, the HDOT conducted its annual “D2” (Designated Driver) radio campaign, which focused on Hawaii’s younger drivers who frequent nightclubs and bars. The campaign ran throughout the summer from Memorial Day weekend 2007 until Labor Day – during high school graduation season and when college-age drivers are out of school and frequenting local nightspots. During the past three years, we have worked with local radio stations to set up promotions with their respective nightclubs and restaurants statewide. Participating clubs and restaurants provided free soft drinks or non-alcoholic beverage to those wearing a designated driver wristband or button during certain business hours.

Another Labor Day initiative the HDOT undertook was the distribution of Interactive Urinal Communicators. The communicators were distributed to local bars, restaurants and nightclubs that participated in our D2 campaign. The communicators helped remind patrons about the merits of using a designated driver if they were planning to drink.

### **Occupant Protection**

The June 2008 seat belt observational survey showed that Hawaii’s seat belt usage rate had increased to 97.6%, the highest ever reached in Hawaii and the first state to ever reach that mark.

We attribute the success of the “Click It Or Ticket” campaign to the continued hard work of our many highway safety partners which included: the four county police departments, the Department of Health, the Department of Education, Federal Highway Administration, the Federal Motor Vehicle Carrier Safety Association, the local fire departments, religious leaders, military bases and so many others. We continued to support the high visibility enforcement campaign with a strong media campaign (television, radio and movie theatre). We also used variable message boards statewide along our highways, distributed 100 new banners and 14,000 posters statewide.

### **Traffic Data Grants**

The HDOT also continued to fund a statewide traffic records data committee to coordinate efforts to improve overall data systems. The state’s goals in the area of traffic records is to revise our motor vehicle crash form to reflect at least 75% of MMUCC criteria, to develop the capacity to transfer citation data electronically to Judiciary and to develop transfer capability of all traffic crash forms from the four county police departments to the Department of Transportation.

### **Safe Communities Grants**

We continue to involve the community in traffic safety by offering mini-grants to fund neighborhood traffic safety projects. Each year, our Highway Safety Office staff conducts public informational meetings in each of our four counties to inform potential applicants about the highway safety program and how to apply for funding. We will continue to encourage

participation from community-based groups, and hope to involve community organizations that have not participated before.

### **2008 Legislative Goals**

Legislatively, the HDOT and representatives from the Honolulu Police Department, the Honolulu Prosecuting Attorney's office, MADD – Hawaii, and the Department of Health, are in the process of planning what legislation to introduce in 2008. We are firmly committed to submitting a bill to revoke a person's driver's license if the person commits a drug offense will be introduced. We are supporting legislation to ban passengers from riding in the bed of pickup trucks, a motorcycle helmet law and no cell phone use for those with a provisional driver's license (GDL). We are also considering the submittal of an aggressive driving bill to define aggressive driving and set higher penalties for violators.

We look forward to the implementation of highway safety projects approved by the HDOT's Highway Safety Office staff in 2008. The Highway Safety Office staff based their approval upon recommendations made by the Governor's Highway Safety Council, the county Traffic Safety Councils, and 2006 Hawaii traffic data. Hawaii's Strategic Highway Safety Plan, to be completed in late 2007 and compiled by various health and safety experts from across the state, will also be a major blueprint for future highway safety planning.

As always, we remain committed to ensuring that Hawaii's roadway users arrive at their destinations safely, and will continue to work towards reducing the number of fatalities and injuries caused by motor vehicle crashes in Hawaii. We will do our best in protecting the traveling public, whatever form of transportation they use. In turn, we will continue to stress to the public the importance of safe and responsible behavior while on our roadways.

## ***BACKGROUND***

---

The Governors of all states are mandated by federal law 23 U.S.C. 402 to establish and implement a statewide highway safety program. Hawaii Revised Statutes (HRS) delegates this authority to the Director of Transportation as the Governor's Highway Safety Representative. The HRS also establishes a Governor's Highway Safety Council to advise the Director of Transportation on highway safety issues and establishes County Traffic Safety Councils.

To assist states in carrying out the highway safety program, Congress provides annual grants for highway safety programs designed to reduce traffic crashes and resulting deaths, injuries, and property damage. A state may use these grant funds only for highway safety purposes; at least 40% of these funds are to be used to address local traffic safety problems.

Sections 2001 and 2002 of SAFETEA-LU reauthorize the State and Community Highway Safety formula grant program (Section 402 of Chapter 4 of Title 23) to support State highway safety programs. In addition, there are incentive grants to states that meet certain requirements, including Sections 405 406, 408, 410, 2010 and 2011. The grants support planning to identify and quantify highway safety problems, provide start up "seed" money for new programs, and give new direction to existing safety programs. The funds are intended to catalyze innovative programs at the state and local level, and leverage commitments of state, local, and private resources.

Hawaii expects to receive an estimated \$2 million in highway safety grants in Federal Fiscal Year 2008, October 1, 2007 to September 30, 2008:

Section 402	General Use.
Section 405	Restricted to seat belt projects.
Section 406	General Use.
Section 408	Restricted to traffic data projects.
Section 410	Restricted to alcohol projects.
Section 2010	Restricted to motorcycle projects.
Section 2011	Restricted to child safety seat projects.

## **PART 1**

### **EXECUTIVE SUMMARY (PERFORMANCE PLAN)**

## ***PROCESS DESCRIPTION***

---

During 2006, the number of traffic fatalities increased to 161, a 15% increase from 2005. There were 144 fatal traffic crashes in 2006, a 11.6% increase from 2005. Alcohol, speed and pedestrians continued to be major factors in the high fatality rate.

A brief summary of 2006 fatal data showed:

- Alcohol was involved in 70, or 48.6% of the 144 fatal crashes.
- There were 32 pedestrian fatalities, which accounted for 19.9% of our fatalities.
- Of the 32 pedestrians killed, 15 or 46.9% were 65 years or older.
- Motorcyclist fatalities decreased from 22 to 21, a 4.5% decrease from 2005.
- Of the motorcycle fatalities, 20 or 95.2% were males.
- Of the 21 motorcyclist fatalities, 17 or 80.9% were not wearing helmets.

A comprehensive data section is included in the appendix of this document.

In federal fiscal year 2008, Hawaii will continue to focus on reducing its fatal crashes in six high priority areas that have been identified as the greatest areas of concern. The state will concentrate its education, enforcement and engineering efforts in these areas, utilizing a variety of countermeasures to address the problems.

### **HIGHEST PRIORITY**

These have been identified as the most critical problem areas in highway safety in Hawaii and grants to selected projects in these areas will receive priority:

- ◆ Programs to reduce pedestrian injuries and fatalities for persons of all ages
- ◆ Programs to reduce motorcycle crashes
- ◆ Programs to reduce excessive speeding by persons ages 16-25
- ◆ Programs to increase the use of seat belts for persons 16-35 years
- ◆ Programs to enforce traffic laws in the areas of speed, occupant protection and alcohol
- ◆ Programs to reduce the number of repeat driving while intoxicated violations

### **LOWER PRIORITY**

If federal monies are available after the highest priority projects have been funded, projects in the following areas will be considered:

- ◆ Programs to involve businesses in traffic safety programs
- ◆ Programs to increase use of child safety seats (including booster)
- ◆ Programs to reduce bicycle crashes
- ◆ Equipment request by Emergency Medical Services

All of the safety projects funded in 2008 are targeted to these key programs.

The Highway Safety Section has studied both collision and enforcement data to identify the statewide problem areas in highway safety. Data that was reviewed came from the Fatal Analysis Reporting System (FARS), state motor vehicle crash report data, enforcement data from the county police departments,

motor vehicle registration and driver license information and population data.

Once the priorities were set, the Safe Community Section issued a Request for Proposals (RFP) in April 2007, which invited interested agencies and Safe Community groups to propose countermeasures. To simplify the process, the RFP included data in each priority area and requested solutions on how to help reduce injuries and fatalities. Public information meetings were held on each island to encourage groups to apply for grants and to answer questions that they had about the process. Applicants were requested to identify their specific problems with their communities using data, develop their solution and provide us with a quantifiable evaluation to show effectiveness of their programs. Copies of the RFP were mailed to all previous grantees. Notices were run in all newspapers soliciting proposals from new applicants.

A total of 56 proposals were received by the Highway Safety Section, compiled and submitted to the County Traffic Safety Councils on each island for their review and ranking, based on the needs of that island. Once the County Traffic Safety Council information was received, the Governor's Highway Safety Council (GHSC) met and reviewed all the proposals and provided recommendations to the Highway Safety Staff who made the final decision on which should be funded. The Governor's Highway Safety Representative (GR) reviewed the process and approved the recommendations made by the Highway Safety Section.

Once our Highway Safety Plan has been officially approved by NHTSA Region 9, a letter will be sent to each grantee informing them of the award and providing them with grant applications. A mandatory orientation meeting is scheduled with all new grantees to review the grant process, how to submit requests for reimbursements, project monitoring and reporting requirements.

## **STATE CERTIFICATIONS AND ASSURANCES**

Failure to comply with applicable Federal statutes, regulations and directives may subject State officials to civil or criminal penalties and/or place the State in a high risk grantee status in accordance with 49 CFR §18.12.

Each fiscal year the State will sign these Certifications and Assurances that the State complies with all applicable Federal statutes, regulations, and directives in effect with respect to the periods for which it receives grant funding. Applicable provisions include, but not limited to, the following:

- 23 U.S.C. Chapter 4 - Highway Safety Act of 1966, as amended;
- 49 CFR Part 18 - Uniform Administrative Requirements for Grants and Cooperative Agreements to State and Local Governments
- 49 CFR Part 19 - Uniform Administrative Requirements for Grants and Agreements with Institutions of Higher Education, Hospitals and Other Nonprofit Organizations
- 23 CFR Chapter II - (§§1200, 1205, 1206, 1250, 1251, & 1252) Regulations governing highway safety programs
- NHTSA Order 462-6C - Matching Rates for State and Community Highway Safety Programs
- Highway Safety Grant Funding Policy for Field-Administered Grants

### **Certifications and Assurances**

The Governor is responsible for the administration of the State highway safety program through a State highway safety agency which has adequate powers and is suitably equipped and organized (as evidenced by appropriate oversight procedures governing such areas as procurement, financial administration, and the use, management, and disposition of equipment) to carry out the program (23 USC 402(b) (1) (A));

The political subdivisions of this State are authorized, as part of the State highway safety program, to carry out within their jurisdictions local highway safety programs which have been approved by the Governor and are in accordance with the uniform guidelines promulgated by the Secretary of Transportation (23 USC 402(b) (1) (B));

At least 40 per cent of all Federal funds apportioned to this State under 23 USC 402 for this fiscal year will be expended by or for the benefit of the political subdivision of the State in carrying out local highway safety programs (23 USC 402(b) (1) (C)), unless this requirement is waived in writing;

**The State will implement activities in support of national highway safety goals to reduce motor vehicle related fatalities that also reflect the primary data-related crash factors within the State as identified by the State highway safety planning process, including:**

- **National law enforcement mobilizations,**
- **Sustained enforcement of statutes addressing impaired driving, occupant protection, and driving in excess of posted speed limits,**
- **An annual statewide safety belt use survey in accordance with criteria established by the Secretary for the measurement of State safety belt use rates to ensure that the measurements are accurate and representative,**
- **Development of statewide data systems to provide timely and effective data analysis to support allocation of highway safety resources.**

**The State shall actively encourage all relevant law enforcement agencies in the State to follow the guidelines established for vehicular pursuits issued by the International Association of Chiefs of Police that are currently in effect.**

This State's highway safety program provides adequate and reasonable access for the safe and convenient movement of physically handicapped persons, including those in wheelchairs, across curbs constructed or replaced on or after July 1, 1976, at all pedestrian crosswalks (23 USC 402(b) (1) (D));

Cash drawdowns will be initiated only when actually needed for disbursement, cash disbursements and balances will be reported in a timely manner as required by NHTSA, and the same standards of timing and amount, including the reporting of cash disbursement and balances, will be imposed upon any secondary recipient organizations (49 CFR 18.20, 18.21, and 18.41). Failure to adhere to these provisions may result in the termination of drawdown privileges);

The State has submitted appropriate documentation for review to the single point of contact designated by the Governor to review Federal programs, as required by Executive Order 12372 (Intergovernmental Review of Federal Programs);

Equipment acquired under this agreement for use in highway safety program areas shall be used and kept in operation for highway safety purposes by the State; or the State, by formal agreement with appropriate officials of a political subdivision or State agency, shall cause such equipment to be used and kept in operation for highway safety purposes (23 CFR 1200.21);

The State will comply with all applicable State procurement procedures and will maintain a financial management system that complies with the minimum requirements of 49 CFR 18.20;

The State highway safety agency will comply with all Federal statutes and implementing regulations relating to nondiscrimination. These include but are not limited to: (a) Title

VI of the Civil Rights Act of 1964 (P.L. 88-352) which prohibits discrimination on the basis of race, color or national origin (and 49 CFR Part 21); (b) Title IX of the Education Amendments of 1972, as amended (20 U.S.C. §§ 1681-1683, and 1685-1686), which prohibits discrimination on the basis of sex; (c) Section 504 of the Rehabilitation Act of 1973, as amended (29 U.S.C. §794), which prohibits discrimination on the basis of handicaps (and 49 CFR Part 27); (d) the Age Discrimination Act of 1975, as amended (42U.S.C. §§ 6101-6107), which prohibits discrimination on the basis of age; (e) the Drug Abuse Office and Treatment Act of 1972 (P.L. 92-255), as amended, relating to nondiscrimination on the basis of drug abuse; (f) the comprehensive Alcohol Abuse and Alcoholism Prevention, Treatment and Rehabilitation Act of 1970(P.L. 91-616), as amended, relating to nondiscrimination on the basis of alcohol abuse of alcoholism; (g) §§ 523 and 527 of the Public Health Service Act of 1912 (42 U.S.C. §§ 290 dd-3 and 290 ee-3), as amended, relating to confidentiality of alcohol and drug abuse patient records; (h) Title VIII of the Civil Rights Act of 1968 (42 U.S.C. §§ 3601 et seq.), as amended, relating to nondiscrimination in the sale, rental or financing of housing; (i) any other nondiscrimination provisions in the specific statute(s) under which application for Federal assistance is being made; and, (j) the requirements of any other nondiscrimination statute(s) which may apply to the application.

**The Drug-free Workplace Act of 1988(49 CFR Part 29 Sub-part F):**

The State will provide a drug-free workplace by:

- k. Publishing a statement notifying employees that the unlawful manufacture, distribution, dispensing, possession or use of a controlled substance is prohibited in the grantee's workplace and specifying the actions that will be taken against employees for violation of such prohibition;
- l. Establishing a drug-free awareness program to inform employees about:
  - 1. The dangers of drug abuse in the workplace.
  - 2. The grantee's policy of maintaining a drug-free workplace.
  - 3. Any available drug counseling, rehabilitation, and employee assistance programs.
  - 4. The penalties that may be imposed upon employees for drug violations occurring in the workplace.
- m. Making it a requirement that each employee engaged in the performance of the grant be given a copy of the statement required by paragraph (a).
- n. Notifying the employee in the statement required by paragraph (a) that, as a condition of employment under the grant, the employee will --
  - 1. Abide by the terms of the statement.

2. Notify the employer of any criminal drug statute conviction for a violation occurring in the workplace no later than five days after such conviction.
- o. Notifying the agency within ten days after receiving notice under subparagraph (d) (2) from an employee or otherwise receiving actual notice of such conviction.
- p. Taking one of the following actions, within 30 days of receiving notice under subparagraph (d) (2), with respect to any employee who is so convicted -
  1. Taking appropriate personnel action against such an employee, up to and including termination.
  2. Requiring such employee to participate satisfactorily in a drug abuse assistance or rehabilitation program approved for such purposes by a Federal, State, or local health, law enforcement, or other appropriate agency.
- q. Making a good faith effort to continue to maintain a drug-free workplace through implementation of paragraphs (a), (b), (c), (d), (e), and (f) above.

### **BUY AMERICA ACT**

The State will comply with the provisions of the Buy America Act (23 USC 101 Note) which contains the following requirements:

Only steel, iron and manufactured products produced in the United States may be purchased with Federal funds unless the Secretary of Transportation determines that such domestic purchases would be inconsistent with the public interest; that such materials are not reasonably available and of a satisfactory quality; or that inclusion of domestic materials will increase the cost of the overall project contract by more than 25 percent. Clear justification for the purchase of non-domestic items must be in the form of a waiver request submitted to and approved by the Secretary of Transportation.

## ***ALCOHOL AND OTHER DRUGS***

---

Impaired driving continues to be a major problem in Hawaii. Of the 161 traffic fatalities in 2006, 79 or 49.1% were alcohol-related.

Male drivers dominate the drinking driver problem in Hawaii with 59, 74.7% being male.

During FFY 2008, we will continue our “52/12” enforcement and media campaign. As part of the “52/12” enforcement program, Hawaii’s four county police departments have, at a minimum, one sobriety checkpoint every week of the year, which means 52 weeks of enforcement during the 12-month federal fiscal year. The county police departments will also implement checkpoints and/or saturation patrols on at least four nights during the National impaired driving campaign. Additional sobriety checkpoints will be established during major holiday periods.

## ***EMERGENCY MEDICAL SERVICES***

---

The Honolulu Emergency Services recently lost access to helicopter transportation from rural areas to the designated level-one trauma center on the island of Oahu. As a result, patients in rural areas have to be transported by ambulance, adding critical time to the “golden hour.” To increase the ability to provide the best care for patients, the Honolulu Emergency Medical Services have requested additional equipment for their ambulances that service rural areas. During federal fiscal year 2007, the Hawaii Department of Transportation approved projects to help alleviate the concerns of the rural areas.

The Hawaii Department of Transportation did not approval any emergency medical services proposals that were submitted for federal fiscal year 2008.

## ***OCCUPANT PROTECTION***

---

As of June 2007, Hawaii's seat belt usage rate increased to 97.6%, the highest in the nation. However, only 41.4% of the people killed in 2005 were using seat belts and/or harnesses.

The goal for Hawaii is to maintain front seat occupant protection usage of 97.6% in 2008 and increase the percentage of fatalities using restraints to 55%. Hawaii also hopes to increase child safety seat usage for infants from 93.4% to 98% and child safety seat usage for toddlers from 73.5% to 94%.

During 2006, 32 pedestrians were killed by motor vehicles, which accounted for 19.9% of Hawaii's traffic fatalities.

Of the 32 pedestrians killed, 15 or 46.9% were more than 65 years old. The majority of pedestrian fatalities occurred on Oahu (62.5%) followed by Hawaii County (18.8%).

The state will continue to concentrate its efforts in the area of pedestrian safety in 2008 through a coordinated education, awareness and enforcement efforts. Hawaii will also coordinate a media campaign for the Safe Routes To School program to remind drivers about Hawaii's pedestrian laws.

**Other Issues**

Our review of the HSP noted an issue requiring attention regarding a proposed project's fundability under the highway safety program:

Under Project Number AL08-02 (08-S-01), you will continue to fund "...a driver education compliance officer and half time clerk to provide monitoring of certified DOT and DOE driver education instructors..." to ensure the instructors are providing the necessary and proper instructions to students that includes education of the GDL law. Will you please clarify how this monitoring function activity relates to highway safety? Is this activity of monitoring all certified DOT and DOE instructors a normal function of the Department of Education? We would like you to provide us with the additional information regarding this proposed project by October 19, 2007.

We appreciate the efforts of the Department of Transportation's Highway Safety Office for developing this HSP to implement the federally funded traffic safety program throughout the Aloha State. You, Mr. Gordon Hong and your highway safety office staff continue to do an outstanding job in helping to make Hawaii's roadways safer for all users.
