## A. DESCRIPTION OF THE ACCIDENT SEQUENCE AND ACCIDENT PECULIARITIES

(Provide a summary of the accident sequence as well as any particular event of the accident that is noteworthy. Pedestrian injury mechanism and vehicle interaction is the focus, not pedestrian or driver culpability. Do not include any personal identifiers.)

Vehicle 1 was traveling north in the second lane of a two lane divided roadway. Cars were parked in the first lane leaving only the second lane open for travel. The pedestrian ran from east to west across the street and was struck by the front of the vehicle. The pedestrian traveled approximately 4.5 meters before final rest. The pedestrian was hospitalized for one night and the vehicle was driven from the scene.

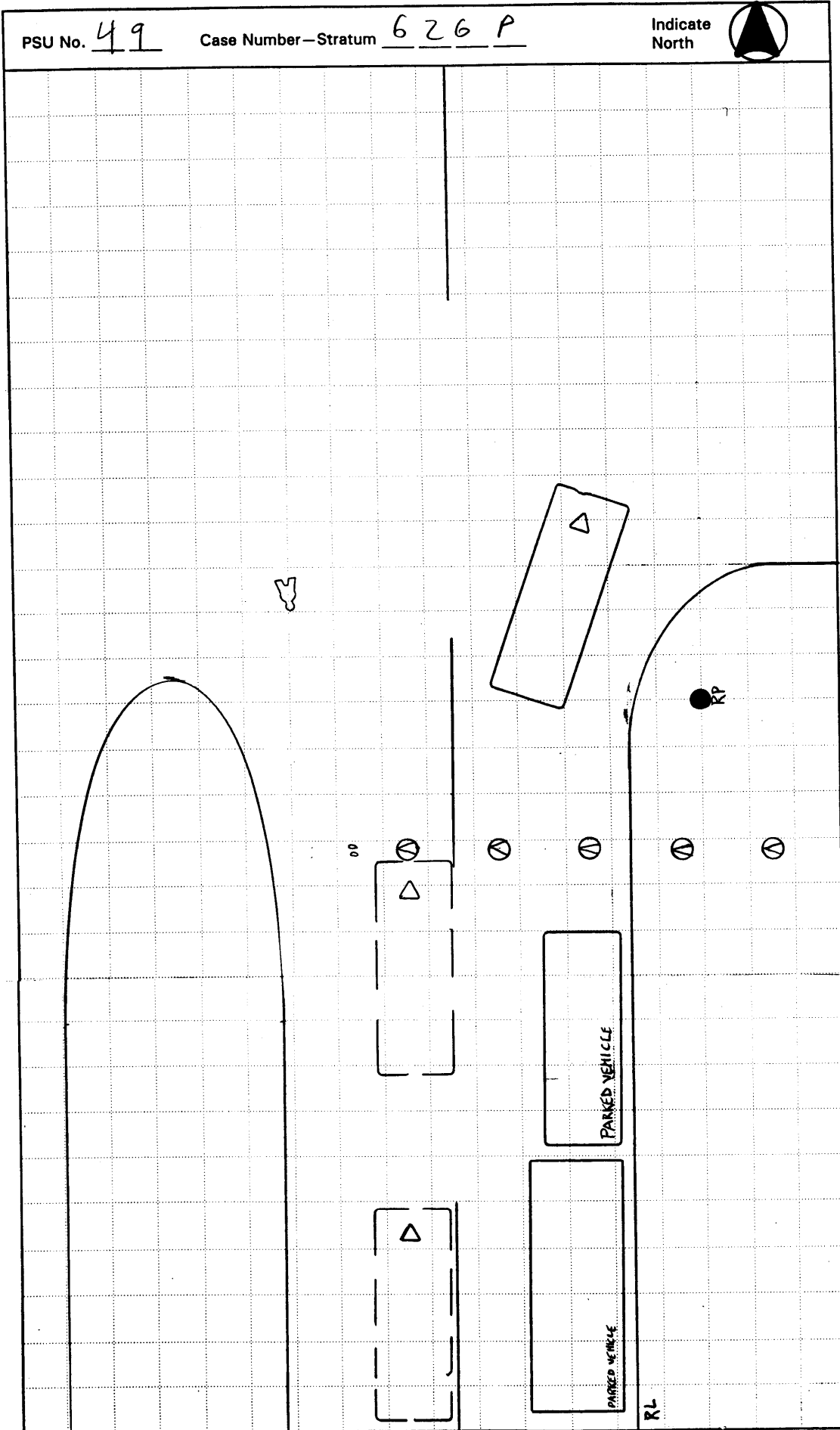

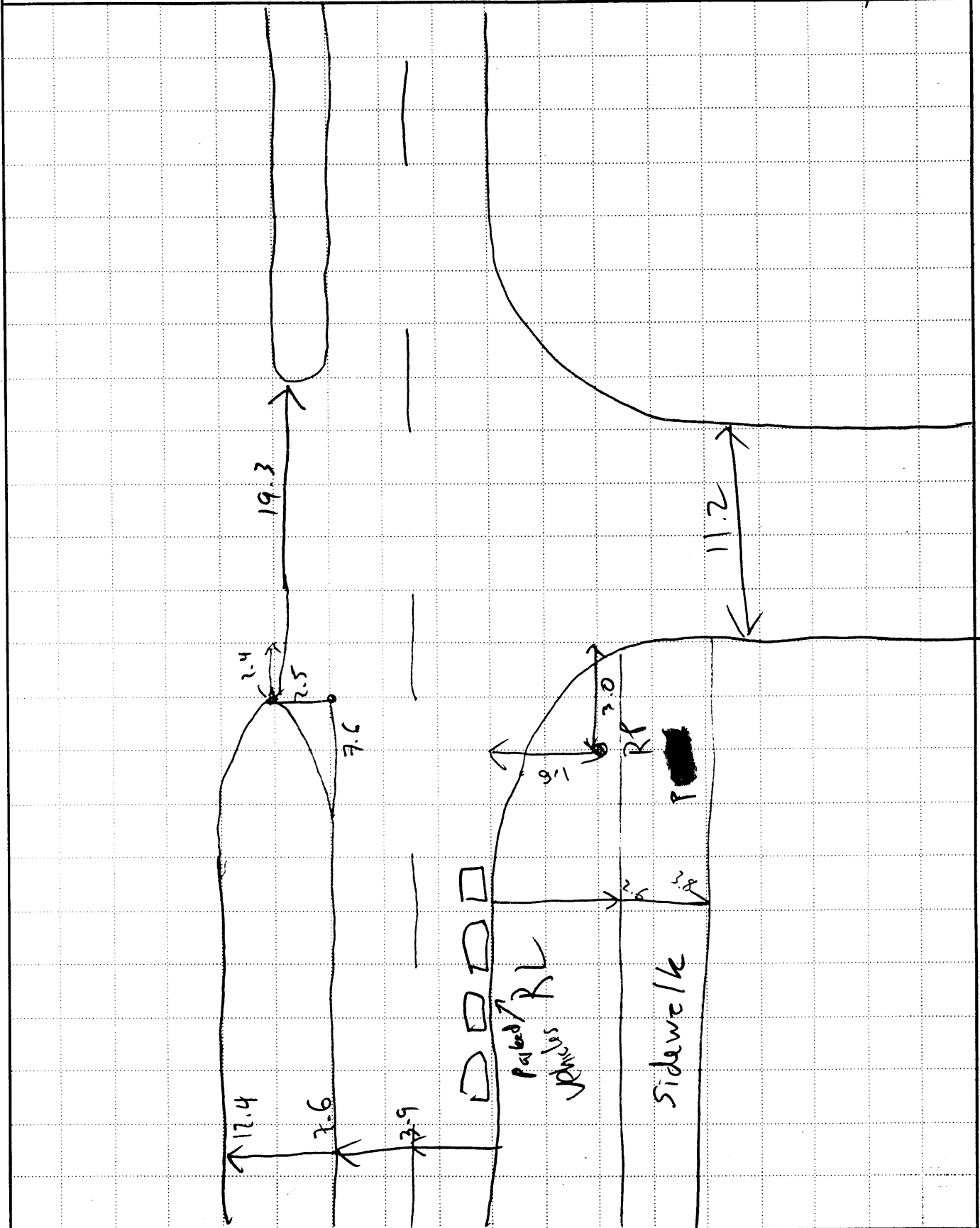

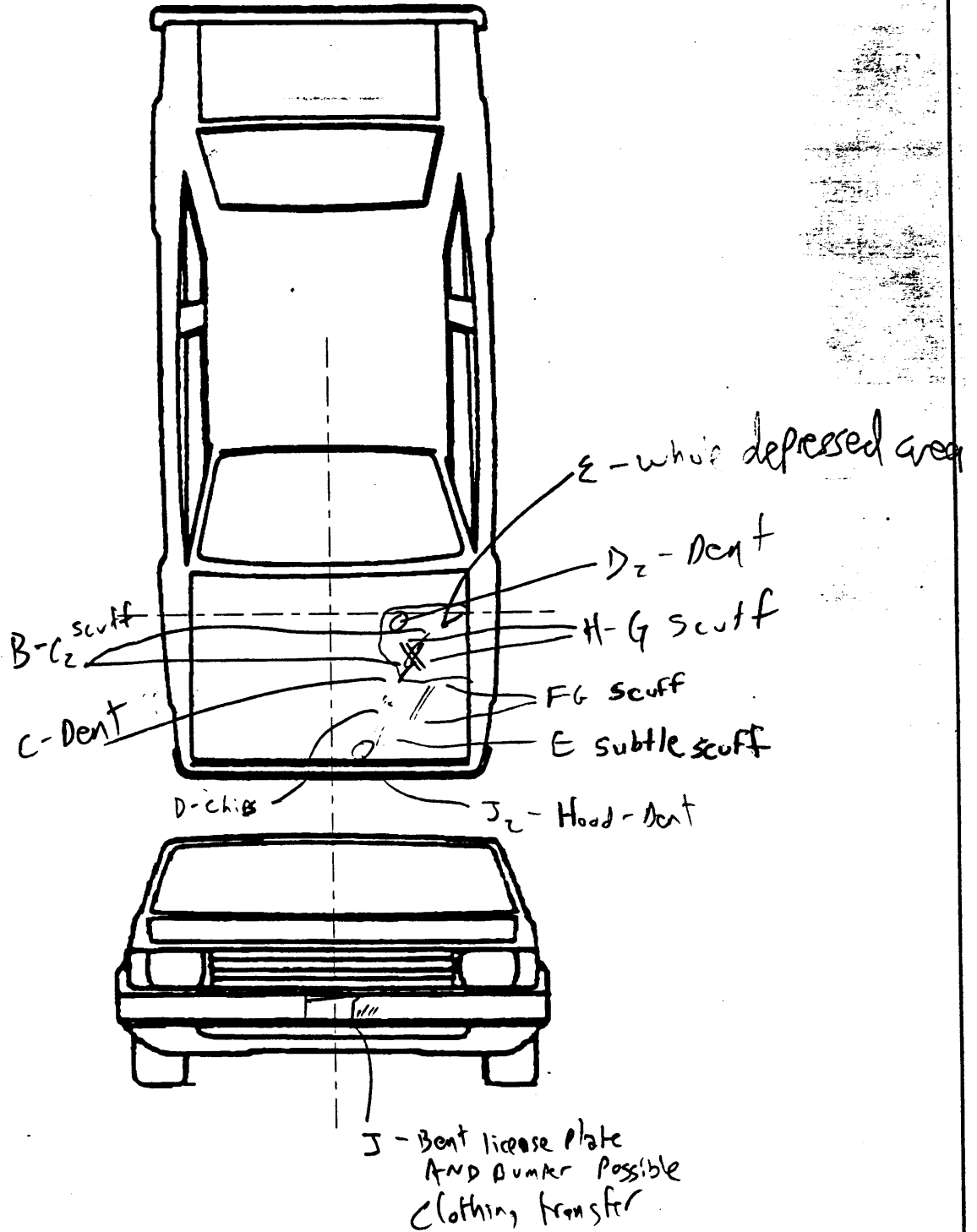

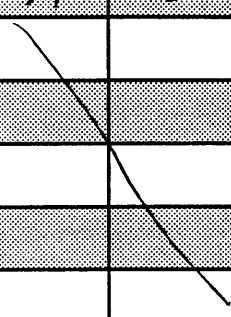
