A. DESCRIPTION OF THE ACCIDENT SEQUENCE AND ACCIDENT PECULIARITIES

Vehicle #1 was traveling North on the roadway and Pedestrian #1 was crossing the roadway in a westerly direction. The front of vehicle #1 contacted pedestrian #1 on her left side. The pedestrian rotated onto the hood of vehicle #1 and slide into the windshield. The pedestrian was carried for approximately 3 meters, where she fell off the right side of the vehicle. The vehicle came to rest immediately prior to the final rest of the pedestrian.

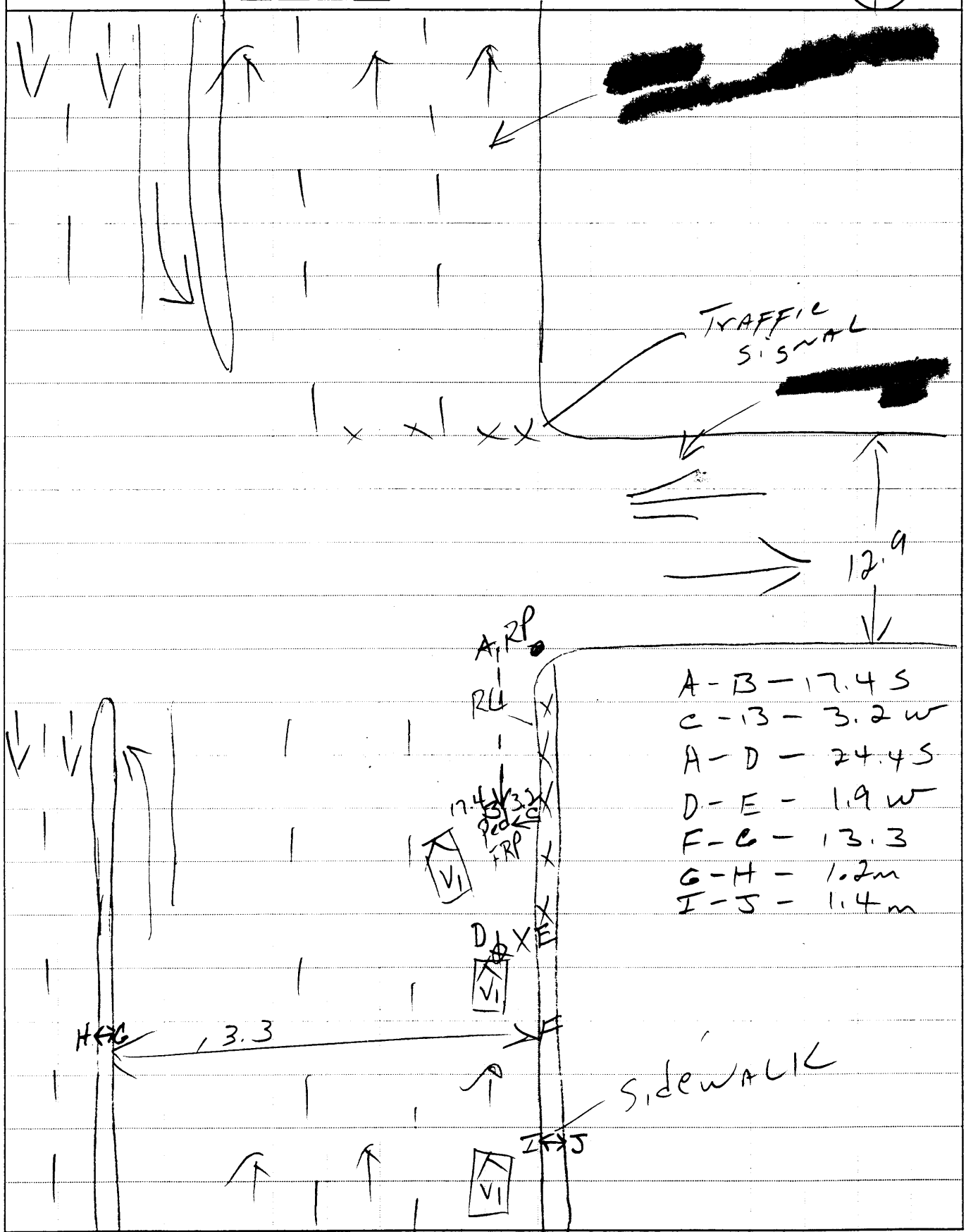

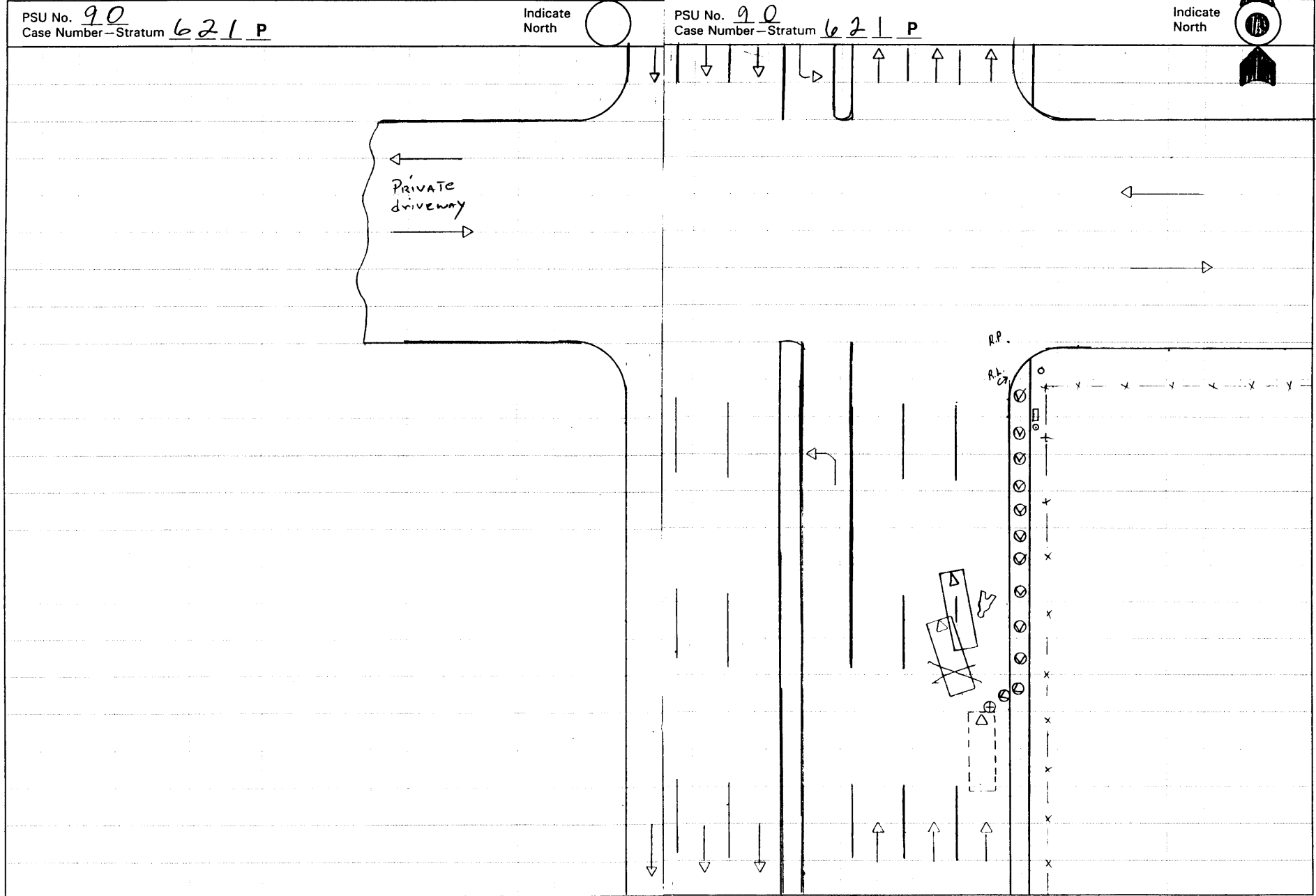

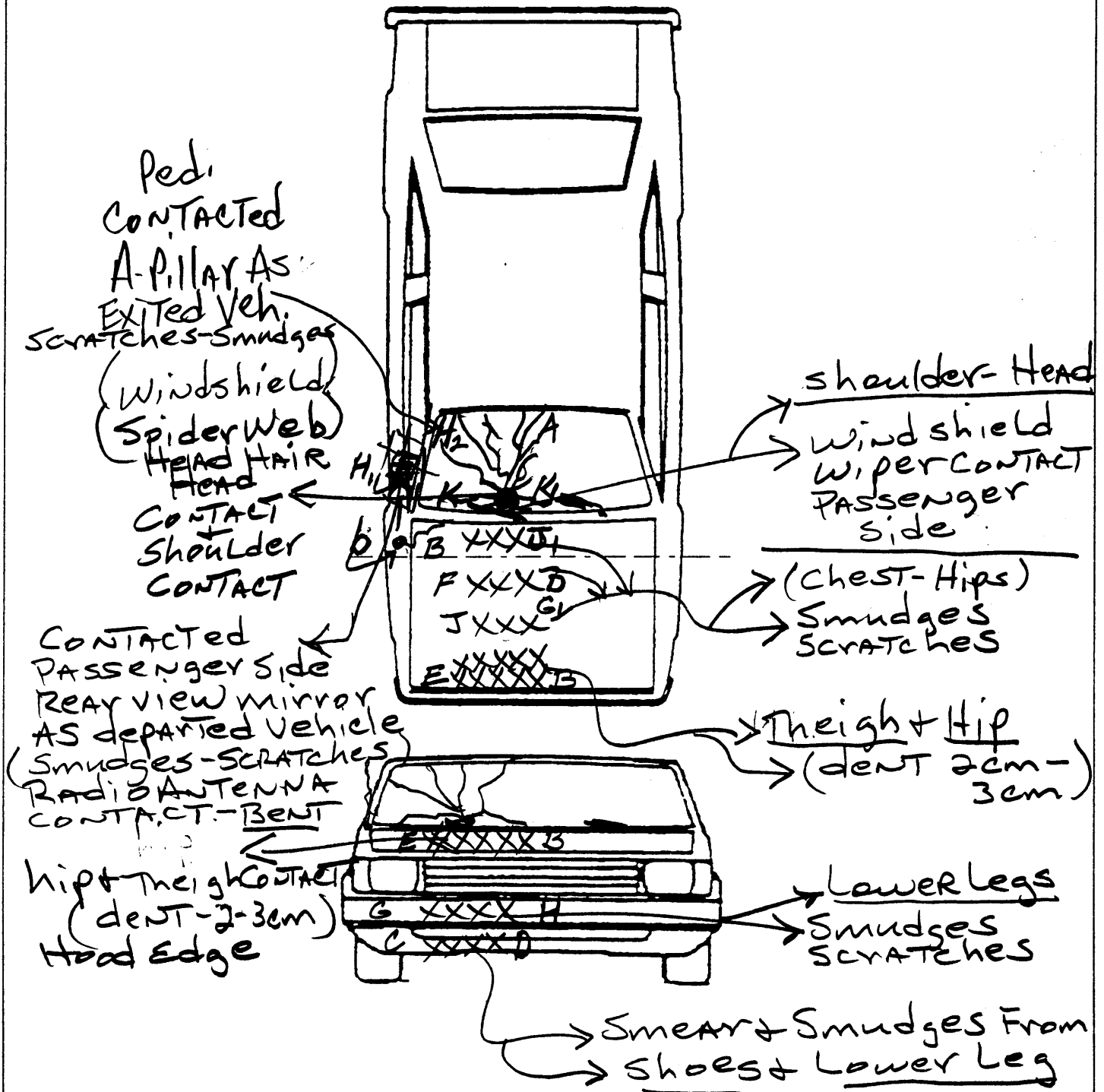

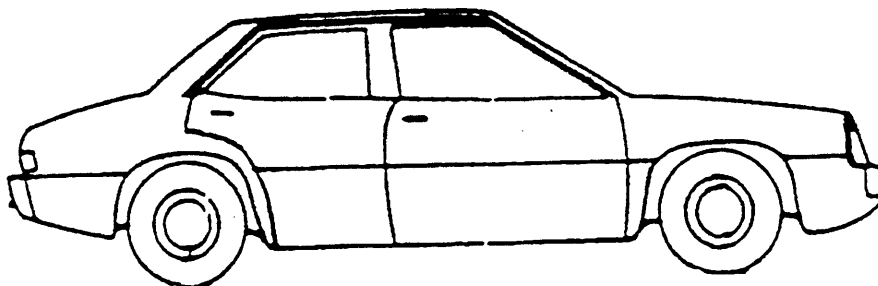
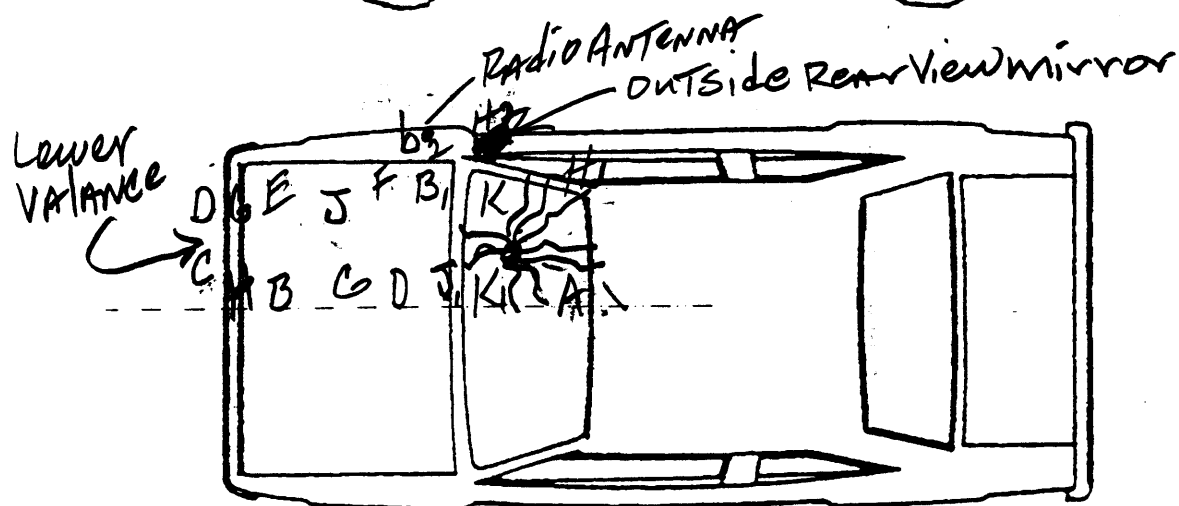
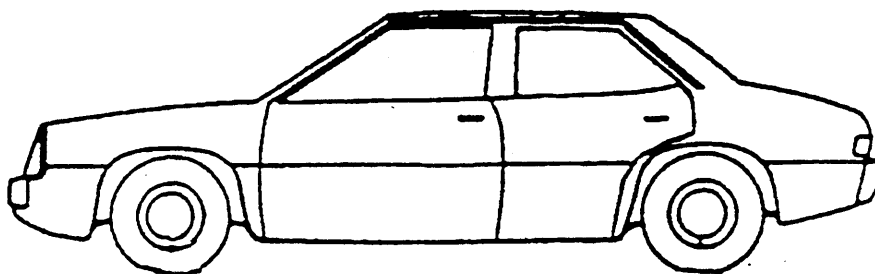
