## A. DESCRIPTION OF THE ACCIDENT SEQUENCE AND ACCIDENT PECULIARITIES

Vehicle #1 was westbound in lane 2 of a 3-lane, 2-way street and entered an intersection and stopped for opposite traffic to make a left turn as a pedestrian was jogging westbound in the crosswalk. The left side of Vehicle #1 impacted the pedestrian and spun her to the ground as Vehicle #1 stopped beyond the crosswalk.

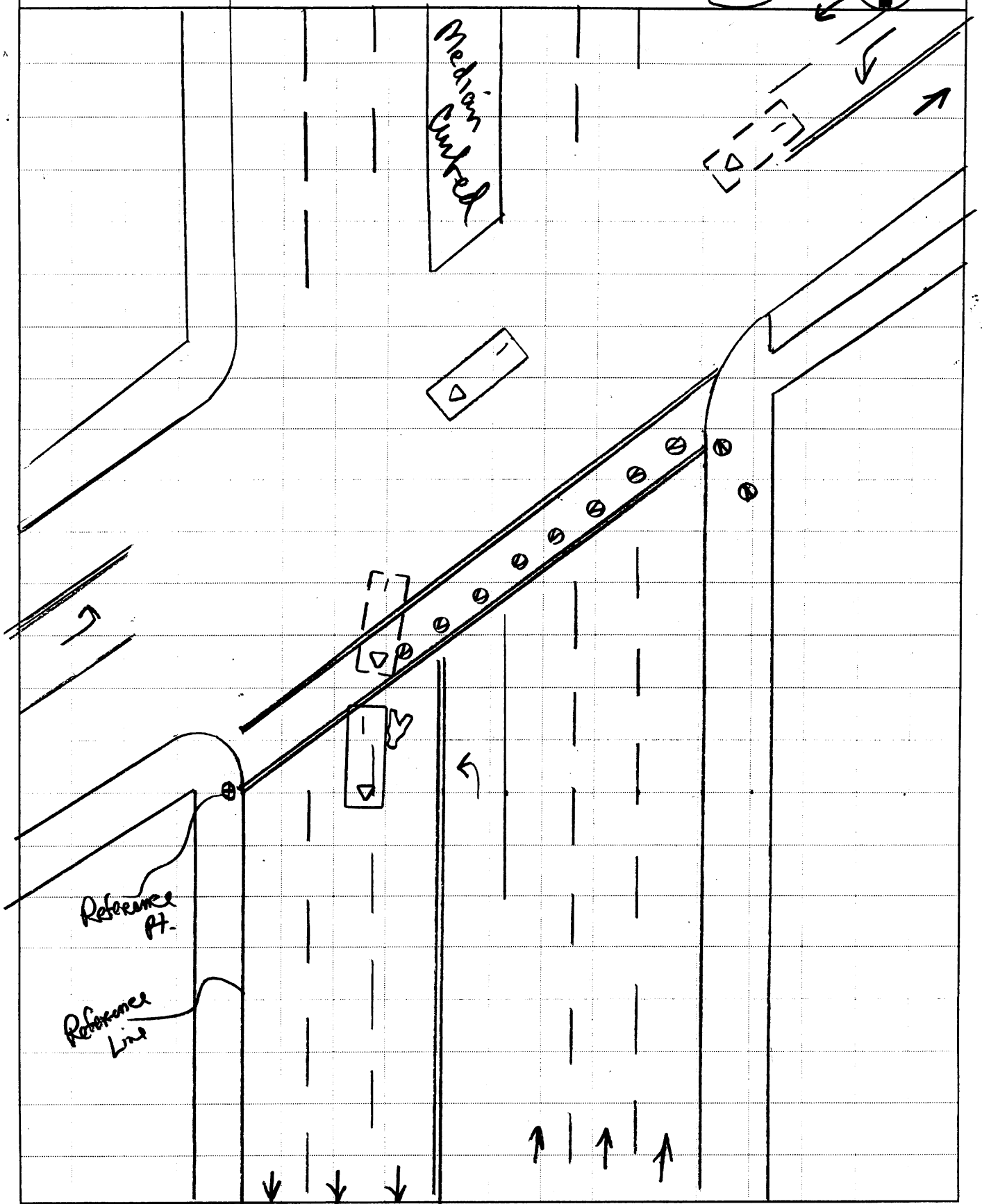
