A. DESCRIPTION OF THE ACCIDENT SEQUENCE AND ACCIDENT PECULIARITIES

(Provide a summary of the accident sequence as well as any particular event of the accident that is noteworthy. Pedestrian injury mechanism and vehicle interaction is the focus, not pedestrian or driver culpability. Do not include any personal identifiers.)

Vehicle 1 was traveling east in the center of three lanes. It is believed, despite information on the PAR, that the pedestrian was moving north across the same street. Based on the data gathered, the pedestrian was probably running. The front of V1 collided with the pedestrian in the center lane and P1 wrapped onto the hood and windshield before coming to a final rest near the north curb. The vehicle continued and came to a complete stop approximately 25 meters from final rest of the pedestrian. The pedestrian was hospitalized and the vehicle was towed.

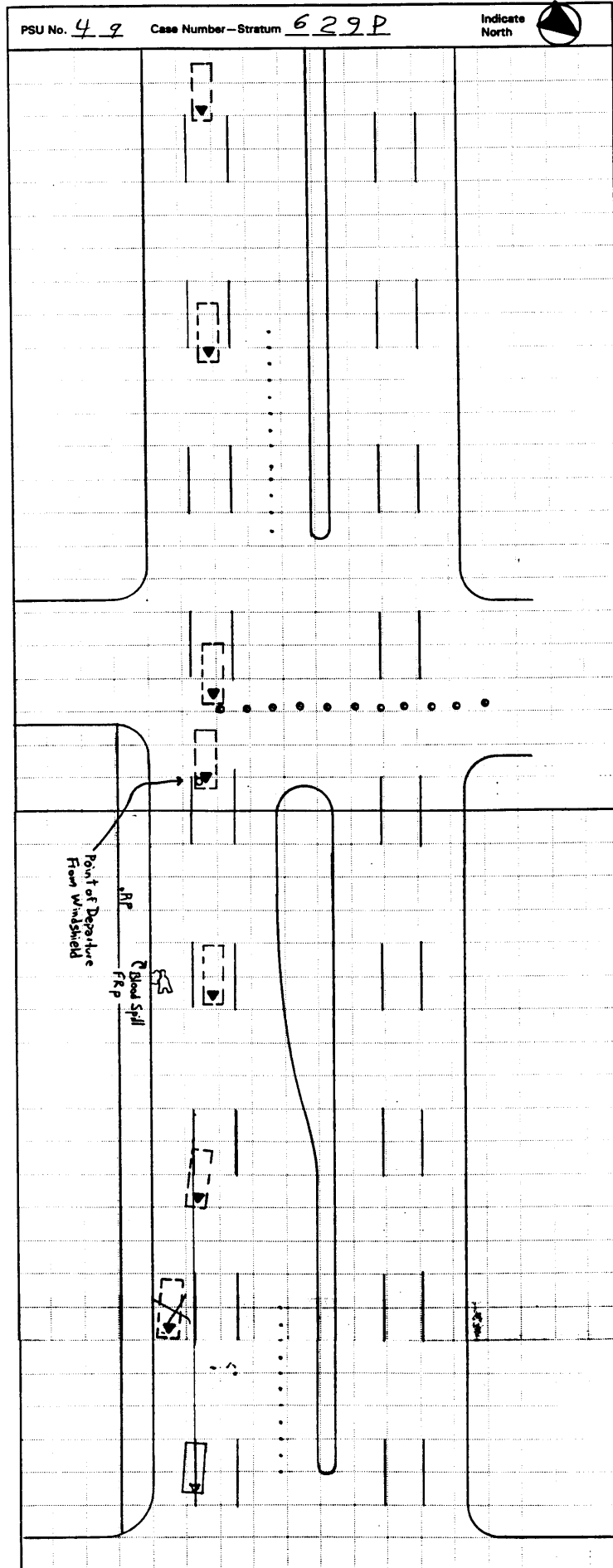

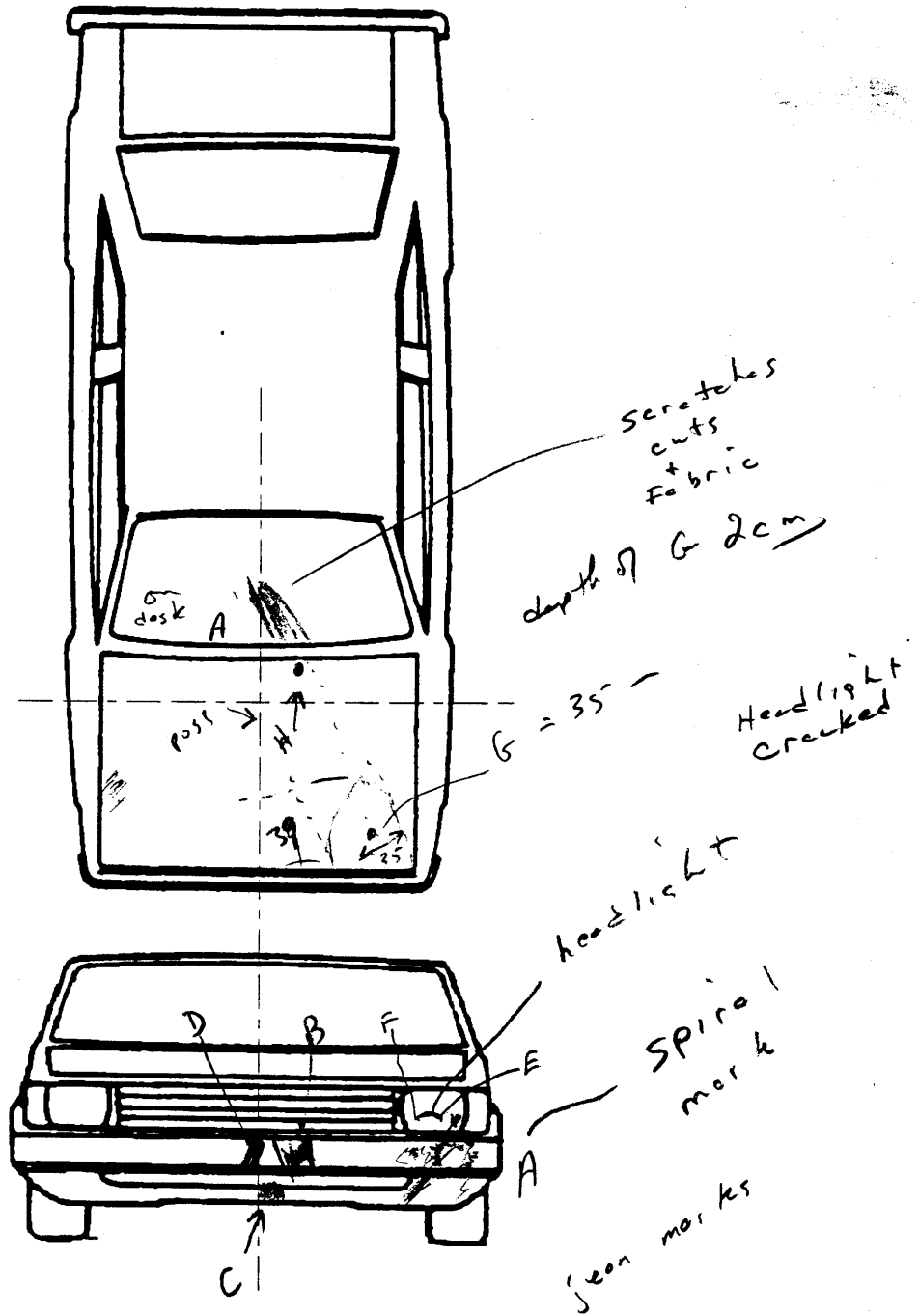
