A. DESCRIPTION OF THE ACCIDENT SEQUENCE AND ACCIDENT PECULIARITIES

(Provide a summary of the accident sequence as well as any particular event of the accident that is noteworthy. Pedestrian injury mechanism and vehicle interaction is the focus, not pedestrian or driver culpability. Do not include any personal identifiers.)

Vehicle 1 was traveling eastbound in the fifth lane of a ten lane, divided roadway. The pedestrian was traveling northbound outside of a crosswalk, with a straight path of travel. Vehicle 1 contacted the pedestrian on the left side with its front end. The pedestrian came to rest directly east of the point of impact in the same lane. The vehicle continued eastbound while braking to final rest in the same lane, just past the point of impact.

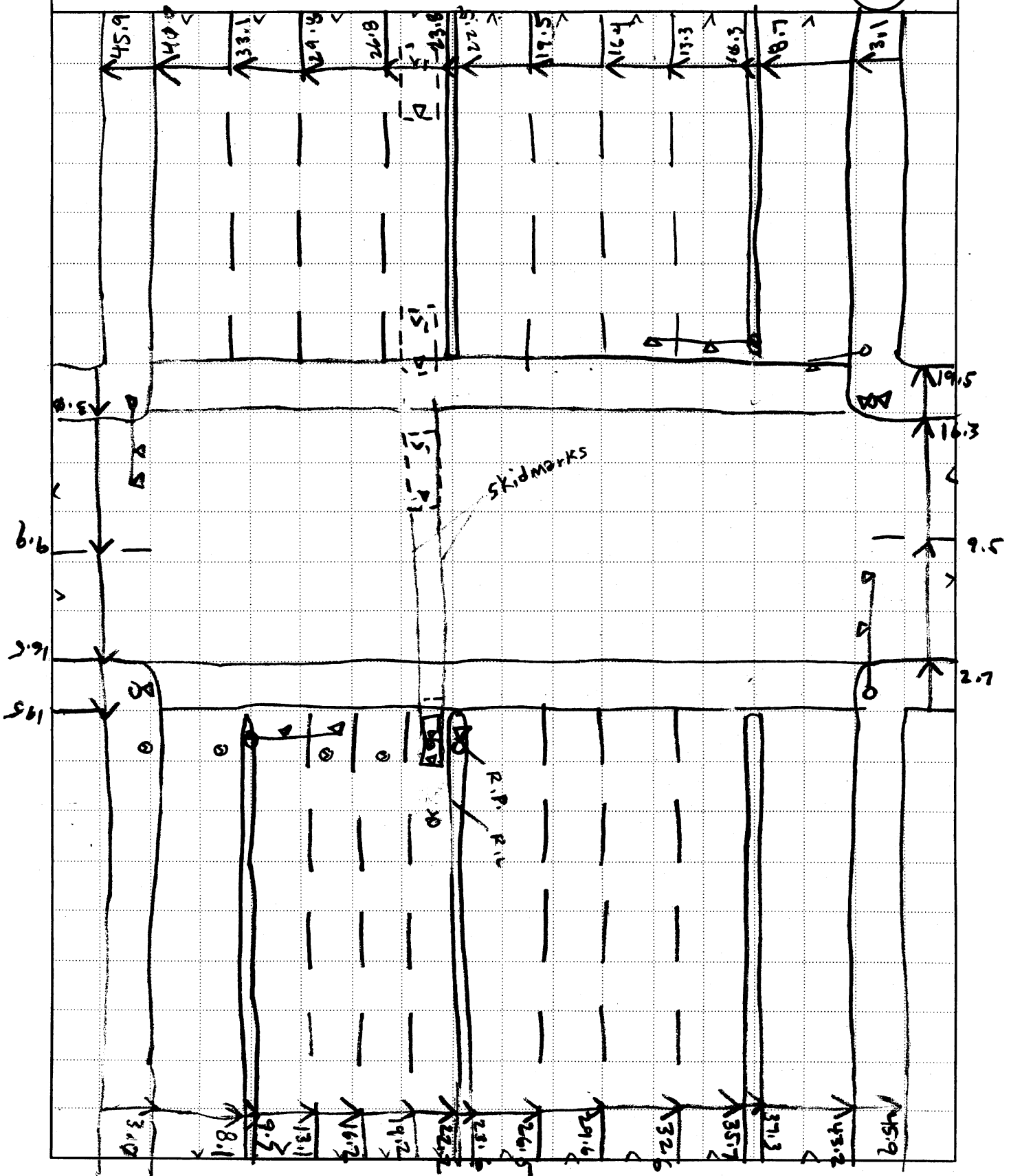


ACCIDENT COLLISION DIAGRAM

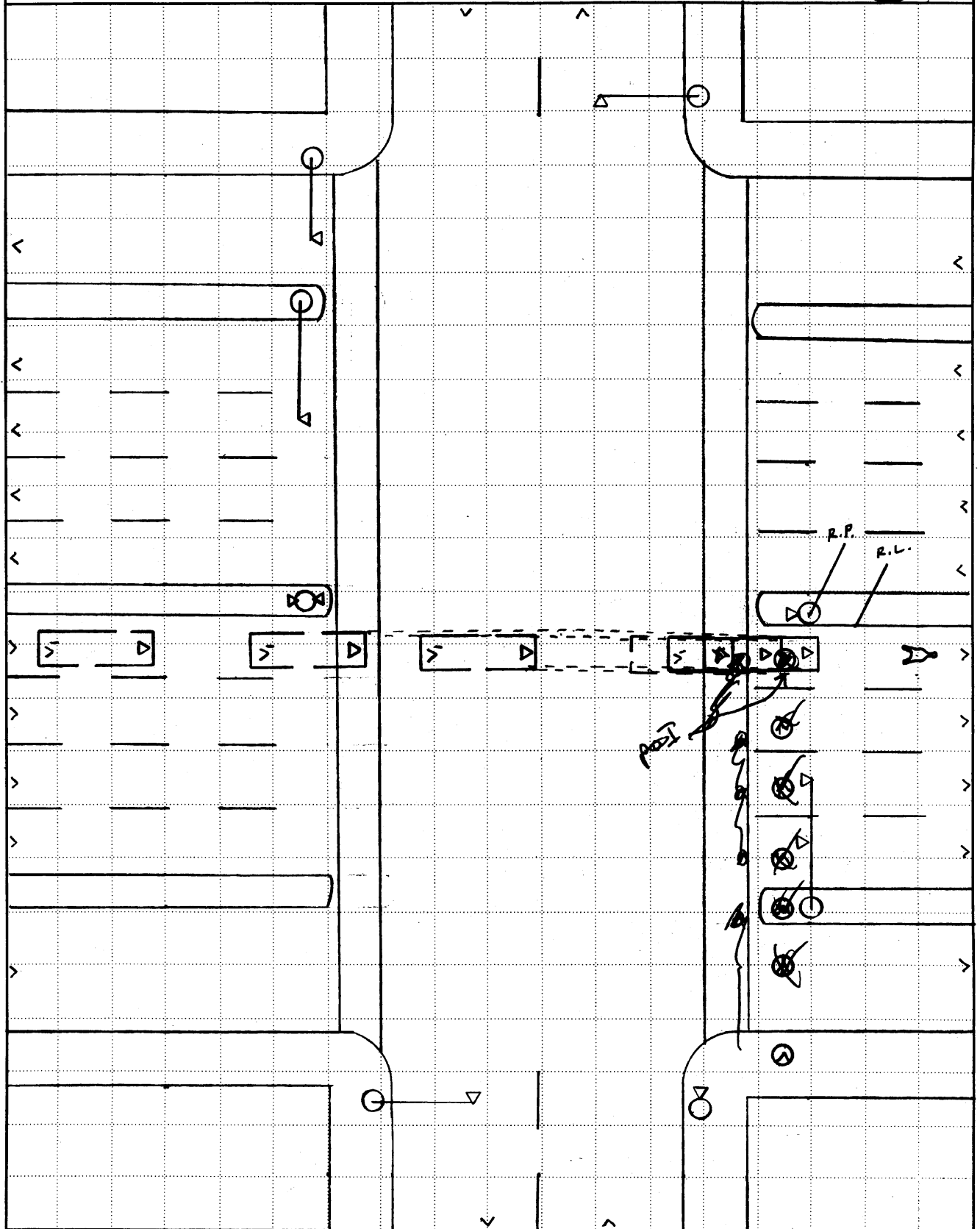


ACCIDENT COLLISION DIAGRAM

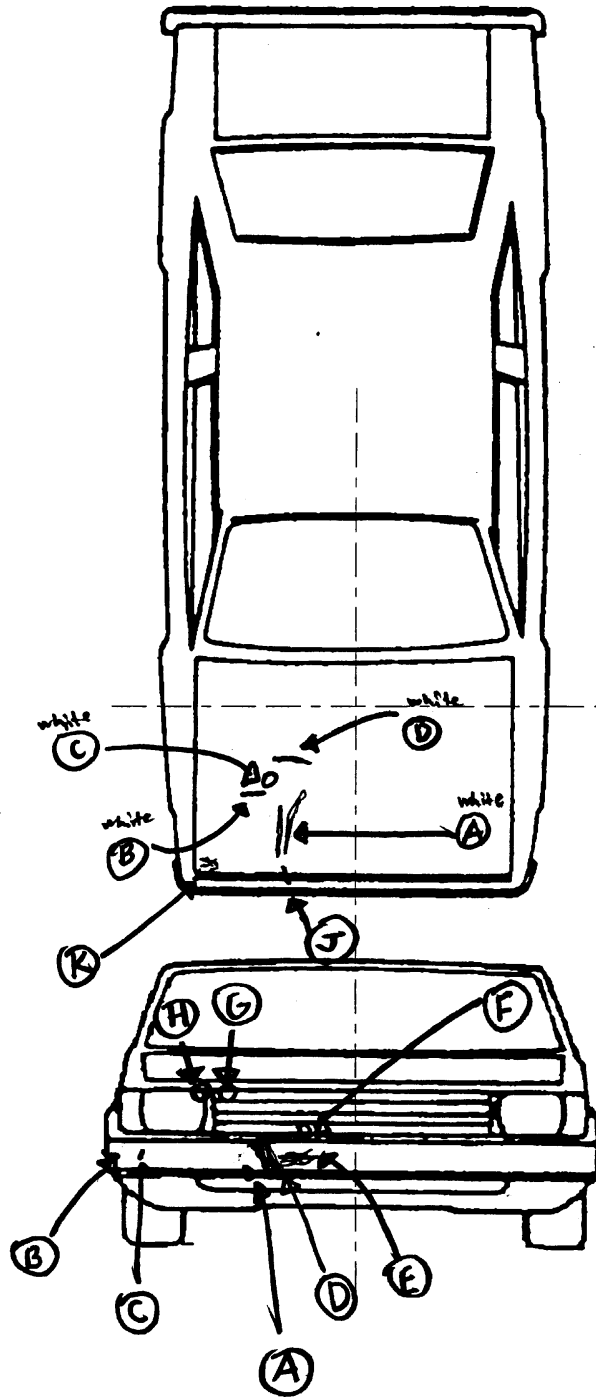

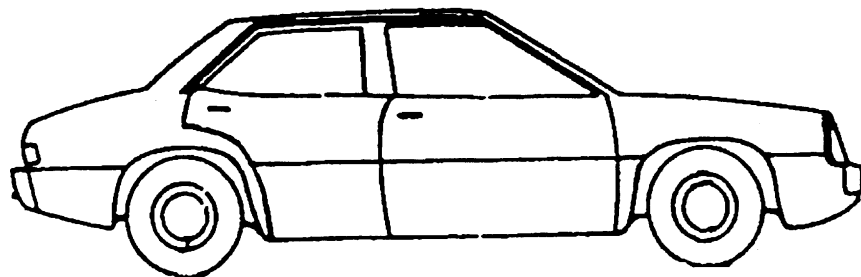
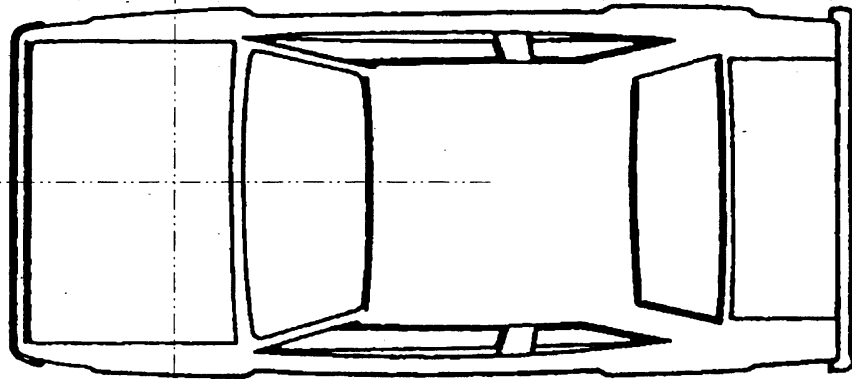
