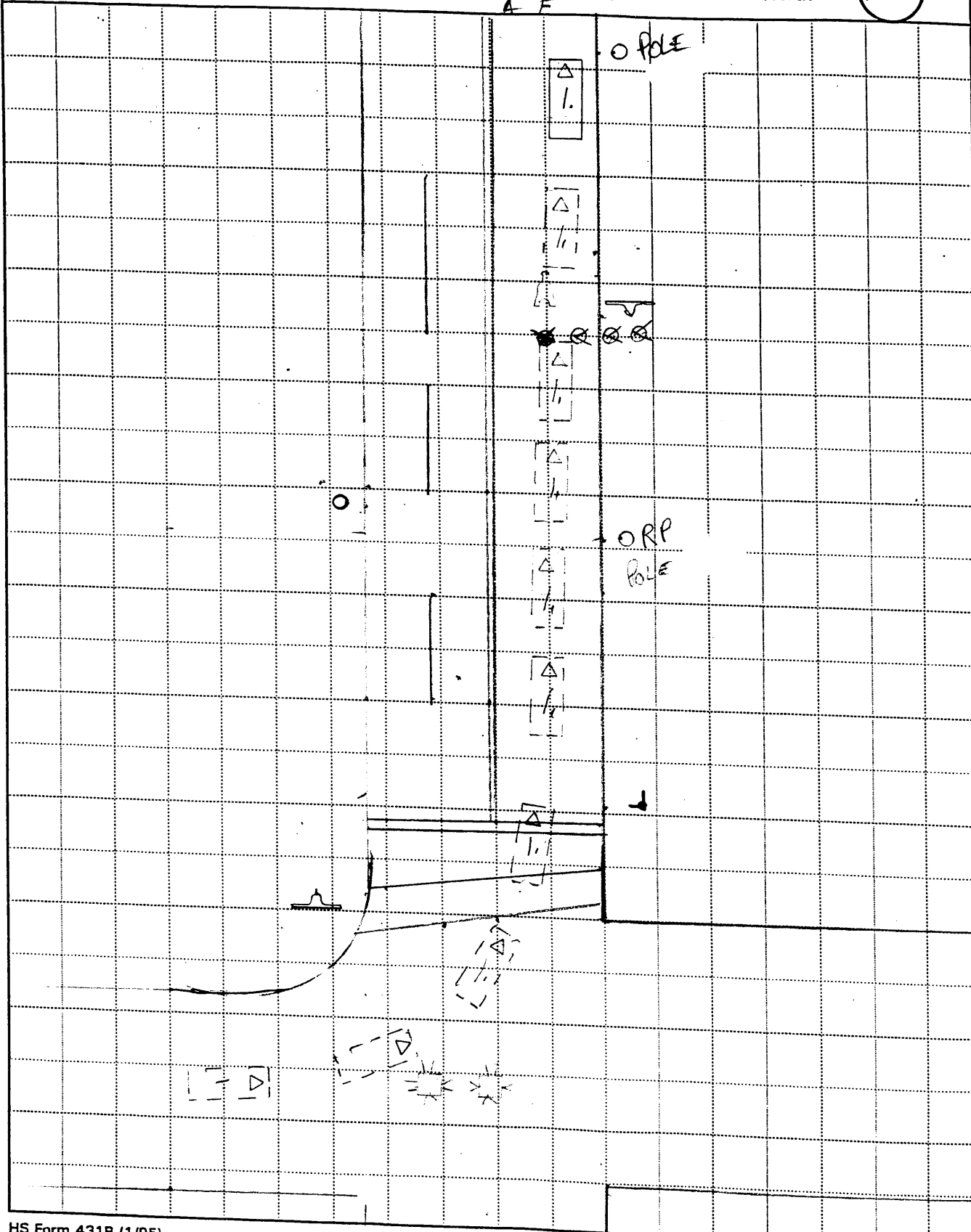
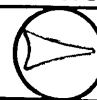
ACCIDENT COLLISION DIAGRAM

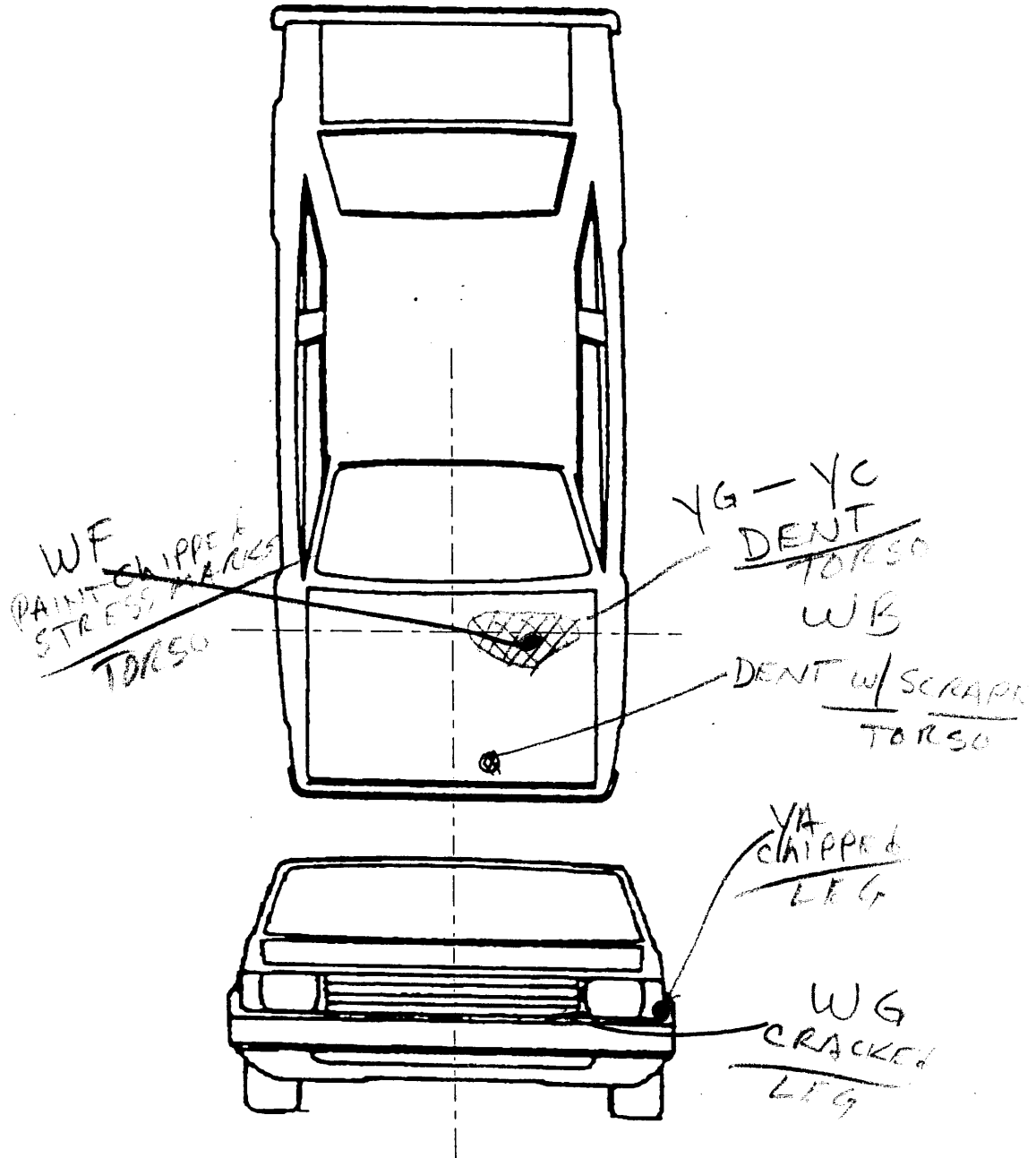

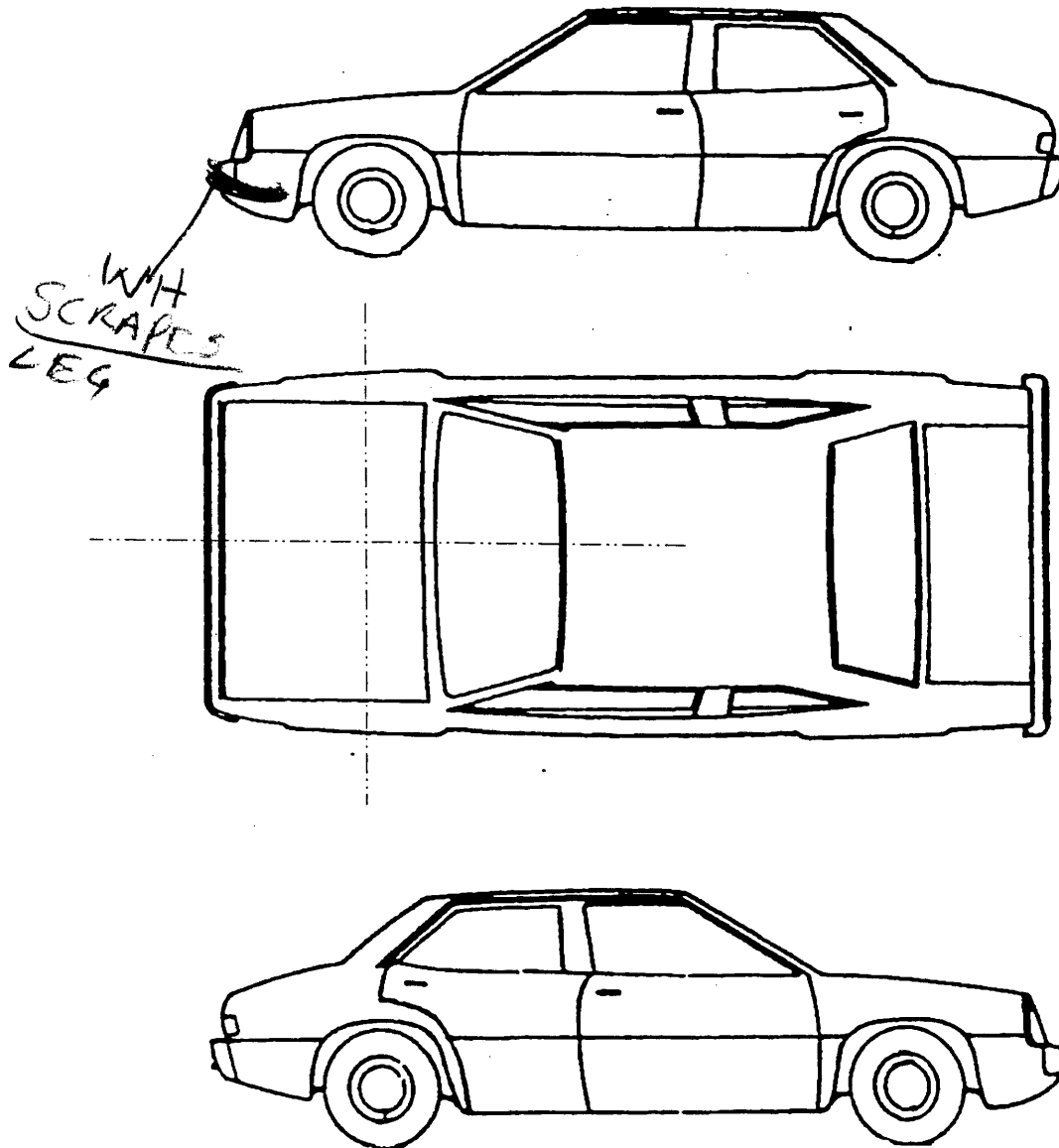
