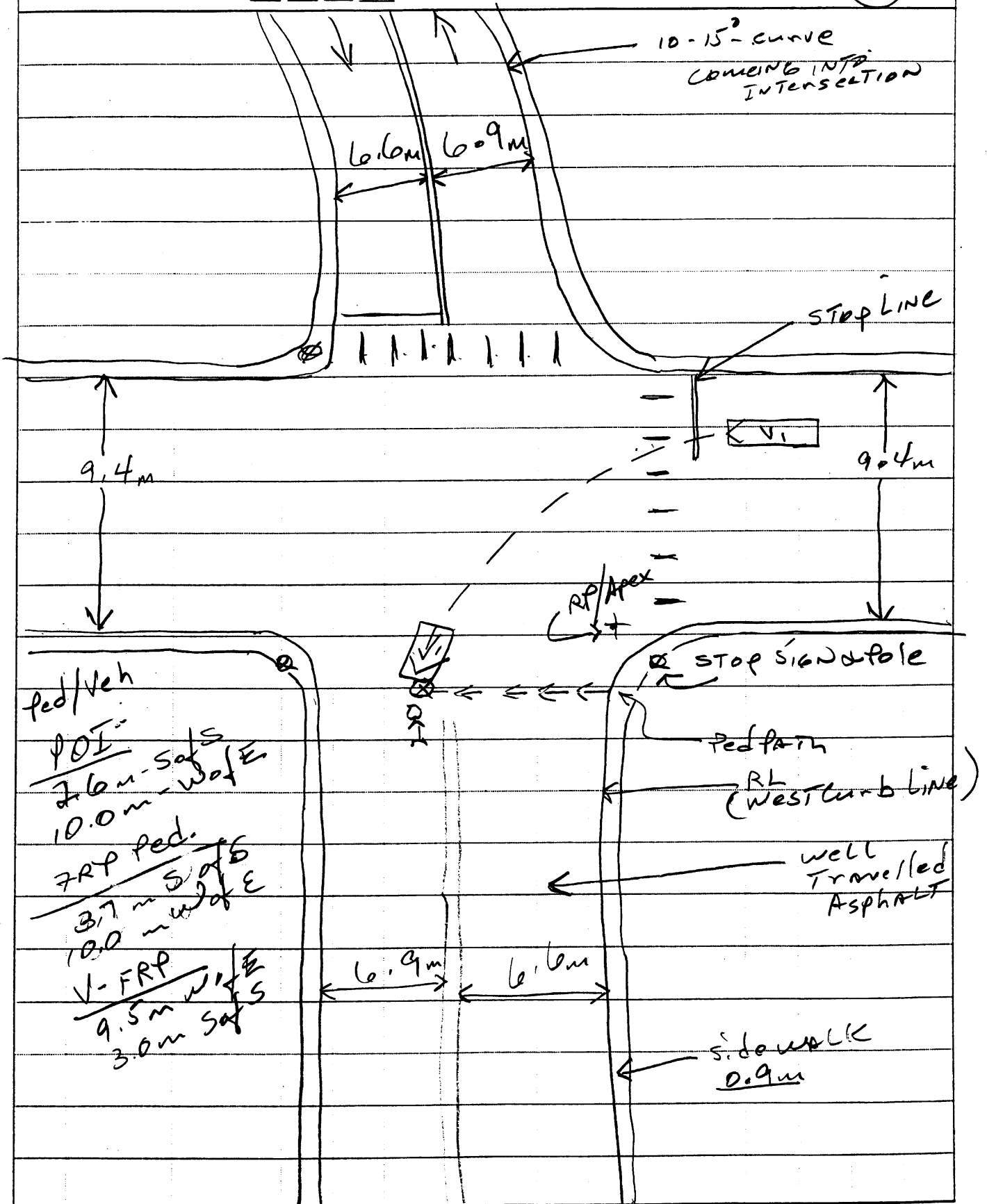
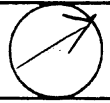

# ACCIDENT COLLISION DIAGRAM

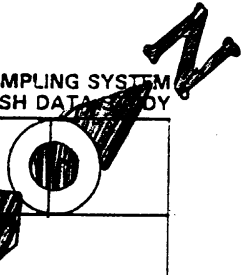

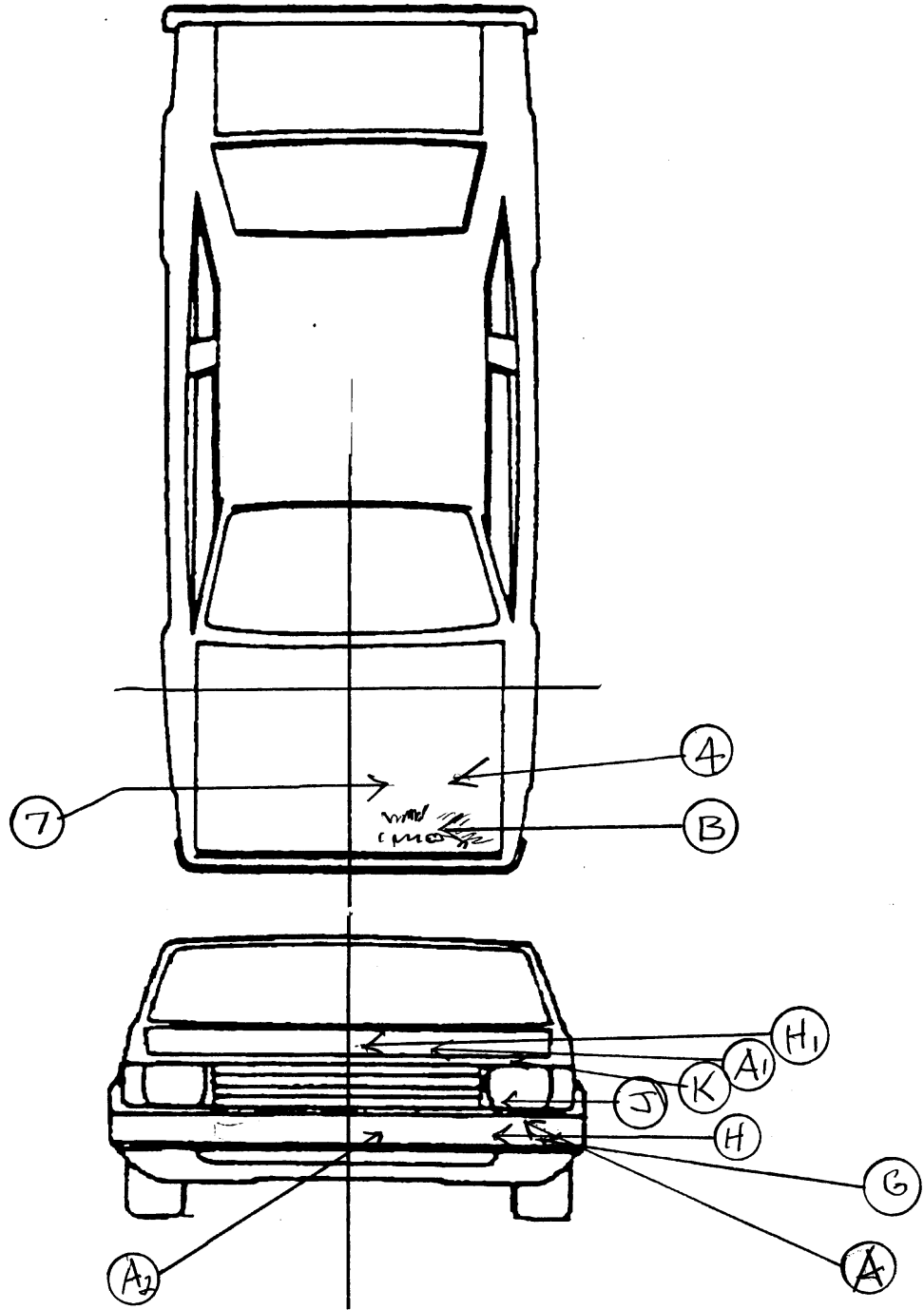

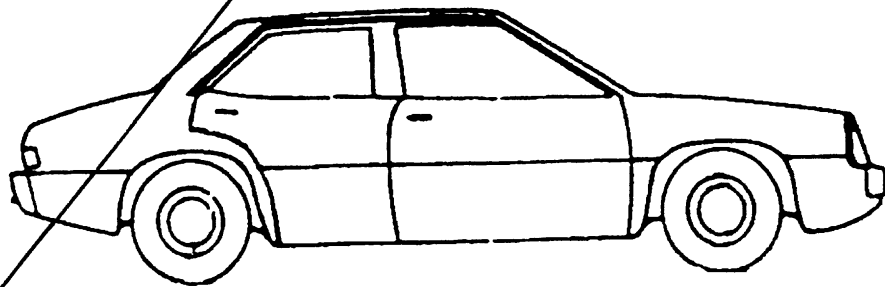
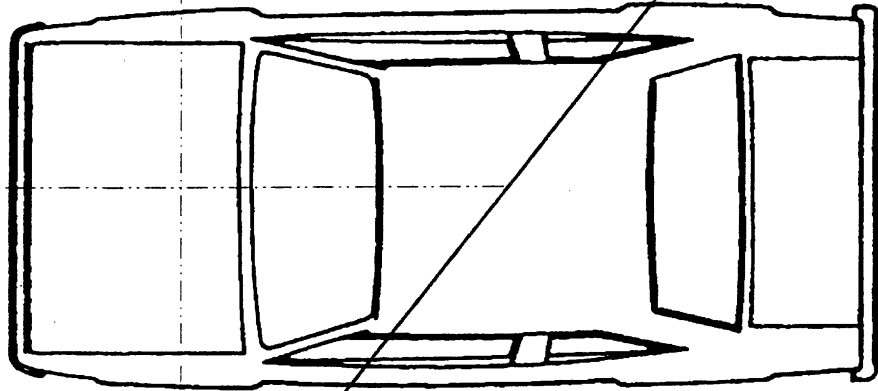
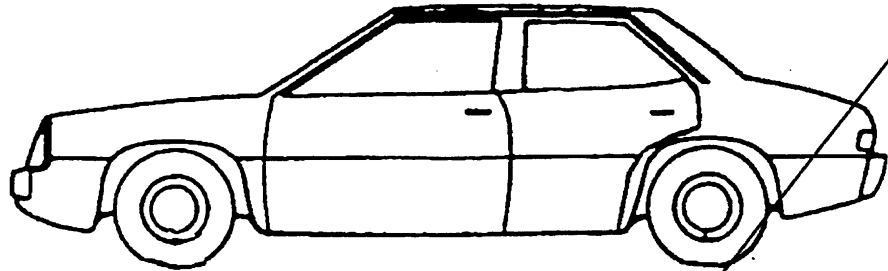
