The letters and caution label will be sent to all ES 350 owners next week, per TMS compliance. Currently, all inventory is being returned to the supplier for rework. The rework consists of a label on the cardboard hanger and a tag attached to the mat for customer removal. The tooling is being reworked to enlarge the lettering on the mat, but I do not have the timing for tooling completion. The suppliers are currently gearing up to start attaching caution labels and tags to all all weather mats. These actions will be viewed as running changes. The lettering on all all weather mats will be adjusted to a standard height and font at major model changeover.
