A. DESCRIPTION OF THE ACCIDENT SEQUENCE AND ACCIDENT PECULIARITIES

Vehicle #1 traveling eastbound in the first lane of a 5 lane roadway. Pedestrian #1 running northwestbound in the intersection while not in a crosswalk. Vehicle #1 contacted pedestrian's left side with its own front end. Pedestrian then traveled 15.7 m from the point of impact to final resting place on the ground. Vehicle #1 broke to frp in same travel lane 18.2 m from the point of impact.











