A. DESCRIPTION OF THE ACCIDENT SEQUENCE AND ACCIDENT PECULIARITIES

(Provide a summary of the accident sequence as well as any particular event of the accident that is noteworthy. Pedestrian injury mechanism and vehicle interaction is the focus, not pedestrian or driver culpability. Do not include any personal identifiers.)

Vehicle #1 was traveling eastbound in the first lane of a three lane, undivided roadway. The pedestrian was walking northbound in a crosswalk to the center of the roadway, when the light changed. The pedestrian then ran diagonally southeast to the point of impact. The vehicle impacted the pedestrian on the right side with its own front end. The vehicle braked to final rest in the same travel lane 14.7 meters east of the point of impact. The pedestrian came to rest near the southeast corner of the intersection 13.7 meters east of the point of impact.






ACCIDENT COLLISION DIAGRAM


