A. DESCRIPTION OF THE ACCIDENT SEQUENCE AND ACCIDENT PECULIARITIES

Vehicle 1 was making a northbound, left turn onto a 3-lane undivided roadway. The pedestrian was walking eastbound while in a crosswalk, with a straight path of travel. As the vehicle was completing it's turn, the pedestrian contacted the left side of the vehicle. The pedestrian then contacted the hood and came to final rest on the ground in front of the vehicle. Vehicle 1 immediately applied brakes and came to rest in same lane.




ACCIDENT COLLISION DIAGRAM




