In accordance with the requirement of §565.7 in CFR Part 565, we are submitting the VIN code information for the 2002 model year Mazda MPV and B-series.


Please find also the information for other 2002 models that we previously submitted. For the Tribute, we deleted the code B and U on the 4th digit, which were typed by mistake.

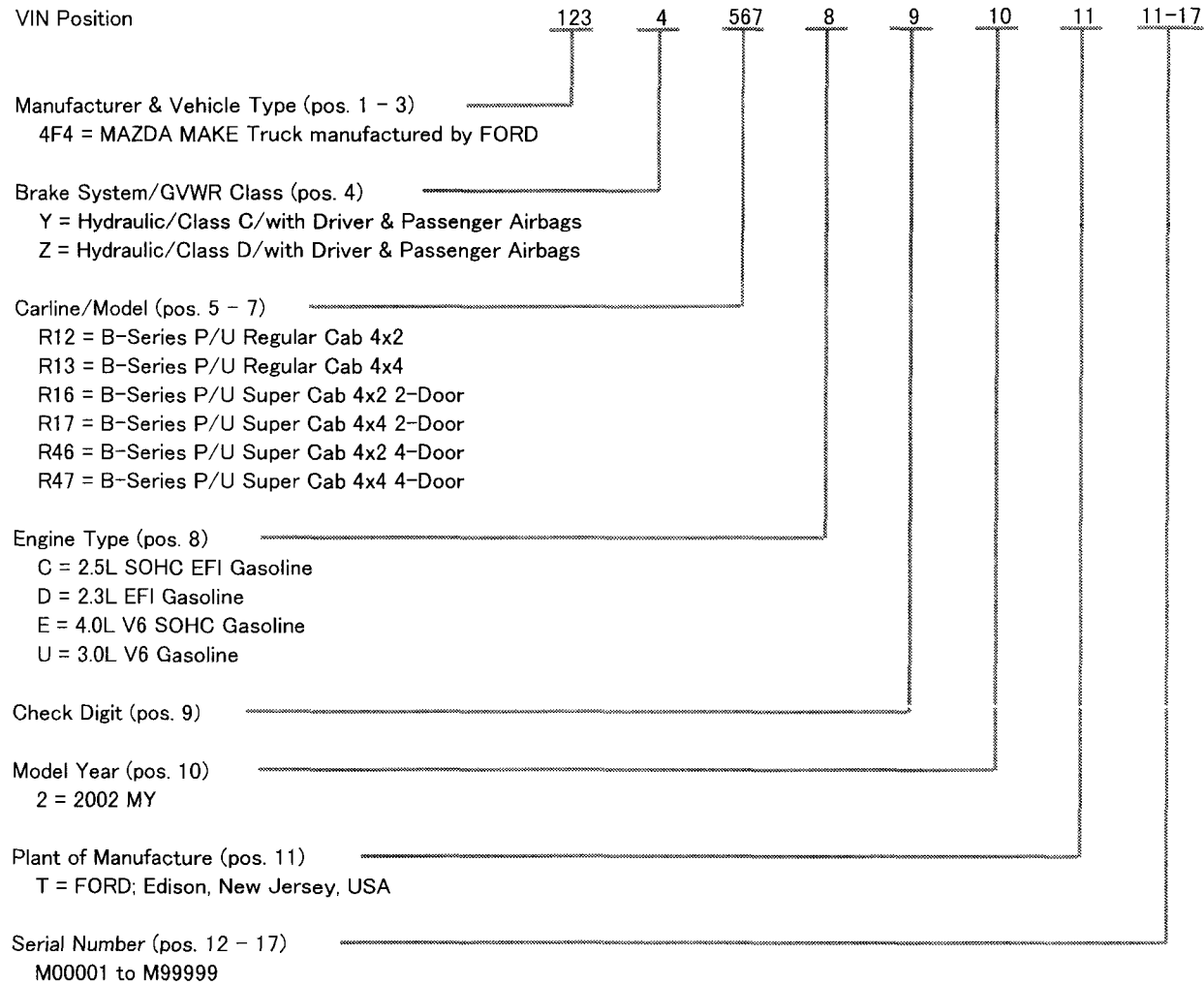

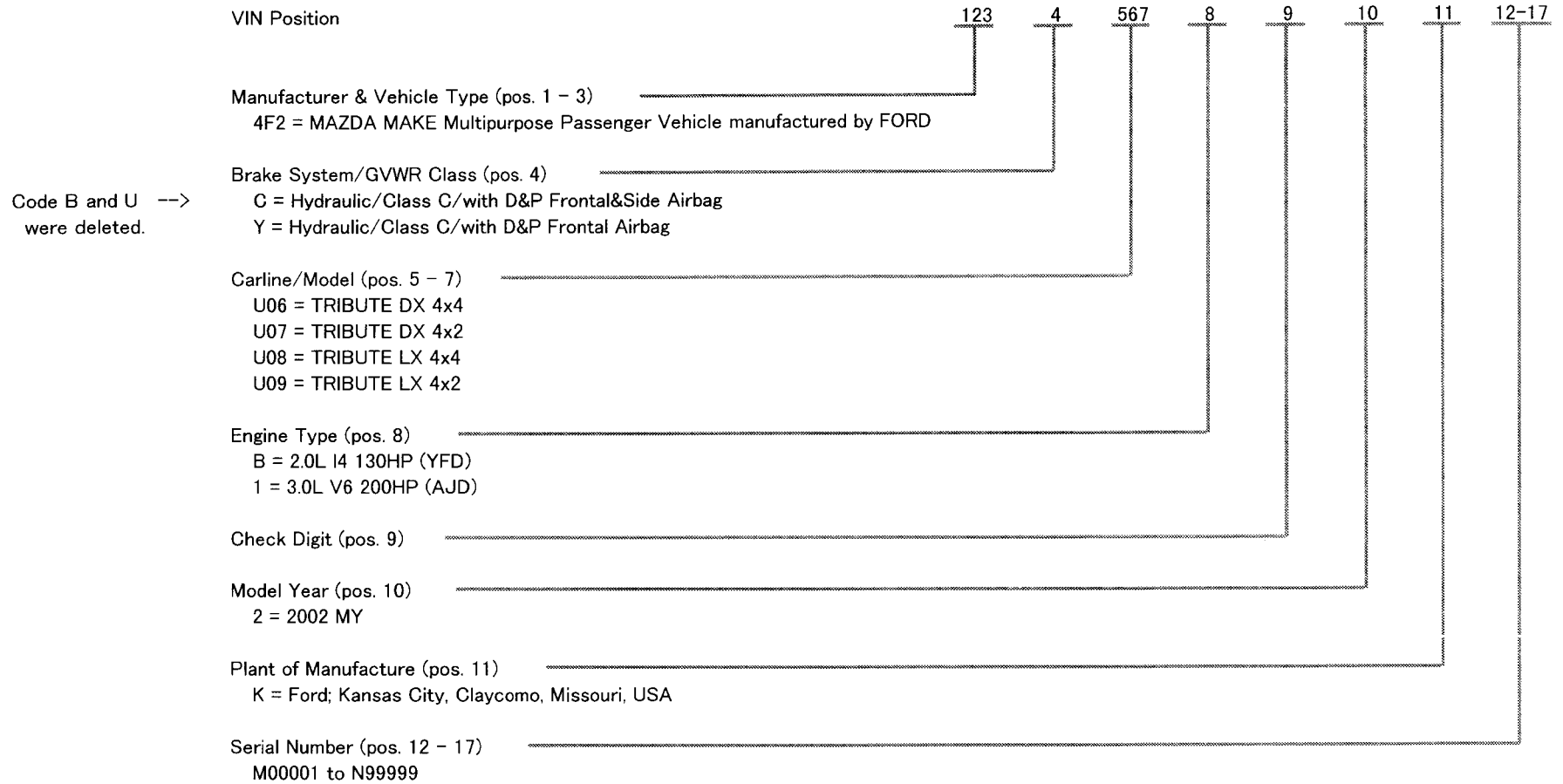
