1988 VIN NUMBER DIFFERENCES

INTRODUCTION

Yamaha has made a change in the 17-character federal Vehicle Identification Number (VIN) on 1988-model street-legal motorcycles. Only one character designation has been changed, as illustrated below. (See Technical Bulletin M80-81A for vehicle registration and appropriate annual bulletins for unit identification information on all units prior to 1988.)

The single-character-designation change

does not affect the way you treat your paperwork; the complete VIN number is still to be used on vehicle registration forms, insurance forms, and overseas purchase requests.

The nine-character engine number (PRIMARY ID number), which is usually included as part of the VIN, will continue to be used on warranty requests and transfer-of-ownership documents.

DEALER ACTION SUMMARY

Inform appropriate personnel of the number change. No other action is required.

VIN NUMBER BREAKDOWN

Using the XV535U as an example, the meaning of each character (letter or digit), or character set, is as follows:

JYA — 2GVE0 — () JA — 600101

- JYA** — This is a constant which identifies the country of origin and the manufacturer. This code was assigned to Yamaha by the federal government.
- 2GV** — These characters identify the model. In most cases, this model code will be the same as the engine number (PRIMARY ID number) prefix.
- E** — This letter is one of five which may be seen on units in this country:
- **A** = U.S.A. — 50-states — (Usually for models with 50cc or less displacement and for off-road vehicles)
 - **C** = U.S.A. — California
 - **E** = U.S.A. — 49-states
 - **N** = Canada
 - **W** = World (Used for other than street-legal machines)
- 0** — This character has no meaning to your dealership.
