The 8th digit refers to the modification version, which is indicated by either the number "0" or letters. For example, "0" means "no modification", "A" means "the 1st modification", "L" means "the 12th modification". Please refer to **Table 2** for the details.

Therefore the sample meanings of the combination of 7th and 8th digits can be found in **Table 3**
