Executive Summary

Louisiana's highway safety program is designed to reduce crashes and the resulting deaths, injuries, and property damage on our roadways. The Louisiana Highway Safety Commission (LHSC) administers the State's highway safety grant program in accordance with the provisions and all amendments of the Highway Safety Act of 1966 (Public Law 89-564).

The Department of Transportation, through the National Highway Traffic Safety Administration (NHTSA), serves as the Federal oversight agency. The funds awarded to the LHSC include:

- Section 402 General Traffic Safety;
- Section 154/164 Open Container and Repeat Offender Hazardous Elimination Funds;
- Section 405b Low Occupant Protection Funds;
- Section 405c State Traffic Safety Information System Improvement;
- Section 405d Impaired Driving Countermeasures;
- Section 405f Motorcyclist Safety;
- Section 408 Data Program;
- Highway Safety Improvement Program (HSIP) Funds Department of Transportation and Development (DOTD) funds to support occupant protection.

The funding received supports Louisiana programs in impaired driving, occupant protection including child passenger safety, traffic records, motorcycle safety, police traffic services, railroad/highway crossing safety, community traffic safety programs, pedestrian and bicyclist safety, young drivers, hazard elimination, and planning and administration.

This Annual Report provides a general assessment of the State's progress in achieving highway safety performance measure targets identified in the Federal Fiscal Year (FFY) 2017 Highway Safety Plan (HSP), a general description of the projects and activities funded and implemented under the plan, and the amount of Federal funds expended on each project.

The Louisiana Highway Safety Commission worked with multiple state and Federal agencies; municipal, parish, and state law enforcement; and nonprofit organizations throughout the State. We also extended our commitment to Louisiana's Strategic Highway Safety Plan (SHSP) and our shared traffic safety vision for reducing traffic-related deaths and serious injuries known as Destination Zero Deaths, by designating a LHSC liaison to work directly with the nine SHSP regional coalitions. Louisiana saw a slight increase in fatalities in 2016 (757) over 2015 (752) which represents the third year of increasing fatalities. We continued to use data driven best practices to address our traffic safety priorities. The most current fatality data show that the LHSC and our many partners were successful in achieving the following:

- Maintained an 87 percent observed seat belt use for drivers and front seat motor vehicle passengers in 2017;
- Reduced unrestrained fatalities from 262 to 225;
- Reduced alcohol impaired driving fatalities to 225 from 250;
- Increased the percentage of EMS patient care reports submitted electronically to the Louisiana Emergency Response Network (LERN) from 81 percent to 90 percent; and
- Reduced bicyclist fatalities from 34 to 22.

Louisiana road safety partners and stakeholders recognize the need to coordinate activities and resources to achieve safer transportation conditions. We will continue to monitor long-term traffic safety problems and identify emerging traffic safety trends, and address both using proven practices and research-based programs. Our strong support of enforcement agencies will continue, our community outreach will foster local interest, and our partnerships will continue to flourish while sharing common goals of reducing fatal and injury crashes on our roadways.

1.0 Commission Leadership

A Governor appointed board of 21 Commissioners supports the LHSC. The LHSC Executive Director is included in the board. As directed in Louisiana Revised Statute 48:1347, the Commission gathers, studies, prepares, evaluates, and distributes statistical compilations and makes recommendations with respect to crashes, injuries, and the related problems. The Commission serves as the coordinating agency for behavioral activities relating to highway safety and prepares such legislation, as it deems necessary to carry out a comprehensive, long-range highway safety program for the state. The Commission makes reports to the Governor, the legislature, and to the proper agencies of the Federal government as required by law or as directed.

In addition to the 21 member Commission, the LHSC has a staff of fifteen. Under the leadership of the Commission, the Executive Director and staff manage the day-to-day operations of the LHSC.

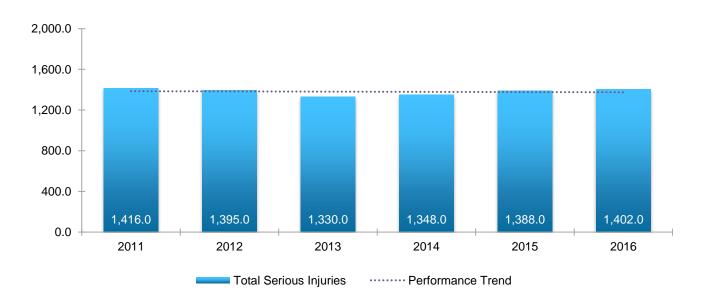

Figure 2.2 Statewide Serious Injuries



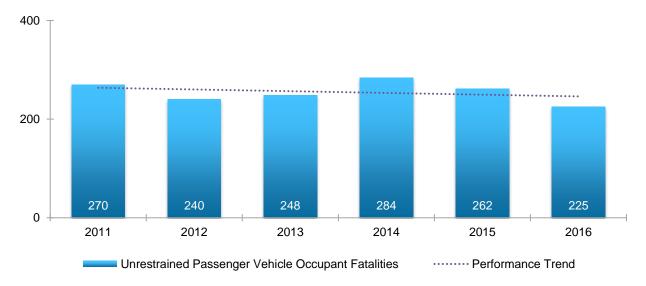

Figure 2.3 Statewide Fatality Rate



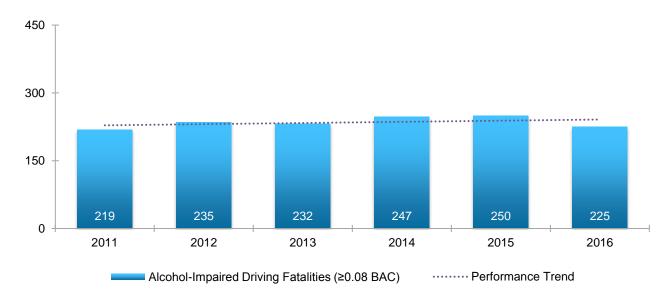

Figure 2.4 Unrestrained Passenger Vehicle Occupant Fatalities



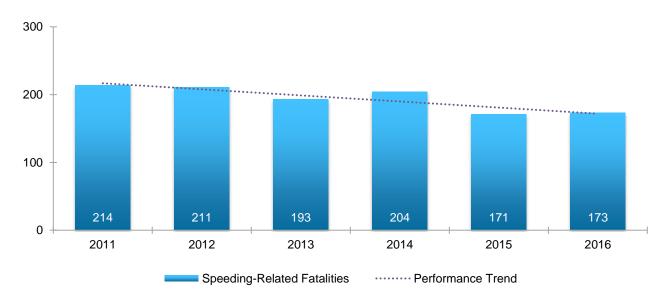

Alcohol-Impaired Driving Fatalities Figure 2.5 (≥0.08 BAC)



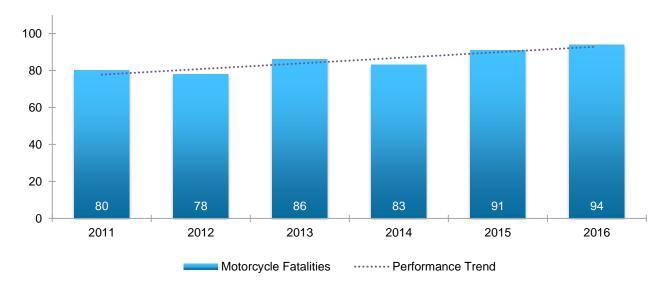

Speeding-Related Fatalities Figure 2.6



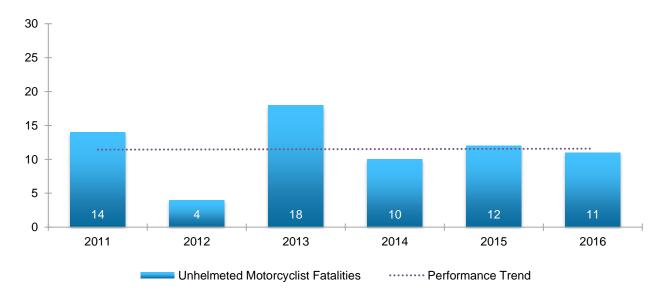

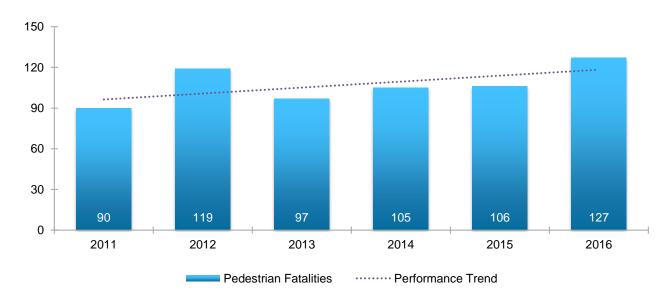
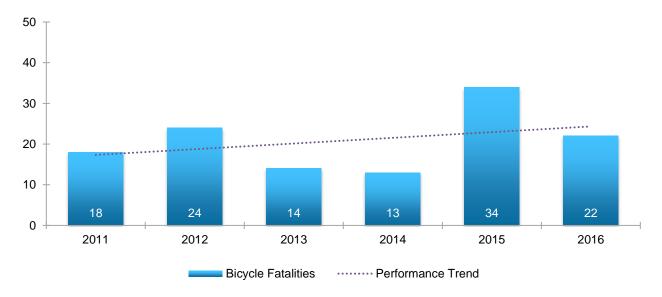


Figure 2.10 Pedestrian Fatalities

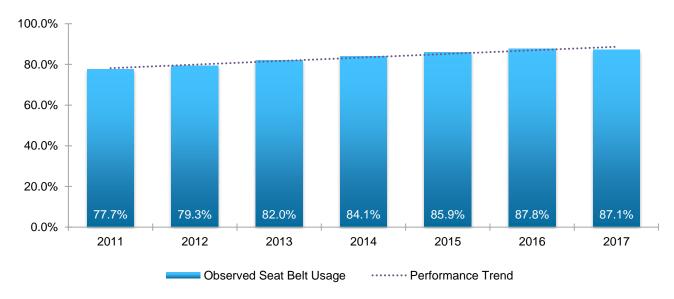

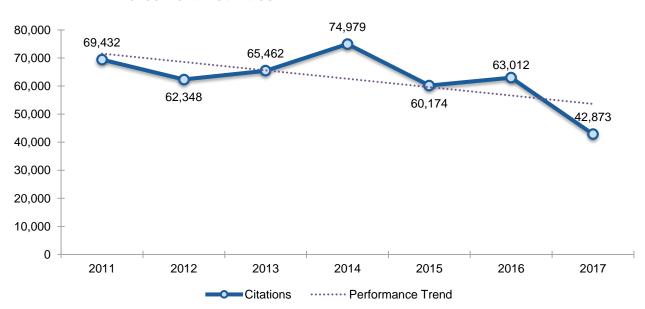
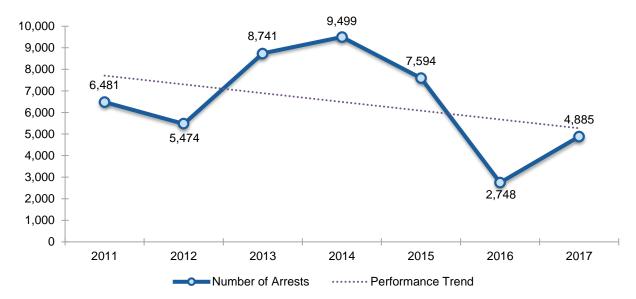


Figure 2.14 Number of Seat Belt Citations Issued During Grant-Funded Enforcement Activities

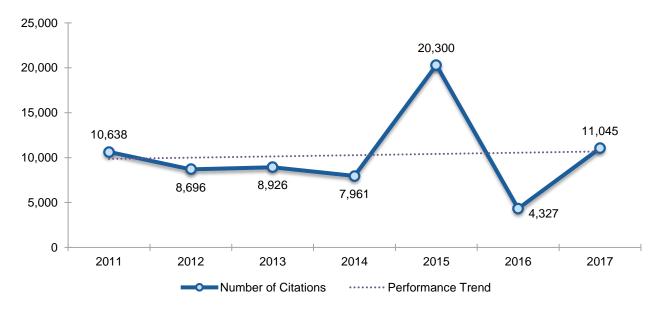

3.1 FFY 2017 Targets

4.0 Program Results

Evidence Based Enforcement Program Activities

In FFY 2017, the LHSC continued to support implementation of evidence based enforcement program activities. A significant portion of Louisiana's highway safety grant funds were awarded to law enforcement agencies as noted in the following programmatic areas. The LHSC has policies and procedures in place to ensure enforcement resources are used efficiently and effectively to support the targets of the state's highway safety program. Funding decisions for subsequent years are based on the effectiveness of the implementation and performance of each agency's enforcement project that are summarized in this section. Louisiana incorporates an evidence-based approach in its statewide enforcement program through three components; participants involved, data sources, and continuous monitoring.

All enforcement grantees who applied for FFY 2017 funding were vetted by a diverse group of participants across an array of disciplines as outlined in detail in Section 1 of the FFY 2017 HSP. The participants focused on the selection of evidence-based traffic safety countermeasure proposals and were further enhanced by the program staff at LHSC.

Various data sources were used by LHSC to identify who is overrepresented in crashes as well as when, where, and why crashes are occurring. Data analyses was conducted to identify high-risk populations that may require additional or alternative responses to address traffic safety concerns. All enforcement agencies who received grant funding used a data-driven approach to identify the enforcement issues in their jurisdictions. Data was provided to local law enforcement agencies as part of the statewide problem identification effort. Agencies also used local data for resource allocation and evidence based enforcement to address their jurisdiction's identified problem(s).

To ensure enforcement resources were deployed effectively, law enforcement agencies were directed to implement evidence-based strategies. The LHSC uses the most current version of the NHTSA publication *Countermeasures That Work: A Highway Safety Countermeasure Guide for State Highway Safety Offices* as a guide for approving proposals with evidenced-based enforcement strategies. In FFY 2017, Louisiana used evidence-based strategies and targeted enforcement to address key problem areas such as impaired driving, failure to wear seat belts, and speeding violations. Additional strategies deployed included enforcement during specific times of day when more crashes occur (e.g., nighttime impaired driving checkpoints), and enforcement of high-risk occupant protection populations, such as an additional focus on restraint use of pickup truck occupants during nighttime enforcement activities. High-visibility enforcement, including participation in the national seat belt and impaired driving mobilizations were also conducted. By implementing these and other strategies that research has shown to be effective, efficient use was made of the available resources to help improve safety on Louisiana's roadways.

To ensure these law enforcement projects remained nimble with the ability to adjust to any situation, various tracking mechanisms were utilized to enable program managers and law enforcement managers with quick insights into the progress of each project. Contact with enforcement agencies was maintained through meetings, conferences, grant monitoring sessions, phone calls, and press events. Progress reports were required from each law enforcement agency receiving grant funding to ensure an understanding of the goals and outcomes of each project. These reports included data on the activities conducted, such as the area and times worked and the number of tickets issued. This monthly monitoring allowed for subtle or major

adjustments within each grantee, leaving sufficient time to make adjustments throughout the year if needed to improve traffic safety in Louisiana.

Compilation of Enforcement Activity Results

In FFY 2017, 50 law enforcement agencies participated in the national "Click It or Ticket" campaign and in the "Drive Sober or Get Pulled Over" campaign. Collectively, the NHTSA funded law enforcement activities resulted in:

- 52,710 seat belt citations;
- 5,529 impaired driving arrests;
- 11,045 speeding citations;
- 22 new Drug Recognition Expert (DRE) officers trained;
- 169 students trained in Standardized Field Sobriety Test (SFST);
- 284 students trained in Advanced Roadside Impaired Driving Enforcement (ARIDE); and
- 114 DREs certified in the State.

The following subsections of Section 4.0 present pertinent data, performance targets and the programs and projects for each program area addressed in the FFY 2017 Highway Safety Plan. The amounts listed after Budget Expended in each project description do not reflect the final expenditures until the final voucher is submitted and approved.

4.1 Impaired Driving Program

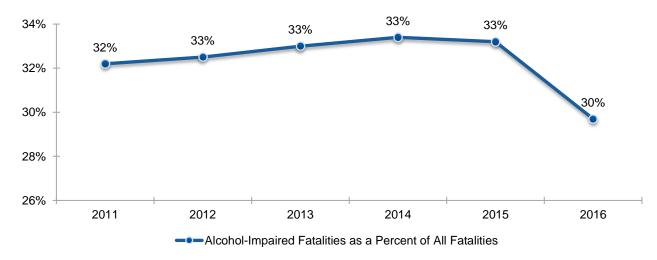


Figure 4.2 Alcohol-Impaired Fatalities as a Percent of All Fatalities

Louisiana's comprehensive impaired driving program used broad-ranging strategies and actions designed to reduce impaired driving fatalities and injuries. Figure 4.1 shows the changes in alcohol-impaired fatalities and alcohol-related fatal crashes from 2009 to 2016. Alcohol-related fatal crashes reversed an upward trend that started in 2015, while alcohol-impaired fatalities in 2016 were the lowest since 2011. Figure 4.2 shows that the percent of alcohol-impaired fatalities as a percent of all the state's motor vehicle fatalities in 2016 reached its lowest level over the past 6 year period. In addition, the number of alcohol related fatalities with a blood alcohol concentration (BAC) at or over .08 was the lowest since 2011 as shown in Figure 4.3.

Project Title: Tangipahoa Reshaping Attitudes for Community Change (TRACC) Coalition

Project Description: The No Refusal impaired driving program was designed to support "No Refusal" sobriety enforcement efforts through the use of certified medical technicians who provided evidence collection (blood draws) when warrants were issued. Certified medical technicians provided 1,295 hours of services which resulted in 21 refusal blood draws, 60 consented blood draws and 148 DWI arrests.

Project Title: Impaired Driving Policy Specialist

The Impaired Driving Policy Specialist also assisted in the management of three of the LHSC-funded DWI courts and assisted with the proper operation of these courts. The Impaired Driving Policy Specialist ensured new and existing DWI courts received the training needed to operate successfully. This person also collaborated with the Louisiana Supreme Court in reference to the DWI courts under their management.

Project Title: Prosecutor/ Law Enforcement Training Program

Project Description: Through the Louisiana District Attorneys Association (LDAA), the LHSC provided funding for a Traffic Safety Resource Prosecutor (TSRP) to help law enforcement, prosecutors, and judges align their efforts to prosecute DWI cases. LDAA conducted eight impaired driving training courses in 2017, reaching 520 prosecutors, 122 law enforcement officers and 87 other stakeholders in the criminal justice environment. The courses were offered statewide.

The legal consultants' primary duties included reviewing all administrative implied consent hearing recalls, disseminating information about why a license suspension was over-turned and corrective actions to prevent future occurrences.

Project Title: Mothers Against Drunk Driving - Court Monitoring

Project Description: This program monitored DWI cases throughout the prosecution process in several court jurisdictions. Courts in Baton Rouge City and the 19th Judicial District Courts in East Baton Rouge Parish were monitored on a weekly basis. In addition, courts in Orleans, Ascension, Livingston, Tangipahoa, Iberville, West Baton Rouge, Bossier, Caddo, Ouachita, Rapides, Natchitoches, and Lincoln parishes were randomly monitored. Court Monitors visited assigned courts/logged into court docket databases, observed DWI cases, collected pertinent data, entered case information into the court monitoring database, trained and supervised program volunteers, managed monitor "watchdog" calls, and compiled reports on specific data elements as requested. MADD monitored 6,657 impaired driving cases in FFY 2017.

Project Description: The LSP Crime Lab has seen a significant increase in the request for analysis of synthetic drugs. The negative analysis results in toxicology cases was believed to be a direct result of the use of synthetic drugs which are undetectable using the lab's then current instruments. In 2015, the lab outsourced the analysis of 50 cases. The TRCC approved this project concept in which the LSP crime lab purchased lab equipment to quantitatively measure amounts of illegal drugs in blood sample of drivers involved in crashes. The basic enzyme-linked immunosorbent assay (ELISA) was validated and implemented into case work in October 2017. The addition of this instrument has reduced blood screens from a two day process for 20 samples to approximately four to six hours. The liquid chromatography-tandem mass spectrometry (LC-MS/MS) is currently being validated to quantify THC and hydroxy-THC (active) metabolite because about 35 percent of the crime lab's current blood samples are testing positive qualitatively for carboxy-THC metabolite (non-active).

4.2 Occupant Protection Program

Louisiana's seat belt use reached a historic high of 87.8 percent in 2016 and the state maintained a rate over 87 percent again in 2017. The LHSC provided leadership, training, and technical assistance to other state and law enforcement agencies, and local occupant protection projects to deliver the maximum impact and likelihood for increasing restraint use. Table 4.1 shows observed seat belt usage by region from 2011 through 2017.

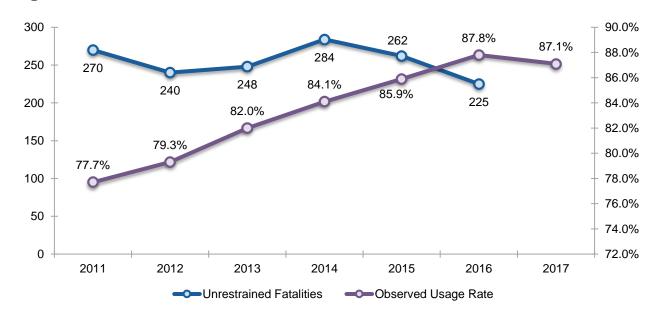

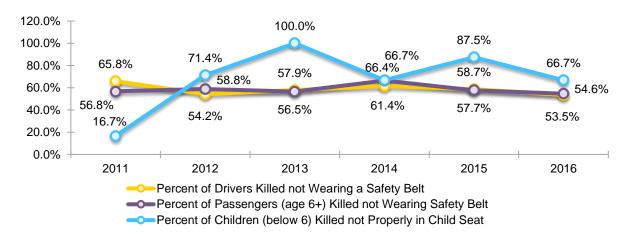
Figure 4.4 Observed Seat Belt Use and Unrestrained Fatalities

Seats were distributed in 9 regions of the State during National Child Passenger Safety Week. During the 2016-17 school year, UMC hosted the STOP program that reached 2,098 elementary school students.

Project Title: Overtime Traffic Safety Enforcement – Local Law Enforcement

Project Description: Local law enforcement agencies conducted overtime enforcement of traffic safety laws using checkpoints and saturation patrols throughout FFY 2017 and during state and national enforcement periods. All overtime enforcement programs were data driven to reduce the number of alcohol-impaired fatalities, unrestrained fatalities, and speeding fatalities in the areas most at risk. In 2017, 43 law enforcement agencies participated in this program across Louisiana.

Research shows that high visibility and sustained enforcement continues to be the most effective countermeasure in increasing seat belt usage. This project provided funding to 44 local police departments and sheriff's offices for occupant protection overtime enforcement. All law enforcement agencies participating in this targeted occupant protection overtime enforcement program utilized data to identify areas, and vehicle types (e.g., pickup trucks, motorcycles), of critical need and focused on areas with known lower seat belt usage. Agencies deployed resources based on crash analysis and made adjustments throughout the year as needed. Participating agencies conducted checkpoints, saturation patrols, and yearlong enforcement to correspond with the national "Click It or Ticket" campaign and state mobilizations. Law enforcement agencies worked 38,584 hours of saturation patrol and 5,890 hours at seat belt checkpoints, issuing 49,787 adult seat belt citations and 2,923 child passenger seat citations. 4.3 Traffic Records Improvement Program

The LHSC continued to partner with the Traffic Records Coordinating Committee (TRCC) to improve the state's traffic records information systems. In FFY 2017, the TRCC focused on improvements to the EMS/injury surveillance and citation/adjudication systems. Five of the following six performance targets were met or exceeded in FFY 2017:

Performance Targets and Results

- Increase the percentage of EMS patient care reports submitted electronically to the Louisiana Emergency Response Network (LERN), which contains all critical data elements from 81 percent on March 31, 2016 to 83 percent by April 1, 2017. From March 31, 2016 – April 1, 2017, increased to 89.64 percent (46,127 reports out of 51,465) of the EMS patient care reports submitted electronically to the Louisiana Emergency Response Network (LERN), contains all critical data elements.
- Increase the number of EMS providers submitting injury surveillance data electronically to LERN from 28 on March 31, 2016 to 30 agencies by April 1, 2017. The number of EMS providers submitting data electronically to LERN by April 1, 2017 increased to 30 agencies.

- Improve the Timeliness of the Crash system as measured in terms of decrease in the mean number of days from (a) the crash date to (b) the date the crash report is entered into the database from 9.92 days on March 31, 2016 to 8.5, days by April 1, 2017. The median or mean number of days from (a) the crash date to (b) the date the crash report is entered into the database increased to 10.42 days.
- Increase the number of courts submitting data electronically to the Louisiana Supreme Court from 82 on March 15, 2016, to 87 by March 31, 2017. The number of courts submitting electronic date to the Louisiana Supreme Court by March 31, of 2017 increased to 89.
- Add and monitor four new performance measures from one or more of the following data systems: Crash, Driver, Vehicle, Roadway, Citation & Adjudication, Injury Surveillance, and Data Integration by April 1, 2017. Four new performance measures were developed and baseline data is being monitored by the TRCC: 1 for crash location data completeness; 1 for crash location data accuracy; 1 for EMS completeness for 5 critical data elements; and, 1 for driver timeliness, which can be broken down into commercial vs. non-commercial driver data.
- Develop a TRCC management and policy manual for TRCC Members by April 1, 2017. The TRCC
 Management and Policy Manual was completed by April 1, 2017. This document serves the TRCC as a
 living document and as such, it will continue to be updated by the TRCC Policy Committee as needed.

A typical scan time takes 3 minutes and allows the officer to capture more complete and accurate scene information than conventional methods. The scanner quickly captures only high quality data over its entire range, even in direct sunlight. This reduces law enforcement setup time to capture and complete an accident scene. The scanner provides data for long range scenes with a maximum range of 340 meters.

Through discussions with the TRCC, the Louisiana State Police along with a police trainer have agreed to provide ongoing training to Baton Rouge Police Department officers on proper use of the accident scene scanner. (Completeness and accuracy)

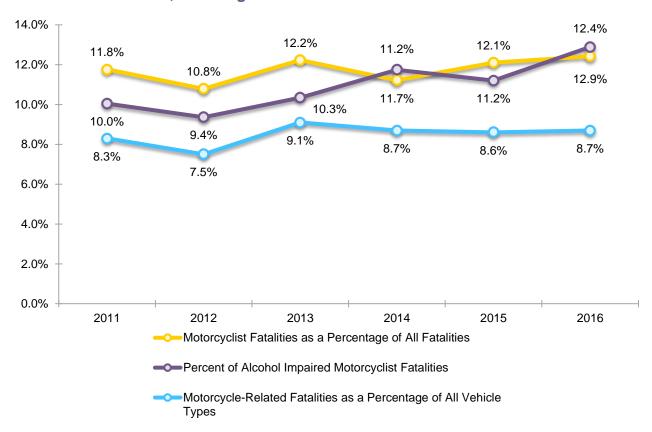

In FFY 2017, LHSC focused on reducing the overall number of motorcyclist¹ fatalities, as well as the number of motorcyclist fatalities that were alcohol-impaired (BAC of 0.08 or above) or not wearing a helmet. Figure 4.6 shows motorcyclist fatalities as a percent of all motor vehicle fatalities, the percent of motorcyclist fatalities that were alcohol-impaired and the percent of motorcyclist fatalities that were single vehicle crashes.

4.5 Police Traffic Services Program

In FFY 2017, funding for Police Traffic Services (PTS) supported overtime enforcement related to occupant protection, speeding, and alcohol-impaired driving. Data from the Highway Safety Research Group at LSU reveal very few fatal or injury crashes include a violation for "over safe speed limit" or "over stated speed limit". The majority of violations reported in injury (16 percent) and fatal (16 percent) crashes in 2017, however, are for "careless driving". Careless driving is defined by LRS 32:58 as: "Any person operating a motor vehicle on the public roads of this State shall drive in a careful and prudent manner, so as not to endanger the life, limb, or property of any person. Failure to drive in such a manner shall constitute careless operation." This statute may be interpreted by law enforcement to include speeding.

Reduce speeding-related fatalities by 14.7 percent from 212 (2010 to 2014 average) to 181 in 2017.

Project Title: Louisiana State Police (LSP) Crash Reduction Grant

Project Description: The LSP conducted DWI, occupant protection, and speed enforcement throughout Louisiana. The LSP worked 8,573 hours of overtime occupant protection enforcement and 3,338 hours of overtime impaired driving enforcement. High fatal and injury crash locations, days, times, and vehicle type were a priority for enforcement activities throughout the year based on resources and crash analysis. During 2017, the LSP conducted four occupant protection checkpoints, issued 15,869 seat belt and child passenger citations, made 364 impaired driving arrests; and issued 2,052 speeding citations.

Enforcement was coupled with public information officers conducting education and outreach activities. LSP Public Information Officers (PIO) conducted 267 occupant protection related and 251 impaired driving related outreach events which included public information presentations. These presentations were used to inform the public of traffic safety issues. Pre- and post-enforcement efforts and statistics were publicized through print, TV, and/or radio media throughout the duration of the grant.

In addition, LSP planned and conducted various training courses that were made available to local law enforcement agencies statewide. The LSP subcontracted with nationally recognized law enforcement training agencies to conduct specific training courses. These training courses included: two SFST Instructor Development Course (41 students), one DRE Certification Courses (20 students), four SFST Certification/Practicum (107 students), seventeen SFST Training Field Courses (177 students), three ARIDE Course (72 students), eighteen ARIDE Field Courses (244 students), and one Radar Instructor Development Course that trained 28 students.

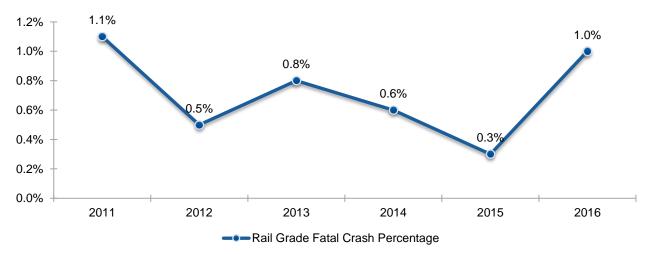

4.7 Community Traffic Safety Program

Louisiana's Strategic Highway Safety Plan (SHSP) is implemented through a robust infrastructure comprised of leadership committees, state-level emphasis areas teams, and nine multidisciplinary regional coalitions that collectively support program implementation at the local level. The SHSP regional coalitions have all developed regional data-driven action plans that are consistent with the SHSP's emphasis areas and address their region's most serious traffic safety problems. In FFY 2017, the LHSC funded pertinent regional coalition projects through a mini grant program.

4.8 Pedestrians/ Bicycle Safety

Louisiana uses a multifaceted approach to pedestrian and bicyclist safety to provide the maximum impact and likelihood for increasing pedestrian and bicyclist safety. The LHSC provides leadership, training, data, and technical assistance to other state agencies, law enforcement agencies, and to local pedestrian and bicyclist safety projects. The LHSC program identified the areas and populations with the highest rate of pedestrian and bicyclist crashes. The program is comprehensive in its geographic coverage, reach to high-risk populations, and engagement with a strong network of safety partners and advocates who implement evidence-based countermeasures.

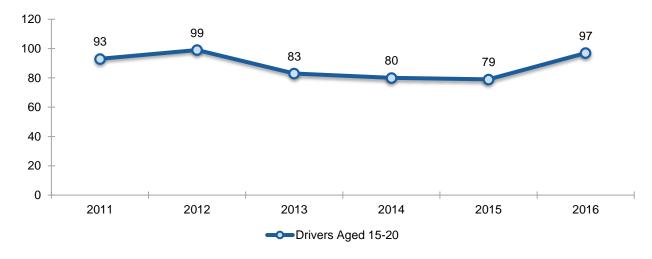

A unique social norms campaign focused on impaired driving was implemented within each school. The project evaluation will consist of both process and outcome measures. Pre and post-test shows four out of five students do not engage in alcohol consumption and do not approve of drinking and driving. There were 1,180 pre-test performed to determine social norm perceptions of each participating school and 1,641 high school students reached and 30,283 college students reached through peer to peer campaigns.

Project Description: LHSC provided funding to local police departments and sheriff's offices for high-visibility and sustained overtime enforcement of traffic safety laws. Each agency provided enforcement which coordinated with the annual campaigns as appropriate, in addition to other identified state enforcement waves. All law enforcement agencies that participated in this targeted overtime enforcement program utilized data to identify areas of critical needs. The local agencies conducted patrols based on their evidence-based enforcement plan, deployed resources based on crash analysis, and make adjustments throughout the year as needed.

Participating agencies conducted checkpoints, saturation patrols, and yearlong enforcement to correspond with the two national "Click It or Ticket" and "Drive Sober or Get Pulled Over" and state mobilizations. Law enforcement

agencies worked 38,584 hours of occupant protection saturation patrols and 5,890 hours at seatbelt checkpoints, issuing 49,787 adult seat belt citations and 2,923 child passenger seat citations, worked 45,026 impaired driving saturation patrol hours, conducted 395 sobriety checkpoints, and worked 13,598 checkpoint hours. Agencies deployed resources based on crash analysis and made adjustments throughout the year as needed. Project Title: Louisiana State Police (LSP) Crash Reduction Grant

Project Description: The LSP conducted DWI, occupant protection, and speed enforcement throughout Louisiana. The LSP worked 8,573 hours of overtime occupant protection enforcement and 3,338 hours of overtime impaired driving enforcement. High fatal and injury crash locations, days, times, and vehicle type were a priority for enforcement activities throughout the year based on resources and crash analysis. During 2017, the LSP conducted four occupant protection checkpoints, issued 15,869 seat belt and child passenger citations, made 364 impaired driving arrests; and issued 2,052 speeding citations.

Enforcement was coupled with public information officers conducting education and outreach activities. LSP Public Information Officers (PIO) conducted 267 occupant protection related and 251 impaired driving related outreach

events which included public information presentations. These presentations were used to inform the public of traffic safety issues. Pre- and post-enforcement efforts and statistics were publicized through print, TV, and/or radio media throughout the duration of the grant.

In addition, LSP planned and conducted various training courses that were made available to local law enforcement agencies statewide. The LSP subcontracted with nationally recognized law enforcement training agencies to conduct specific training courses. These training courses included: two SFST Instructor Development Course (41 students), one DRE Certification Courses (20 students), four SFST Certification/Practicum (107 students), seventeen SFST Training Field Courses (177 students), three ARIDE Course (72 students), eighteen ARIDE Field Courses (244 students), and one Radar Instructor Development Course that trained 28 students.

4.10 Distracted Driving

Louisiana's current distracted driving law consists of a hand held ban for drivers with a learner or intermediate license regardless of age, a primary cell phone ban for bus drivers, a primary cell phone ban for novice drivers during their first year of licensure, and a primary texting ban on all drivers.

Performance Target

Reduce distracted driving fatalities by 27 percent from 41 (2012 to 2014 average) to 30 by 2017.

Project Description: This was a statewide comprehensive injury prevention program for adolescents to decrease the number of alcohol-impaired traffic fatalities and participating in high-risk behavior that accompanies driving while intoxicated and included information on distracted driving and occupant protection. The program increased knowledge, created positive attitudes and influenced healthy decisions related to driving under the influence of alcohol through a multidisciplinary, multi-tiered approach. In FFY 2017, 8,738 students attended hospital based and on-site school presentations, 7,797 students viewed Mock Crashes, 3,929 students viewed Mock Trials, and 253 students participated in Senior Sessions.

5.0 Safety Communications

5.1 Paid/ Earned Media

The state did not fund any paid media placement in FFY 2017. A new paid media contractor for FFY 2018 is currently being selected through the RFP process.

A number of earned media initiatives were completed in FFY 2017. The news releases, letters, and columns Lambert Media issued were published hundreds of times by print publications in Louisiana. In addition, thousands of social media postings were made, and many of these were reposted by others. Social media efforts yielded a 103.2 percent growth in the LHSC's Facebook audience as measured by the number of "likes" the page received and a 17.3 percent growth in Twitter followers. Media Monitoring Service

LHSC contracted with a media monitoring service to monitor articles relating to impaired driving, occupant protection, distracted driving, teens, and a number of other topics of interest to LHSC that had an estimated value. According to the information submitted by the service, the estimated value of earned media coverage of highway safety issues was \$44,533,059.00 for FY 2017, this includes:

- \$20,801,389 in coverage for impaired driving;
- \$6,848,343 in coverage for occupant protection; and
- \$16,982,327 for general highway safety issues, including distracted or inattentive driving, railroad crossing safety, pedestrian safety, work zone awareness, speeding, tailgating, etc.

Many of the stories in the general highway safety issues category also included occupant protection and impaired driving issues but may not have been specifically categorized as such.
