# **Mission Statement**

To reduce the number and severity of traffic crashes in Indian Country by supporting education, enforcement, and safe tribal community programs.

# **Vision Statement**

To create a safe tribal community environment where roadways in Indian Country are safe for all.

## Introduction

According to the 2010 U.S. Census, the United States is home to 308,745,538 people. Of these individuals, approximately 2,932,248, 0.9%, identify themselves as American Indian and/or Alaska Native. Consistent with the general population in the United States, the largest age group for American Indian/Alaska Natives is 35-44 years of age. These American Indians/Alaska Natives represent over 574 federally recognized tribes throughout the country.

Despite their small ethnicity numbers, American Indians/Alaska Natives continue to be killed and injured in traffic crashes at rates that are 2 to 3 times that of other ethnic groups and that of the national average.

The tribes that comprise the Indian Nation are geographically spread throughout the United States, and it is extremely difficult to affect change in motor vehicle deaths in each of them. Each tribe is unique in its heritage, language, and lifestyle. The lack of motor vehicle crash data and tribal reporting are areas of continual struggle.

The FY21 Request for Proposal (RFP) was mailed to the tribal leaders of all federally recognized tribes in the United States in February 2020. Prospective applicants were required to submit proposals no later than May 1, 2020. The Indian Highway Safety Program (IHSP) received 35 tribal project proposals for FY21. Out of the 35 proposals received 35 were awarded: 29 for Police Traffic Services and 6 occupant protection.

A Selection Committee met in May of 2020 to review and score all proposals. This Selection Committee was comprised of representatives from the National Highway Traffic Safety Administration, and Bureau of Indian Affairs Office of Justice Services. Indian Health Services and State of New Mexico were not available to assist in the Selection Committee in May of 2020. 35 Tribal highway safety projects were included in the initial FY21 Highway Safety Plan (HSP) submitted to NHTSA for final approval. NHTSA approved 35 projects for funding. 29 Police Traffic Services and 6 Occupant Protection, 32 total, tribal grantee accepted FY21 grant awards (28 Police Traffic Services and 4 Occupant Protection).

The approved IHSP projects for FY21 consisted of 35 grants, for tribes in 15 different states, in the program areas of Police Traffic Services straight-time, overtime enforcement, and occupant protection. The projects included some of the largest tribes in the country. Data provided in this report is based upon statistics submitted from 29 of the Police Traffic Services 6 Occupant Protection Tribal projects and the national Fatality Analysis Reporting System. The IHSP utilized FARS reporting for FY17 because FY21 was not available at the time. The FY21 Annual Report will be using the most current FY18 FARs data.

The IHSP staffing for FY21 included a Program Director, Program Coordinator, Financial Analyst, Highway Safety Specialist, and two (2) Law Enforcement Assistants.

# **FY21** Tribal Project Reports

The BIA IHSP utilizes the funding in order to provide supplemental funding to tribes for strategic targeted enforcement activities. This year the IHSP funded 35 programs, 6 Occupant Protection grants with 29 Police Traffic Services grants, Indian Country Seat Belt Survey, and funding for BAT mobiles; other funds are also provided in support through training activities. The focus of all funded programs is to have an impact on the total number of Native Americans killed in traffic related deaths nationwide. The information provided in this section outlines the activities which our tribal programs have produced in order to have an effect on the overall fatalities as reported to FARS each year.

The Tribal Project Reports contain information on the results put forth by each tribal grantee's hard work in traffic safety. Their individual tribal efforts are aimed to collectively have an effect on the Indian Nations safety targets identified in the 2021 HSP.

# FY21 IHSP 402 Expenditures

The IHSP expended a total of \$4,373,990.21 in FY21 for Tribal Highway Safety Projects, BAT Mobile operation and maintenance costs, and Planning and Administration.

In FY21, many tribal governments across the United States were forced to shut down their tribal operations and mandate lock downs on their reservations due to the COVID-19 pandemic. This was done to keep their people safe and to slow the spread of the COVID-19 virus among tribal members and employees. The lock downs limited access to the reservation roadways not only to tribal members but also non-tribal members.

Tribal law enforcement limited their interactions with the general public to assist in containing the spread of COVID-19. COVID-19 is spread by person-to-person through respiratory droplets, tribal law enforcement officers were at an increased risk of exposure

due to their close contact with the public. COVID-19 pandemic did not allow for tribal police departments to fully expend their grant budgets. Officers were forced to suspended training, community outreach initiatives, increase traffic patrol and decrease traffic contacts on their roadways. COVID-19 prohibited the tribal police departments from reaching their traffic goals in reducing motor vehicle crash fatalities and issuing citations and increasing DUI arrests for the FY21 grant year. In addition, tribes are also suffering the effects of the lack of officers or officers leaving the profession.

# **IHSP Targets for FY21**

To reduce death and injury rates resulting from traffic crashes among Indian Tribes and on the reservations within the United States.

To reduce all fatalities on Indian Reservations by 4% from the 2017 FARS number of 394 to 380 by the end of FY 2021. According to 2018 FARS data there were 377 motor vehicle fatalities on reservations.

In FY21: The 33 funded Tribes reported a total of 3,964 motor vehicle crashes, of which 995 were injury crashes. 458 of the crashes involved alcohol and 469 were speed related.

In FY20: The 34 funded Tribes reported a total of 4,074 motor vehicle crashes, of which 961 were injury crashes. 448 of the crashes involved alcohol and 423 were speed related.

In FY19: The 37 funded Tribes reported a total of 3,908 motor vehicle crashes, of which 951 were injury crashes. 364 of the crashes involved alcohol and 330 were speed related.

# **Planning & Administration:**

The target of the BIA IHSP is to effectively administer highway safety funds, offer technical assistance to all tribes requesting assistance and monitor funded projects to reduce traffic related deaths and injuries in Indian Country.

The BIA IHSP awarded 35 grants in FY21. During the fiscal year, services and technical assistance were provided to approximately 35 Tribes throughout the country. This was accomplished by providing media materials for the impaired driving and safety belt mobilizations. Tribes not currently funded by the IHSP also attend Lifesavers Conference and Grant Writing training.

# **Impaired Driving:**

The BIA IHSP planned to reduce the incidence of impaired driving by increasing DUI/DWI/OWI arrests by all funded traffic activity within the participating tribes by 8% from the FY2019 total of 3,251 to 3,500 by the end of FY2021.

33 tribes were funded for traffic enforcement grants and 0 OWI Court grant in FY2134 tribes were funded for traffic enforcement grants and 0 OWI Court grant in FY2041 tribes were funded for traffic enforcement grants and 0 OWI Court grant in FY19

In FY 21: 33 funded Tribes reported 3,338 DUI/DWI/OWI arrests. The target was not achieved. Tribal governments limited access on reservation roadway to tribal members only and implemented lock downs. Limited access and lock downs contributed to the decreased number of traffic violations during the FY21 grant year.

# **Occupant Protection:**

The BIA IHSP planned to increase safety belt usage rates in Indian Country from the FY 2019 "national" Indian Country rate of 77% to 80% by the end of FY2021.

Safety Belt usage experienced an increase from 76.3% in FY20 to 78.8% in FY21. The Safety Belt usage rate in Indian Country increased by 2.5% is statistically at a standstill due to the relative error rate of the survey is  $\pm 1.96\sigma$ . The safety belt target was not achieved but the seat belt usage rate in Indian Country is continuing to be a priority. 33

grant funded tribes provided 04 educational presentations to their communities to raise awareness on traffic safety and occupant protection. COVID-19 pandemic kept many grant funded tribes from providing educational presentations due to tribal governments shutting down tribal run facilities to reduce the spread of the virus.

Seven grant funded tribes participated in the "Click It or Ticket" national safety belt mobilization and reported statistics on activity reports.

The BIA IHSP planned to increase safety belt usage rates in Indian Country from the FY 2019 "national" Indian Country rate of 77% to 80% by the end of FY2021.

Performance measure to be tracked: Number of seat belt citations issued during grantfunded enforcement activities.

In FY21: The 33 Tribes funded by the BIA IHSP reported issuing a total of 1,832 safety belt violations and 654 child passenger safety violation citations throughout the project year.

In FY20: The 34 Tribes funded by the BIA IHSP reported issuing a total of 1,732 safety belt violations and 518 child passenger safety violation citations throughout the project year.

In FY19: The 37 Tribes funded by the BIA IHSP reported issuing a total of 2,638 safety belt violations and 633 child passenger safety violation citations throughout the project year.

#### **Police Traffic Services:**

The Police Traffic Services grants are designed to provide an ongoing sustained impaired driving, speeding, occupant protection and child passenger safety enforcement throughout the grant year.

The BIA IHSP planned to reduce the number of speed related fatalities, on Indian Reservations, by 3% from the 2017 FARS number of 119 to 115 by the end of FY2021.

In FY21: The 33 Tribes funded by the BIA IHSP reported a total of 22 speed-related motor vehicle fatalities on their reservations during the project year.

In FY20: The 34 Tribes funded by the BIA IHSP reported a total of 23 speed-related motor vehicle fatalities on their reservations during the project year.

In FY19: The 37 Tribes funded by the BIA IHSP reported a total of 13 speed-related motor vehicle fatalities on their reservations during the project year.

The BIA IHSP planned to increase the number of citations issued for speed, on Indian reservations, by 8% from the FY2019 number of 38,775 to 39,500 by the end of FY2021.

This target was not met in the FY21 grant year. Tribal governments also limited access

on reservation roadway to tribal members only and implemented lock downs. Limited access and lock downs contributed to the decreased number of traffic violations during the FY21 grant year.

In FY21: 33 Tribes funded by the BIA IHSP reported 36,926 speed citations issued during the project year.

Performance Measure to be tracked: Number of pedestrian fatalities.

In FY21: Number of pedestrian fatalities reported by 33 Tribes was 16. In FY20: Number of pedestrian fatalities reported by 34 Tribes was 10. In FY19: Number of pedestrian fatalities reported by 37 Tribes was 2.

# **Evidence Based Enforcement Program Activities:**

The evidence-based enforcement activities utilized in order to meet the identified targets included:

- Indian Country evidence-based activities included individual tribal analysis of crashes, crash fatalities and the identification of high-risk crash areas utilizing local crash data.
- The tribal agencies then deployed a range of enforcement activities through the use of tribal enforcement resources based on the crash analysis and other elements. The activities included: saturation patrols, sobriety checkpoints, overtime enforcement activities and other proven strategies to alleviate unsafe roadway behavioral issues.
- The tribes utilized crash date to educate and inform tribal members on roadway safety dangers through educational presentations and other communication efforts at the local tribal level.

# **Impaired Driving Program Area**

The BIA IHSP has over the years funded many projects aimed at reducing the high rates of drinking and driving on the reservations. The program also remains committed to providing training, educational materials, and equipment necessary to assist tribal law enforcement officers and police departments in their efforts to remove drunk drivers from the roadways through sustained enforcement efforts.

All funded projects in FY20 signed a commitment to participate in all national traffic safety campaigns. Tribes were also required to participate in, and report on, the "Don't Shatter the Dream", Indian State Impaired Driving Mobilization. Funded Tribes

participated by conducting checkpoints, saturation patrols and/or enhanced enforcement. Extra funding was added to each project budget for high visibility sustained enforcement throughout the year.

Each of the tribal projects funded in FY21 had an alcohol related performance measure.

# **Impaired Driving Program Area Target:**

The BIA IHSP planned to reduce the incidence of impaired driving by increasing DUI/DWI/OWI arrests by all funded traffic activity within the participating tribes by 8% from the FY2019 total of 3,251 to 3,500 by the end of FY2021. In FY20: 34 Tribes funded by the BIA IHSP reported 3,483 DUI/DWI/OWI arrests.

In FY21: 33 Tribes funded by the BIA IHSP reported 3,338 DUI/DWI/OWI arrests.
In FY21: 33 Tribes reported conducting 124 checkpoints.
In FY21: 33 Tribes reported conducting 1,247 saturation patrols
In FY20: 34 Tribes funded by the BIA IHSP reported 3,483 DUI/DWI/OWI arrests.
In FY20: 34 Tribes reported conducting 77 checkpoints.
In FY20: 34 Tribes reported conducting 2,361 saturation patrols
In FY19: 37 Tribes funded by the BIA IHSP reported 3,251 DUI/DWI/OWI arrests.

The White Earth Nation, Minnesota Chippewa Tribe - Leech Lake Band, and Upper Sioux Tribes in Minnesota and the Shoshone Bannock Tribe in Idaho could not conduct sobriety checkpoints as state law does not permit but did participate in the saturation patrols.

*Note:* For each Tribal project, the Reservation Population and Land Base information is from Tiller's Guide to Indian Country updated with 2010 Census data with the exception of the Upper Sioux Tribes.

# AL-21-01 – BIA OJS (Office of Justice Services)

#### **Grant Award: \$100,000.00**

#### Amount Expended: \$62,744.86

#### **TARGET:**

To provide support for the continued operation and maintenance of the Breath Alcohol Testing (BAT) Mobiles purchased for use in Indian Country which will result in decreased alcohol related motor vehicle crash injuries and fatalities within the participating Tribes.

In FY21 the BAT Mobile was deployed 0 times, in 0 check points, used for traffic control 0 times and once for educational purposes.

In FY21 the BAT Mobile was used for zero (0) educational event on the reservation.

To support the tribes the BIA IHSP purchased four (4) BAT Mobiles in FY10. This was a collaborative effort between the IHSP and OJS Districts. The BAT Mobiles are available for tribal use in OJS Districts I (South Dakota), III (Phoenix), IV (Albuquerque), and V (Billings).

The purchase of these BAT Mobiles has allowed Tribes to combat drunk drivers more effectively on the reservations and to decrease alcohol related motor vehicle crash injuries and fatalities within the participating tribes in OJS Districts I, III, IV, and V.

This allowed for a total of approximately zero (0) Tribes to have access to the BAT Mobiles in these OJS Districts for education, checkpoint, and traffic control use.

The BAT Mobile was utilized in zero (0) BIA OJS District IV at sobriety checkpoints and made available for viewing to tribal community members and school students during health fairs and public safety days. Due to the COVID-19 pandemic BAT Mobiles were not deployed.

# **Occupant Protection Program Area**

Motor vehicle crashes (MVC's) are the leading cause of death and injuries to Native Americans in the United States. Native Americans are killed at rates at least twice that of all other ethnic groups in this country. These high death rates can be attributed to several factors including the low and non-use of safety belts and child passenger safety restraint usage on the reservations.

## **Occupant Protection Program Area Target:**

The BIA IHSP planned to increase safety belt usage rates in Indian Country from the FY 2019 "national" Indian Country rate of 77% to 80% by the end of FY2021.

Indian Country is now at 78.8% in 2021. While Native American utilization is still lower than the national rate, there has been progress made in Indian Country; seat belt use will continue to be one of the primary focus areas of the IHSP as seat belt usage continues to rise.

# **Child Passenger Safety**

For several years, the BIA IHSP has collaborated with the Indian Health Service to provide child passenger safety seats for Native American children and child passenger safety support safety materials for clinics, checkpoints and fitting stations for those tribes working with their respective Indian Health Service Injury Prevention Specialists.

In FY21, the BIA IHSP awarded Occupant Protection grants to the Tribes. The BIA IHSP reimbursed a total of \$30,773.92 to grant funded tribes for child safety seats in FY21. The reaming seats that were not distributed during the period of performance will remain with the tribe and are not reimbursable.

#### **TARGET:**

The BIA IHSP planned to increase safety belt usage rates in Indian Country from the FY 2019 "national" Indian Country rate of 77% to 80% by the end of FY2021.

Indian Country is now at 78.8% in 2021. While Native American utilization is still lower than the national rate, there has been progress made in Indian Country; seat belt use will continue to be one of the primary focus areas of the IHSP as seat belt usage continues to rise.

Occupant Protection: (Seat Belt Survey) - This grant is a financial assistance award to conduct seat belt usage survey on various reservations throughout Indian Country. Planned activity for this grant is for the contractor to observe seat belt use for passenger vehicles front seat outboard occupants for a select group of federally recognized tribes. The report will reflect trends on seat belt usage throughout Indian Country.

# **Police Traffic Services Program Area**

The BIA IHSP has remained committed to providing the necessary tools and training that tribal law enforcement departments need to effectively enforce traffic laws and ordinances.

All Tribal law enforcement agencies funded in FY21 signed commitments to participate in all national mobilizations as well as enhanced enforcement at other times of the year and sustained enforcement throughout the year. Additionally, extra funding was added to each project so they could conduct high visibility enforcement throughout the year.

The BIA IHSP staff depends on the NHTSA Region 6 Media Consultant to provide mobilization campaign material to distribute to tribes nationwide. It is invaluable during the national mobilizations the grant funded Tribes are required to participate in. The media services were available but didn't provide much for the tribes to utilize in this time period.

The BIA IHSP Director did not conduct any site visits in FY21. The site visit is used to ensure compliance with grant agreement requirements and evaluate the project progress toward stated goals. Site visits will be conducted in the upcoming year, dependent on the mitigation of the covid pandemic precautions.

In FY21, the BIA IHSP Director and Program Coordinator continued to evaluate and assist tribes to meet their performance measures/targets. Tribal Police departments had difficulty in meeting their overall and individual performance measures. This could be due to high visibility enforcement which would deter traffic infractions and keep impaired drivers off the road. It should be noted Tribal Police Departments issued 20,302 verbal and written warnings during the grant year. This may not be effective to change driver behavior, it illustrates Tribal Police are making vehicle contacts.

#### Police Traffic Services (PTS) Program Area Target:

The BIA IHSP planned to reduce the number of speed related fatalities, on Indian Reservations, by 3% from the 2017 FARS number of 119 to 115 by the end of FY2021. FARS 2018 reported 120 speed related fatalities on reservations.

33 Tribes funded, by the BIA IHSP, in FY21 reported a total of 22 speed-related motor vehicle fatalities on their reservations during the project year. This target was met.

The BIA IHSP planned to increase the number of citations issued for speed, on Indian reservations, by 8% from the FY2019 number of 38,775 to 39,500 by the end of FY2021.

33 Tribes funded, by the BIA IHSP, in FY21 reported 36,926 speed citations issued during the project year. This target was not met in the FY21 grant year. Tribal governments also limited access on reservation roadway to tribal members only and

implemented lock downs. Limited access and lock downs contributed to the decreased number of traffic violations during the FY21 grant year.

To maintain the number of motorcyclist fatalities, on Indian Reservations, by the 2017 FARS number of 19 by the end of FY2021.

Number of motorcyclist fatalities reported by 33 funded Tribes was 1. Number of un-helmeted motorcyclists was 0.

To reduce the number of pedestrians involved in fatal crashes on reservations by 6% from 2017 FARS number of 62 to 58 in 2021.

Number of pedestrian fatalities reported by 33 Tribes in FY20 was 16.

#### **FY21** Core Outcome Measures

**A-1 Core Measure:** Seat belt citations issued during grant-funded enforcement activities current:

In FY21: 33 Tribes reported 2,486 seat belt citations issued.

**A-2 Core Measure:** Impaired driving arrests made during grant-funded enforcements activities current:

In FY21: 33 Tribes reported 3,338 DUI/OWI arrests were made.

**A-3 Core Measure**: Speeding citations issued during the grant-funded enforcement activities current:

In FY21: 33 Tribes reported 36,926 speed citations were issued.

**B-1 Core Measure:** The BIA IHSP planned to increase safety belt usage rates in Indian Country from the FY 2019 "national" Indian Country rate of 77% to 80% by the end of FY2021.

In FY21: Indian Country is now at 78.8%.

**C-1 Core Measure:** To reduce all fatalities on Indian Reservations by 4% from the 2017 FARS number of 394 to 380 by the end of FY 2021. According to 2018 FARS data there were 377 motor vehicle fatalities on reservations. FARs shows motor vehicle crash fatalities are declining from 394 in 2017 to 377 in 2018.

In FY21: 33 Tribes reported a total of 75 motor vehicle fatalities.

**C-4 Core Measure:** To reduce the total number of un-restrained passenger vehicle occupant fatalities, all seat positions by 3% from the 2017 FARs number of 144 to 139 by the end of FY2021. Current FARS 2018 data reflects 142 un-restrained passenger vehicle occupant fatalities all seat positions. Un-restrained passenger vehicle-occupant fatalities all seat positions have decreased for the 2016 number of 262 to 142 in 2018.

**In FY21:** 33 Tribes reported a total of 26 un-restrained passenger vehicle occupant fatalities all seat positions on their reservations.

**C-5 Core Measure:** Reduce crash fatalities on Indian Reservations involving drivers or motorcycle operators with a BAC of 0.08 or above, by 5% from the FARS 2017 number of 158 to 150 by the end of FY2021. Current 2018 FARS data reflects the number of on reservation fatalities in crashes involving a driver/motorcycle rider increased from the 2017 number of 154 to increased to 164.

In FY21: 33 funded Tribes reported a total of 6 fatalities with drivers with .08+ BAC.

**C-6 Core Measure:** To reduce the number of speed related fatalities, on Indian Reservations, by 3% from the 2017 FARS number of 119 to 115 by the end of FY2021.

Current 2018 FARs data reflects an upward trend of fatalities on reservations from the 2016 number of 117 to 120.

**In FY21:** 33 funded Tribes reported a total of 22 speed-related motor vehicle fatalities on their reservations during the project year.

**C-7 Core Measure:** To maintain the number of motorcyclist fatalities, on Indian Reservations, by the 2017 FARS number of 19 by the end of FY2021. Current FARS 2018 data shows motorcyclist fatalities on reservations have increased from the 20 number in 2016 to 21.

**In FY21:** 33 funded tribes reported 1 motorcyclist fatalities on their reservations during the project year.

**C-8 Core Measure:** To maintain the number of un-helmeted motorcyclist fatalities on reservations by the 2017 FARS number of 11 by the end of 2020.Current 2018 FARs data reflects a downward trend of unhelmeted motorcycle fatalities on reservations to 4.

**In FY21:** 33 funded tribes reported 0 un-helmeted motorcyclist fatality on their reservations during the project year.

**C-9 Core Measure:** To decrease the number of drivers 20 or younger on reservations involved in fatal crashes by 6% from 2017 FARS number of 18 to 17 in 2021. Current 2018 FARS data reveals a downward trend of 16 driver fatalities age 20 and younger on reservations.

**In FY21:** 33 funded tribes reported a total of 9 fatalities of drivers 20 or younger fatalities on their reservations during the project year.

**C-10 Core Measure:** To reduce the number of pedestrians involved in fatal crashes on reservations by 6% from 2017 FARS number of 62 to 58 in 2021.Current FARS data from 2018 shows a decrease in pedestrian fatalities on reservations at 56.

**In FY21:** 33 funded tribes reported a total of 16 pedestrian fatalities on their reservations during the project year.

**C-11 Core Measure**: To maintain the number of bicyclists on reservation involved in fatal crashes by the 2017 FARS number of 2 in 2021. Current FARS 2018 data shows the number of pedal cyclist fatalities of 2 which reflects an increase from the 2017 number of 3.

#### **SUMMARY:**

The COVID-19 Pandemic is still affecting day to day operations within the Navajo Nation which resulted in not allowing the Navajo Nation Police Department to fully expend grant funds. Administrative staff have been teleworking to continue the day-to-day operations but also caused a delay in processing paperwork. The grant program had a change in Project Coordinators during the grant year. Purchase deadlines were not met due to Navajo Nation governments requirements on programs to undergo a strenuous procurement process before purchases can be approved. Police units were not

purchased due to vendors experiencing vehicle shortages because of the world-wide COVID-19 Pandemic. Data Clerk position was approved by the Human Resources but the IHSP grant has not been approved internally. The approval is delaying advertisement of the Data Clerk position.

Navajo Nation Police Department did not fully meet their FY21 targets due to Highway Safety Officers (HSO) appointments fluctuating during the grant year. The department appointed 3-6 Officers to work the grant, covering 7 districts. Mid-year the NNPD decided to have HSO's concentrate on traffic enforcement within their respective police districts. In April 2021, Police Districts statistics were included with the monthly report however it off-set the statistics. The Project Coordinator chose not to include overall police agency stats. This will become a practice for FY22.

#### **SUMMARY:**

White Mountain Apache tribe did not fully expend grant funds because of the COVID-19 state of emergency throughout the entire FY2021. Some of their overtime efforts still involved the department's COVID response.

Target 1 not achieved: unfortunately had a total of 8 MVC fatalities. Out of those 8 fatalities, half were intoxicated pedestrians walking along the road during night hours, in areas where the highway either had no artificial lighting or very dim lighting. This element made it difficult for those sober drivers to see the 4 pedestrians. Tribal DOT is working on getting better lighting. Target 2 not achieved: The department had more MVCs than anticipated. Hopefully with 2 HSO's for FY22 the department can curb the motor

vehicle crash rate. The department was successful in meeting target goals for targets 3-5.

# **SUMMARY:**

the end of FY21.

Original award was in the amount of S 1,066,663 .00. With Budget Modifications the final total awarded was \$1,070,776.44. Due to significant and unusual events, not all the targets were met and not all the overtime funds were expended. There have been several issues that have arisen during the fiscal year that limited the use of funding. The Miccosukee Tribe of Indians is still operating under strict COVI0-19 restrictions, based on the high numbers of COVI0-19 positive cases affecting Florida. These restrictions have adversely affected staffing, scheduling, overtime, minimized any training, and all but eliminated travel. These restrictions made implementing the use of federal funding difficult. In February of 2021, the agency was struck with tragedy, as one of the tribal Highway Safety Officers was killed in a vehicle crash

on duty. This incident crippled the agency, and the program was short staffed. In July of 2021, another the Highway Safety Officer sustained a severe Injury, putting the officer on light duty for a significant amount of time. These issues as outlined have severely hampered the grant program's ability to provide the same level of production and effectiveness as years prior. As COVID-19 restrictions are loosening and injured officer is returning to full duty, the agency expects to be back to providing the same level of service, as it relates to the BIA Traffic Safety Program.

#### **SUMMARY:**

During the FY2021, Leech Lake Band of Ojibwe-Leech Lake Tribal Police Department did not fully expend all grant funds provided by the BIA Indian Highway Safety Program as we had started the grant year with one Highway Safety Officer (HSO), they were able to hire a second HSO but shortly after the second hire, one HSO had resigned, and Leech Lake Band of Ojibwe- Tribal Police Department was down to a single HSO again. Training and Travel was fully spent due to COVID-19 restrictions on many trainings and travel bands. Billboard/Media and Equipment line items were fully expended. The grant programs purchased police units for the grant program

Leech Lake Tribal Police Department (LLTPD) reduced Motor Vehicle Crashes (MVC) to 34, unfortunately did not see a decrease in Motor Vehicle Crash Fatalities (MVCF) and ended the year with 3. The PD reached their DUI/DWI arrests goal of 58. The PD did not reach target goals for speed and traffic citations. Goals were not met due to short staffing issues and having only one HSO, there were two grant funded HSO's for a very short period, until one resigned. Citations issued were also short because of the COVID-19 restrictions. Restrictions included only stopping vehicles for more serious offenses, such as DWI/DUI's. Jails were not accepting offenders unless it was "serious" or "felony" level offenses. The court hearings for traffic stops, both "serious" and minor were also postponed or cancelled due to COVID-19 Restrictions.

#### **SUMMARY:**

Due to COVID-19 the police department (PD) was unable to complete a multitude of activities outlined in the grant. Officers normally working traffic safety overtime were pulled from traffic safety activities and moved to support pandemic security activities. Training classes were canceled due to the pandemic. Equipment purchases were canceled due to conflict with County Attorney's office and ability to prosecute utilizing the Draeger unit. The PD experienced a staff reduction of one full-time officer from the agency.

COVID-19 caused unprecedented changes to enforcement activities. With the pandemic in full effect, the PD noticed a marked change in traffic patterns and vehicle counts. Furthermore Highway 67 at the East reservation line has been permanently closed and detoured around the reservation due to land slide that

shifted the road and is no longer passable. With the government offices closed due to the COVID-19 pandemic the Minnesota Governor issued an executive order that closed the OMV offices and under executive order driver's license renewals and vehicle registration renewals were all put on hold and no enforcement action could be taken against someone for not renewing the registration or driver's license during the pandemic this caused a marked decline in traffic citations and traffic stops for these offenses. A fatal crash occurred when a drug impaired driver in a single vehicle crash drove off ,1 road and crashed into a tree killing passenger.

#### **SUMMARY:**

The Chippewa Cree Tribal Police Department (CCTPD) experienced the immediate effects of the COVID-19 pandemic. The department was assisting and tasked with manning 24-hour checkpoints to help the efforts to eliminate the spread of COVID-19 from March 16, 2020, until January 18, 2021. During grant year, law enforcement officers and HSO's were working mandatory 12-hour shifts. Much of the grant funds budgeted for highway safety overtime Don't Shatter the Dream Mobilization were not used because it was not feasible for the department to run. The tribe still had curfew orders in place. COVID-19 infections during the winter months resulted in many Law Enforcement staff going into

quarantine. The CCTPD achieved their goal for motor vehicle crash fatalities (MVC) ending the grant year with 0. They did not achieve their other grant targets for the year due to ongoing challenges the COVID-19 pandemic presented. One of the challenges was the reduction of traffic due to the 24-hour check points that were placed 4 months out of the year. For FY21 there were 96 motor vehicle crashes which is very consistent with FY20 crash data. There was also a decrease in DUI arrests from 160 (FY20) to 82. However, the department will continue to take an aggressive stance on drunk driving. For FY21 there was a decrease in speed citations from 804 (FY19) to 317, and traffic citations from the FY19 number of 600 to 390 (FY21), this is to be expected with the heavily monitored traffic going in and out of the reservation and checkpoints that slowed down the amount of traffic normally experienced on the roadways.

#### **SUMMARY:**

POL COVID-19 safety protocol curtailed many POL community events and activities due to the safety restrictions placed on all POL tribal employees and community members. Transitions in the HSO positions and HSO/LE personnel sick/quarantined due to COVID-19 impacted salary and fringe expenditures. The limited availability of regular patrol personnel resulted in the continued reliance on the HSOs to assist with CFS and other non-traffic safety activity. COVID-19 also impacted the largest portion of awarded funding (\$120K) for the purchase of two new police units. The manufacturer was not able to produce the vehicles until mid-September 2021 which would have delayed the request for reimbursement for these items. A request to move the funding forward into the 2022 grant funding was submitted and approved.

None of the targets for FY2021 were met. The number of MVCs & MVC fatalities increased as travel increased with the easing of COVID-19 restrictions throughout the state. There were 84 DUI/OWI arrests due to highly visible patrols by the HSOs/LEOs in areas with a high frequency of violations. POL Executive Order restrictions kept people at home, lowering the number of people driving intoxicated. Speed & other traffic violation citations were low due to the continued safety restrictions set by the POL EO regarding maintaining safe distances & large group gatherings. Check point events impacted the number of citations issued by the HSOs & regular patrol.

#### **SUMMARY:**

The reimbursable grant funds were not fully expended. Warm Springs Police Department (WSPD) did not receive their Tribal Council Resolution for the grant until mid-March 2021. WSPD was not able to purchase any equipment due to Tribal Procurement Policy, they did not have any time to attain quotes and bids and were unable to purchase equipment. With the ongoing COVID-19 pandemic, Tribe instituted a "Travel Ban" outside the immediate area and WSPD was unable to send any officers to training. Reducing Motor Vehicle Crash Fatalities target was not met. Fatal crashes increased to 4 during the grant period. Due to a high volume of turnover, dedicated traffic officers were redirected to covering patrol shifts and other community safety duties, taking their main focus from traffic enforcement/safety activities. Decreasing motor vehicle crashes and increasing DUI arrests was not met due to a high turnover rate, our officers were forced to be more "reactive", focusing on calls for service and less focused on traffic. Officers issued 630 citations for speeding but did not meet the target for the year.

The Cheyenne River Sioux Tribal Police Department (CRSTPD) did not fully expend grant funding due to an HSO #3 being hired under Emergency Appointment through COVID-19 on 05/2/2021. The funds not expended from the Salaries line items were used to purchase (23) radars for the HSO's and patrol officers to assist with traffic stops due to the high volume of traffic.

Due to the pandemic, the HSO's were directed to help with patrol duties (638), there was a reduction in traffic due to health checkpoints, lockdowns and resulted in not being able to meet performance

measures. There were 3 Motor Vehicle Fatalities and 233 Motor Vehicle Crashes, 1,566 speed and 1,721 traffic citations were issued during the grant year. The speed citation target was also increased with the tribes purchase of 23 radars with grant funding. As of today, only (13) are installed. The CRSTPD did meet the target for DUI arrests.

#### **SUMMARY:**

All the Wages, Fringe Benefits, Indirect Costs, Overtime, and Mileage was not expended because after we were approved a Budget Mod to add 2 HSOs and 1 Data Clerk #2 it took the tribe several months to advertise, do to background checks, interviews before the positions were filled. About this same time, the Captain of Highway Safety unexpectedly passed away, and it took some time to move staff around to fill the position. The vehicles and equipment ordered for the additional officers took more time than usual to receive and some of the quotes for the vehicles and equipment cost less than what was quoted.

The motor vehicle related fatalities target was not met because the officers have a large area to cover with most of the Police Officers handling their regular calls for service and 6 HSO covering the highways from one end of the reservation to the other. The Speed citations and traffic citations targets were not met because the first half of the year the reservation was under a "Shelter in Place" order because of the COVID-19 pandemic with a "Curfew" and "Lock-down" which resulted in reduced traffic flow. There was a higher volume of intoxicated pedestrians walking from location to location and the vehicles stopped during the curfew or lockdown resulted in DUI/OWI arrests. The DUI/OWI target was achieved along with the Motor Vehicle related Crashes.

#### **SUMMARY:**

During FY2 I Colville Tribal Police lost 7 officers to different agencies, death, and military leave. This, along with officers being off work due to COVID-19 illness, has left the department extremely short staffed which resulted in not being able to fully expend grant funding. The police department also has a contractual responsibility to the Bureau of Reclamation to provide 24/7 coverage at the Grand Coulee Dam. Since December of 2020, the tribe was short staffed a BOR officer which led to officers being pulled from the road to fill that shift. During FY21 hired three new officers, however, between the academy and FTO they have only recently been out on the road by themselves. This summer the tribe was plagued with wildland fires across the reservation as well as an increase in COVID-19 cases which

decreased the number of officers we had on the road.

Though we were able to reduce the number of motor vehicle collisions across the reservation during FY21, we were unable to achieve the rest of the targets. Running on a bare minimum of staff and the COVID-19 pandemic has taken its toll on officers and the membership. The officers have been making contacts with drivers, they had 691 warnings issued this year, but have not been issuing many citations.

#### **SUMMARY:**

The Fort McDowell Police Department was unable fully expend grant funding. Funding was utilized to the best of our ability, attempting to hold saturation patrols every month. Unfortunately, this fiscal year the nation was hit with the COVID- 19 pandemic, limiting our ability to hold required mobilizations. Saturation patrols were attempted with proper PPE, to use visual presence as a deterrent for driving behavior, with corrective action taken when needed. The department utilized Facebook, Instagram, and a traffic/messaging board to promote good driving behaviors and announced saturation patrols. The nation passed a Hands-Free Law to match the state of Arizona for hands free driving.

The department did not meet any of their targeted goals. The nation has reached out to ADOT over the last 24 months and had speed bumps added to make drivers aware when approaching traffic signals and also had reflective barriers installed around the lights to help with the rising and setting sun. The department continues to have a high number of private property crashes from the golf course and casino parking lots. The nation is open range, and they have several vehicles vs. livestock crashes per year. DUI arrests, Speed citations and Traffic citations were not met. The nation did participate in the DSOGPO mobilization and attempted several other saturation patrols when allowable. Strict COVID-19 protocols were in place and the department scaled back on personal contact unless obvious serious violations were committed.

- Request for Reimbursement reconciliation continues to be document heavy and with minimal staff, continues to limit the number of programs we can provide to the tribes. We hope to find a path to digital reporting for the tribes.
- The documentation of Officer productivity will continue to evolve to a digital format when the tribal police could do it in a confirmable format. We have plans to conduct virtual training on this subject to enhance a better understanding of the importance of daily log activities.
- Traffic data collection for tribes continues to be a priority and the IHSP will continue to encourage partnerships with state reporting formats or utilizing the tribal crash data tool which was introduced this fiscal year.
- The BAT Mobiles have started the process to be moved from BIA oversight and to the tribal possession. There have been 4 tribes interested in obtaining the vehicles. The receiving agencies do have the statistics to support the year around use of these vehicles.
- The continued issue of the 5% P&A allowance continues to hamper the growth of services to Indian Country. The new Infrastructure bill did not directly address the needs. Additional communication on this matter is planned for FY22

Motor vehicle crash fatalities continue to increase within the projects funded by IHSP from FY20 (68) to FY21 (75). The percentage of Alcohol involved has increased and noted to be 40.0%, excessive speed identified at 29.3% and non-seat belt use is at 34.6% in the fatal crashes reported. Continuing to increase enforcement efforts in all these areas will be made in FY22.

Straight time and overtime grant programs worked aggressively on traffic safety/enforcement and impaired driving laws throughout the pandemic in FY21. Although the IHSP collectively didn't achieve the targets and goals in some areas for FY21, the tribal programs continued to mitigate the pandemic threats through continued social distancing for the officer's health and safety. The tribes continue to conduct high visibility traffic patrols to "be seen" and be a deterrent to unsafe driving behavior. Officers still utilize Protective Equipment, and the numbers of contacts has steadily risen and will continue to rise as the officers receive the vaccine and continue utilizing Personal Protective Equipment.

The IHSP plans to continue to work toward meeting and surpassing the Performance Measures/Targets outlined in our FY21 HSP. The IHSP is prepared to meet the targets

and challenges in the coming year. The IHSP will continue to provide technical assistance to each tribe when requested.

The continued priority for the IHSP is to work with the tribes in the RFR process to maintain accountability. The IHSP will be implementing a partnership with the tribes to identify discrepancies, sending the RFR back to the tribes to recalculate and return for processing; hoping to relieve some of the administrative processing burden to the IHSP staff. The lack of P&A costs and issues with staffing-created by continuing to utilize a paper-based reimbursement process is still an issue to be worked on.

FY22 the IHSP will continue to work with the Indian Police Academy on training. A class has already been set for June of 2022.

The IHSP will continue its efforts in FY22 to improve the collection of traffic crash data. The Infrastructure bill contains elements that mandate improved collection that must be implemented.

In FY2021, the IHSP offered Highway Safety Specialists to the tribes as a permanent position to work with all tribal departments in the interest of traffic safety. Only one tribe applied for and receive this position, we are hopeful to continue to expand this program in the upcoming year.

In FY2021 the IHSP will continue to offer Police Traffic Services and Occupant Protection grants to the tribes. The IHSP will continue with positive working relationships with the tribes who have received the grants and actively recruit other tribal programs in need.

As always, we appreciate the guidance and assistance of the NHTSA Region 6 staff and acknowledge and thank all our traffic safety partners.
