Mission Statement

To reduce the number and severity of traffic crashes in Indian Country by supporting education, enforcement, and safe tribal community programs.

Vision Statement

To create a safe tribal community environment where roadways in Indian Country are safe for all.

Introduction

According to the 2010 U.S. Census, the United States is home to 308,745,538 people. Of these individuals, approximately 2,932,248, 0.9%, identify themselves as American Indian and/or Alaska Native. Consistent with the general population in the United States, the largest age group for American Indian/Alaska Natives is 35-44 years of age. These American Indians/Alaska Natives represent over 560 federally recognized tribes throughout the country.

Despite their small ethnicity numbers, American Indians/Alaska Natives continue to be killed and injured in traffic crashes at rates that are 2 to 3 times that of other ethnic groups and that of the national average.

The tribes that comprise the Indian Nation are geographically spread throughout the United States, and it is extremely difficult to affect change in motor vehicle deaths in each of them. Each tribe is unique in its heritage, language and lifestyle. The lack of motor vehicle crash data and tribal reporting are areas of continual struggle.

The FY18 Request for Proposal (RFP) was mailed to the tribal leaders of all federally recognized tribes in the United States in February 2017. Prospective applicants were required to submit proposals no later than May 1, 2017. The Indian Highway Safety Program (IHSP) received 60 tribal project proposals for FY18. Out of the 60 proposals received 59 were awarded; 27 for Police Traffic Services and 32 occupant protection.

A Selection Committee met in May of 2017 to review and score all proposals. This Selection Committee was comprised of representatives from the National Highway Traffic Safety Administration, Indian Health Service, and a representative from the New Mexico Highway Safety Office. A total of 59 Tribal highway safety projects were included in the initial FY18 Highway Safety Plan (HSP) submitted to NHTSA for final approval. NHTSA approved 59 projects for funding which included 27 Police Traffic Services and 32 Occupant Protection grantees. Fifty-six (56) of the 59 tribal grantees accepted FY18 grant awards (26 Police Traffic Services and 30 Occupant Protection).

The approved IHSP projects for FY18 consisted of 59 grants for tribes in 18 different states, in the program areas of Police Traffic Services Full-time, Overtime Enforcement, and Occupant Protection. The projects included some of the largest tribes in the country. Data provided in this report is based upon statistics submitted from 27 of the Police Traffic Services, 32 Occupant Protection Tribal projects and the national Fatality Analysis Reporting System. The HSP utilized FARS reporting for FY14 because FY15 was not available at the time. The FY18 Annual Report will be using the most current FY 15 FARs data.

The IHSP staffing for FY18 included a Program Director, Program Coordinator, Financial Analyst, and two (2) Law Enforcement Assistants.

FY18 Tribal Project Reports

The BIA IHSP utilizes the funding in order to provide supplemental funding to tribes for strategic targeted enforcement activities. This year the IHSP funded 56 programs, the majority being Occupant Protection Grants with 26 Police Traffic Service Grants, and funding for BAT mobiles; other funds are also provided in support through training activities. The focus of all funded programs is to have an impact on the total number of Native Americans killed in traffic related deaths nationwide. The information provided in this section outlines the activities which our tribal programs have produced in order to have an effect on the overall fatalities as reported to FARS each year.

The Tribal Project Reports contain information on the results put forth by each tribal grantee's hard work in traffic safety. Their individual tribal efforts are aimed to collectively have an effect on the Indian Nations safety targets identified in the 2018 HSP.

FY18 IHSP 402 Expenditures


The IHSP expended a total of <u>\$4,062,802.01</u> in FY18 for Tribal Highway Safety Projects, BAT Mobile operation and maintenance costs, and Planning and Administration.

Overall Program Target:


IHSP Targets for FY18

To reduce death and injury rates resulting from traffic crashes among Native American Tribes and on the reservations within the United States.

To reduce all fatalities on Indian reservations by 11% from the 2014 FARS number of 359 to 318 by the end of FY2018. According to 2015 FARS data there were 369 motor vehicle fatalities on reservations.



FARs data reflects an upward trend in fatalities on reservations from FY2013 to FY2015.



In FY18: 26 Tribes reported a total of 51 motor vehicle crash fatalities on their reservations. Twenty-six (26) involved alcohol and 23 of the people killed were not wearing seat belts. The 3 Tribes with the highest number of MVC fatalities reported were:


In FY17: Twenty-six (26) of 27 Tribes reported a total of 30 motor vehicle crash (MVC) fatalities on their reservations. 15 involved alcohol, 14 involved excessive speed and 26 of the people killed were not wearing seat belts.



In FY16: Thirty-two (32) of 38 Tribes reported a total of 79 motor vehicle crash (MVC) fatalities on their reservations. Forty-three (43) involved alcohol, 20 involved excessive speed and 50 of the people killed were not wearing seat belts.

The 3 Tribes with the highest number of MVC fatalities reported were:





In FY18: The 26 funded Tribes reported a total of 3,218 motor vehicle crashes, of which 768 were injury crashes. There were also 354 crashes involving alcohol and 294 were speed related.

In FY17: The 26 of 27 funded Tribes reported a total of 2,988 motor vehicle crashes, of which 672 were injury crashes. There were also 334 crashes involving alcohol and 499 were speed related.

In FY16: The 32 of 38 funded Tribes reported a total of 4,467 motor vehicle crashes, of which 1,414 were injury crashes. There were also 427 crashes involving alcohol and 632 were speed related.

Planning & Administration:

The target of the BIA IHSP is to effectively administer highway safety funds, offer technical assistance to all tribes requesting assistance and monitor funded projects to reduce traffic related deaths and injuries in Indian Country.

The BIA IHSP awarded 59 project grants in FY18. During the fiscal year, services and technical assistance were provided to approximately 56 Tribes throughout the country. This was accomplished by providing media materials for the impaired driving and safety belt mobilizations. Tribes not currently funded by the IHSP also attended Lifesavers Conference and Grant Writing training.

Impaired Driving:

The BIA IHSP planned to reduce the incidence of impaired driving by increasing DUI/DWI/OWI arrests by all funded traffic activity within the participating tribes by 20% from the FY2016 total of 4,128 to 4,954 by the end of FY2018.

Twenty-six (26) tribes were funded for traffic enforcement grants and 0 OWI Court grant in FY18 Twenty-seven (27) tribes were funded for traffic enforcement grants and 0 OWI Court grant in FY17 Thirty-two (32) of 38 tribes were funded for traffic enforcement grants and 0 OWI Court grant in FY16

In FY 18: Twenty-six (26) funded Tribes reported 2,795 DUI/DWI/OWI arrests. Although the target was not achieved, low arrests numbers could be attributed to increased high visibility enforcement in FY18.

In FY 17: Twenty-six (26) of 27 funded Tribes reported 4,664 DUI/DWI/OWI arrests. Although the target was not achieved, the tribes reported 536 more DUI arrests than the previous year, FY16.

Performance Measure to be tracked: Number of fatalities involving a driver or motorcycle operator with .08+ BAC (Blood Alcohol Content).

In FY18: Twenty-six (26) funded Tribes reported a total of 19 fatalities with drivers with .08+ BAC. In FY18: Twenty-six (26) funded Tribes reported a total of 15 fatalities that were alcohol related

In FY17: Twenty-six (26) of 27 funded Tribes reported a total of 6 fatalities with drivers with .08+ BAC.


In FY17: Twenty-six (26) of 27 funded Tribes reported a total of 15 fatalities that were alcohol related.

In FY16: Thirty-two (32) of 38 funded Tribes reported a total of 33 fatalities with drivers with .08+ BAC.

In FY16: Thirty-two (32) of 38 funded Tribes reported a total of 43 fatalities that were alcohol related.

Occupant Protection:

The BIA IHSP planned to increase safety belt usage rates in Indian Country from the FY 2016 "national" Indian Country rate of 77.70% to 80% by the end of FY2018.



Safety Belt usage has increased from 76.8% in FY17 to 78% in FY18. The Safety Belt usage rate in Indian Country increased by 1.2% statistically, however it is at a standstill due to the relative error rate of the survey being $\pm 1.96\sigma$. The safety belt target was not achieved but the seat belt usage rate in Indian Country is continuing to rise. Fifty-nine (59) grant funded tribes provided 47 educational presentations to their communities to raise awareness on traffic safety and occupant protection.

The BIA IHSP planned to increase the number of tribes participating and reporting on the "Click It or Ticket" national mobilization from 17 in FY2016 to 20 by the end of FY2018.

Twenty-four (24) grant funded tribes participated in the "Click It or Ticket" national safety belt mobilization and reported statistics on activity reports. The target was achieved

Performance Measure to be tracked: Number of seat belt citations issued during grant-funded enforcement activities.

In FY18: The 26 Tribes funded by the BIA IHSP reported issuing a total of 2,816 safety belt violations and 657 child passenger safety violation citations throughout the project year.

In FY17: The 26 of 27 Tribes funded by the BIA IHSP reported issuing a total of 3,110 safety belt violations and 724 child passenger safety violation citations throughout the project year.

In FY16: The 32 of 38 Tribes funded by the BIA IHSP reported issuing a total of 2,718 safety belt violations and 553 child passenger safety violation citations throughout the project year.

Police Traffic Services:

The Police Traffic Services grants are designed to provide an ongoing sustained impaired driving, speeding, occupant protection and child passenger safety enforcement throughout the grant year.

The BIA IHSP planned to reduce the number of speed related fatalities, on Indian reservations, by 3% from the 2015 FARS number of 108 to 105 by the end of FY2018.

In FY18: The 26 Tribes funded by the BIA IHSP reported a total of 20 speed-related motor vehicle fatalities on their reservations during the project year.

In FY17: The 26 of 27 Tribes funded by the BIA IHSP reported a total of 14 speed-related motor vehicle fatalities on their reservations during the project year.

In FY16: The 32 of 38 Tribes funded by the BIA IHSP reported a total of 20 speed-related motor vehicle fatalities on their reservations during the project year.

BIA IHSP planned to increase the number of citations issued for speed, on Indian reservations, by 6% from the FY2016 number of 39,396 to 41,614 by the end of FY2018.

In FY18: Twenty-six (26) Tribes funded by the BIA IHSP reported 29,217 speed citations issued during the project year.

The BIA IHSP planned to increase the number of citations issued for other moving violations (excluding speed and DUI), on Indian reservations, by 12% from the FY2016 number of 33,947 to 38,023 by the end of FY2018.

In FY18: Twenty-six (26) Tribes funded by the BIA IHSP reported issuing 19,162 traffic violation citations. This target was not achieved but this may be due to increased high visibility traffic enforcement by tribal police departments.

In FY17: Twenty-six (26) of 27 Tribes funded by the BIA IHSP in FY16 reported issuing 19,521 traffic violation citations. This target was not achieved but this may be due to increased high visibility traffic enforcement by tribal police departments. In FY17, 26 tribes reported which is six less than the 32 tribes that reported from the previous year.

In FY18: Number of motorcyclist fatalities reported by the 26 funded Tribes was 0. In FY18: Number of un-helmeted motorcyclist fatalities was 0.

In FY17: Number of motorcyclist fatalities reported by the 26 of 27 funded Tribes was 0. In FY17: Number of un-helmeted motorcyclist fatalities was 1.

In FY16: Number of motorcyclist fatalities reported by the 32 of 38 funded Tribes was 3. In FY16: Number of un-helmeted motorcyclist fatalities was 1.

Performance Measure to be tracked: Number of drivers age 20 or younger involved in fatal crashes.

In FY18: Five (5) fatalities involving drivers age 20 or younger were reported by the Tribes. In FY17: Two (2) fatalities involving drivers age 20 or younger were reported by the Tribes. In FY16: One (1) fatality involving drivers age 20 or younger were reported by the Tribes.

Performance Measure to be tracked: Number of pedestrian fatalities.

In FY18: Number of pedestrian fatalities reported by 26 Tribes in FY18 was 9.

In FY17: Number of pedestrian fatalities reported by 26 of 27 Tribes in FY17 was 5

In FY16: Number of pedestrian fatalities reported by 32 of 38 Tribes in FY16 was 16.

Evidence Based Enforcement Program Activities:

The evidence based enforcement activities utilized in order to meet the identified targets included:

- Indian Country evidence based activities included individual tribal analysis of crashes, crash fatalities and the identification of high risk crash areas utilizing local crash data.
- The tribal agencies then deployed a range of enforcement activities through the use of tribal enforcement resources based on the crash analysis and other elements. The activities included: saturation patrols, sobriety checkpoints, overtime enforcement activities and other proven strategies to alleviate unsafe roadway behavioral issues.
- The tribes utilized crash data to educate and inform tribal members on roadway safety dangers through educational presentations and other communication efforts at the local tribal level.

Grant Award: \$169,006.40

Amount Expended: \$168,057.00

TARGET:

To establish an accurate account of all tribal law enforcement program crash records reporting status.

PERFORMANCE MEASURES:

Conduct Traffic Crash Records Summary Assessment of all Indian Country law enforcement programs through a contract which has been awarded to Kaufman and Associates, Inc.

Assess the findings of the information to better serve the tribes which are in need of resources. Onsite traffic crash record assessments by the contractor will be conducted to better assist the nonreporting tribes.

By the conclusion of the contract, June 30, 2016, the IHSP will have a completed report on the state of traffic crash reporting in Indian Country. This report will include full traffic crash record assessments of several of the agencies in an effort to assist the tribes who have no reporting system.

STRATEGIES:

- Ensure the vendor selected for the traffic records assessment is adhering to the Statement of Work provided in the contract.
- Ensure the vendor is performing the tasks in a timely manner by monitoring monthly status reports.

SUMMARY:

In FY2018 a Tribal Traffic Records contract was awarded this grant year to Kaufman & Associates, Inc. (KAI). The contract is to conduct a Traffic Records Assessment of tribal law enforcement programs throughout Indian Country.

The period of performance concluded in FY2018 and the purpose of the contract was to identify the level underreporting of crashes occurring in Indian Country.

The final report identified a total of 174 tribal law enforcement agencies, all of which were contacted through phone calls and emails. The response rate was 72% with 126 agencies providing a response and 50 agencies 28% did not provide a response due to incorrect contact information, non-response to e-mails, phone calls or unsuccessful attempts to contact the alternate tribal personnel who could provide a response.

The information gained provided these results:

- Thirty-seven (37%) or 47 agencies responded "Yes" they share crash data with the state.
- Forty-two (42%) or 51 agencies responded "No" they do not share crash date with the state.
- Eighteen (18%) or 23 agencies responded they share limited data with the state based on contingencies. These variables include the jurisdiction, location of the crash, if the crash was considered a misdemeanor or felony offense and if the crash involved tribal or non-tribal members.

At the conclusion of the initial assessment, a determination was made KAI would conduct on-site assessments of tribal agencies in order to collect more specific information pertaining to the agency structure, data collection and reporting processes, crash statistics, relationship with the state, successes of local safety efforts and plans for short-term changes to crash reporting and data. Nine agencies were selected:

- San Carlos Apache Tribe in Peridot, AZ
- Confederated Tribes of the Colville Reservation in Nespelem, WA
- Oglala Sioux Tribe in Pine Ridge, SD
- Miccosukee Tribe of Indians in Miami, FL
- Cherokee Nation in Tahlequah, OK
- Walker River Paiute Tribe in Schurz, NV
- Spokane Tribe in Wellpinit, WA
- Hopi Tribe in Keams Canyon, AZ
- Jemez Pueblo in Jemez Pueblo, NM

KAI developed a Tribal Traffic Crash Reporting Assessment which was sent to the agencies which were selected for an on-site visit. The agencies were chosen based on the level of crash reporting and of the eight that responded to the questionnaire; one agency shared crash data with the state, one shared limited crash data and six of the agencies did not share crash data with the state. The elements of the assessment included:

- Tribal Crash Reporting Program Details-8 questions
- Tribal Crash Reporting Program Communication-14 questions
- Traffic Record Accident Information-10 questions
- Creating a Database for Crash Information-20 questions
- Traffic Safety Decision Making-9 questions

The KAI Traffic Crash Reporting Assessment Final Report was submitted at the conclusion of the contract. The report provides all of the assessments and findings of the on-site evaluations.

Tribal Traffic Records data continues to be a priority of the IHSP. The BIA IHSP serves as part of the tribal Safety Management Systems (SMS) Steering Committee. This committee is comprised of members from tribes and other federal agencies such as; National Highway Traffic Safety Administration (NHTSA), Federal Highway Administration (FHWA), Indian Health Service (IHS), Centers for Disease Center (CDC), and Tribal Technical Assistance Programs (TTAPs). A sub-committee of the many members of the SMS Steering Committee serves as the Tribal Traffic Records Coordinating Committee (TTRCC) for the BIA IHSP. The TTRCC will make every effort to meet at least quarterly during FY2017 and develop a multi-year Traffic Records Strategic Plan.

In addition, FY2018 projects will be required to report all traffic related data to the IHSP as it relates to the traffic records program.

Impaired Driving Program Area

The BIA IHSP has over the years funded many projects aimed at reducing the high rates of drinking and driving on the reservations. The program also remains committed to providing training, educational materials and equipment necessary to assist tribal law enforcement officers and police departments in their efforts to remove drunk drivers from the roadways through sustained enforcement efforts.

All funded projects in FY18 signed a commitment to participate in all national traffic safety campaigns. Tribes were also required to participate in and report on, the "Don't Shatter the Dream", Indian State Impaired Driving Mobilization. Funded Tribes participated by conducting checkpoints, saturation patrols and/or enhanced enforcement. Extra funding was added to each project budget for high visibility sustained enforcement throughout the year.

Each of the tribal projects funded in FY18 had an alcohol related performance measure.

Impaired Driving Program Area Target:

The BIA IHSP planned to reduce the incidence of impaired driving by increasing DUI/DWI/OWI arrests by all funded traffic activity within the participating tribes by 20% from the FY2016 total of 4,128 to 4,954 by the end of FY2018.

In FY18: Twenty-six (26) Tribes funded by the BIA IHSP reported 2,795 DUI/DWI/OWI arrests. In FY18: Fifteen (15) Tribes reported conducting 107 checkpoints.

In FY18: Twenty-four (24) Tribes reported conducting 1,019 saturation patrols.

In FY17: Twenty-six (26) of 27 Tribes funded by the BIA IHSP reported 4,664 DUI/DWI/OWI arrests. In FY17: Fourteen (14) Tribes reported conducting 109 checkpoints.

In FY17: Twenty-five (25) Tribes reported conducting 1,028 saturation patrols.

In FY16: Thirty-two (32) of 38 Tribes funded by the BIA IHSP reported 4,128 DUI/DWI/OWI arrests. In FY16: Fourteen (14) Tribes reported conducting 132 checkpoints. In FY16: Twenty-four (24) Tribes reported conducting 1,183 saturation patrols.

In FY15: Thirty-seven (37) Tribes funded by the BIA IHSP reported 5,381 DUI/DWI/OWI arrests. In FY15: Thirty-three (33) Tribes reported conducting 170 checkpoints. In FY15: Thirty-five (35) Tribes reported conducting 693 saturation patrols.

The White Earth Nation, Leech Lake Band of Ojibwe, Upper Sioux and Lower Sioux Tribes in Minnesota and the Shoshone Bannock Tribe in Idaho could not conduct sobriety checkpoints as state law does not permit, but did participate in the saturation patrols.

Note: For each Tribal project, the Reservation Population and Land Base information is from Tiller's Guide to Indian Country updated with 2010 Census data with the exception of the Ramah-Navajo and Upper Sioux Tribes.

TARGET:

To provide support for the continued operation and maintenance of the Breath Alcohol Testing (BAT) Mobiles purchased for use in Indian Country which will result in decreased alcohol related motor vehicle crash injuries and fatalities within the participating Tribes.

PERFORMANCE MEASURES:

To increase the number of times the BAT Mobiles are deployed within the participating tribes from the FY2016 total of 136 to 140 by the end of FY2018.

In FY18 the BAT Mobile was deployed 19 times, in 9 check points, used for traffic control 9 times and once for educational purposes.

To increase use of BAT Mobiles for educational events on the reservations from the FY2016 number of 41 to 45 in FY2018.

In FY18 the BAT Mobile was used for one (1) educational event on the reservation.

To support the tribes the BIA IHSP purchased four (4) BAT Mobiles in FY10. This was a collaborative effort between the IHSP and OJS Districts. The BAT Mobiles are available for tribal use in OJS Districts I (South Dakota), III (Phoenix), IV (Albuquerque), and V (Billings).

The purchase of these BAT Mobiles has allowed Tribes to more effectively combat drunk drivers on the reservations and to decrease alcohol related motor vehicle crash injuries and fatalities within the participating tribes in OJS Districts I, III, IV, and V.

This allowed for a total of approximately seven (7) Tribes and one (1) BIA OJS Agency to have access to the BAT Mobiles in these OJS Districts for education, checkpoint and traffic control use.

The BAT Mobile was utilized in one (1) BIA OJS District IV at sobriety checkpoints and made available for viewing to tribal community members and school students during health fairs and public safety days.



Occupant Protection Program Area

Motor vehicle crashes (MVC's) are the leading cause of death and injuries to Native Americans in the United States. Native Americans are killed at rates at least twice that of all other ethnic groups in this country. These high death rates can be attributed to a number of factors including the low and non-use of safety belts and child passenger safety restraint usage on the reservations.

Occupant Protection Program Area Target:

To increase safety belt usage rates in Indian Country from the FY 2016 "national" Indian Country rate of 77.70% to 80% by the end of FY2018.



Indian Country is now at 78% in 2018. While Native American utilization is still lower than the national rate, there has been progress made in Indian Country; seat belt use will continue to be one of the primary focus areas of the IHSP as seat belt usage continues to rise.

Child Passenger Safety

For several years, the BIA IHSP has collaborated with the Indian Health Service to provide child passenger safety seats for Native American children and child passenger safety support safety materials for clinics, checkpoints and fitting stations for those tribes working with their respective Indian Health Service Injury Prevention Specialists.

In FY18, the BIA IHSP awarded Occupant Protection grants to the Tribes. The BIA IHSP reimbursed a total of **\$109,534.62** to grant funded tribes for child safety seats in FY18.

Police Traffic Services Program Area

The BIA IHSP has remained committed to providing the necessary tools and training that tribal law enforcement departments need in order to effectively enforce traffic laws and ordinances.

All Tribal law enforcement agencies funded in FY18 signed commitments to participate in all national mobilizations as well as enhanced enforcement at other times of the year and sustained enforcement throughout the year. Additionally, extra funding was added to each project so they could conduct high visibility enforcement throughout the year.

The BIA IHSP staff depends on the NHTSA Region 6 Media Consultant to provide mobilization campaign material to distribute to tribes nationwide. It is invaluable during the national mobilizations the grant funded Tribes are required to participate in. The media services were available but didn't provide much for the tribes to utilize in this time period.

The BIA IHSP Director provided one site visit to the following tribes: Cheyenne River Sioux Tribe, Pueblo of Laguna, and Pueblo of Acoma law enforcement, along with Pyramid Lake Paiute Tribe child protection seat grant programs.

The site visit was used to ensure compliance with grant agreement requirements and evaluate the project progress toward stated goals.

In FY18, the BIA IHSP Director and Program Coordinator continued to evaluate and assist tribes to meet their performance measures/targets. Tribal Police departments had difficulty in meeting their overall and individual performance measures. This could be due to high visibility enforcement which would deter traffic infractions and keep impaired drivers off the road. It should be noted Tribal Police Departments issued 23,237 verbal and written warnings during the grant year. This may not be effective to change driver behavior, it illustrates Tribal Police are making vehicle contacts.

Police Traffic Services (PTS) Program Area Target:

To reduce the number of speed related fatalities on Indian reservations by 3% from the 2015 FARS number of 108 to 105 by the end of FY2018. FARS 2015 reported 125 speed related fatalities on reservations.

Twenty-six (26) Tribes funded by the BIA IHSP in FY18 reported a total of 20 speed-related motor vehicle fatalities on their reservations during the project year. This target was met.

The BIA IHSP planned to increase the number of citations issued for speed on Indian reservations by 6% from the FY2016 number of 39,396 to 41,614 by the end of FY2018.

Twenty-six (26) Tribes funded by the BIA IHSP in FY18 reported 29,217 speed citations issued during the project year. This target was not met and could be the result of high visibility enforcement.

To increase the number of citations issued for other moving violations (excluding speed and DUI), on Indian reservations, by 12% from the FY2016 number of 33,947 to 38,023 by the end of FY2018.

Twenty-six (26) Tribes funded by the BIA IHSP in FY18 reported 19,162 traffic violation citations. The target was not met. This could be due to high visibility traffic enforcement.

To decrease the number of motorcyclist fatalities on Indian reservations by 12% from the 2014

FARS number of 25 to 22 by the end of FY2018.

Number of motorcyclist fatalities reported by 26 funded Tribes was 0.

Number of un-helmeted motorcyclists was 0.

To decrease the number of pedestrian fatalities on Indian reservations by 20% from the 2014 FARS number of 54 to 45 by the end of FY2018.

Number of pedestrian fatalities reported by 26 Tribes in FY18 was 9.

FY18 Core Outcome Measures

A-1 Core Measure: Seat belt citations issued during grant-funded enforcement activities current:

In FY18: Twenty-six (26) Tribes reported 2,816 seat belt citations issued.

A-2 Core Measure: Impaired driving arrests made during grant-funded enforcements activities current:

In FY18: Twenty-six (26) Tribes reported 2,795 DUI/OWI arrests were made.

A-3 Core Measure: Speeding citations issued during the grant-funded enforcement activities current:

In FY18: Twenty-six (26) Tribes reported 29,217 speed citations were issued.

B-1 Core Measure: To increase safety belt usage rates in Indian Country from the FY 2016 "national" Indian Country rate of 77.70% to 80% by the end of FY2018.

In FY18: Indian Country is now at 78%.

C-1 Core Measure: To reduce all fatalities on Indian reservations by 11% from the 2014 FARS number of 359 to 318 by the end of FY2018. According to 2015 FARS data there were 369 motor vehicle fatalities on reservations. FARs shows motor vehicle crash fatalities have continued to rise from the 316 reported in 2013 to 369 reported in FY15.

In FY18: Twenty-six (26) Tribes reported a total of 51 motor vehicle fatalities.

C-4 Core Measure: To reduce the total number of un-restrained passenger vehicle occupant fatalities, all seat positions by 9% from the 2014 FARs number of 166 to 152 by the end of FY2018. Current FARS 2015 data reflects 166 un-restrained passenger vehicle occupant fatalities all seat positions remains the same as what was reported in FARS 2014. Un-restrained passenger vehicle-occupant fatalities all seat positions have not increased or decreased but has stayed the same the last two years.

In FY18: Twenty-six (26) Tribes reported a total of 3,218 motor vehicle crashes (MVC's) on their reservations. Of this number 51 were motor vehicle crash fatalities and 23 of the people killed were not wearing seat belts.

C-5 Core Measure: Reduce crash fatalities on Indian reservations involving drivers or motorcycle operators with a BAC of 0.08 or above by 17% from the FARS 2014 number of 133 to 111 by the end of FY2018. Current 2015 FARS data reflects the number of on reservation fatalities in crashes involving a driver/motorcycle rider increased to 168.

In FY18: Twenty-six (26) funded Tribes reported a total of 19 fatalities with drivers with .08+ BAC.

C-6 Core Measure: To reduce the number of speed related fatalities on Indian reservations by 3% from the 2015 FARS number of 108 to 105 by the end of FY2018. Current 2015 FARs data reflects an upward trend of 125 fatalities on reservations. According to FARS speed related fatalities increased from the FY2014 number of 108 to 125 in FY2015.

In FY18: Twenty-six (26) funded Tribes reported a total of 20 speed-related motor vehicle fatalities on their reservations during the project year.

C-7 Core Measure: To decrease the number of motorcyclist fatalities on Indian reservations by 12% from the 2014 FARS number of 25 to 22 by the end of FY2018. Current FARS 2015 data shows

motorcyclist fatalities decreased to 22 on reservations. FARS 2013 number of 18 reveals motorcyclist fatalities have steadily increased on Indian reservations according to FARS 2015 number of 22.

In FY18: Twenty-six (26) funded tribes reported 0 motorcyclist fatalities on their reservations during the project year.

C-8 Core Measure: To reduce the number of un-helmeted motorcyclist fatalities on reservations from 2014 FARS number of 13 to 11 by the end of 2018. Current 2015 FARs data reflects a downward trend of un-helmeted motorcycle fatalities on reservations to 6 from the FARS 2013 number of 13.

In **FY18:** Twenty-six (26) funded tribes reported 0 un-helmeted motorcyclist fatality on their reservations during the project year.

C-9 Core Measure: To decrease the number of drivers 20 or younger on reservations involved in fatal crashes from 2014 FARS number of 18 to 13 in 2018. Current 2015 FARS data reveals a downward trend of 15 driver fatalities age 20 and younger on reservations compared to FARS 2014 number of 18.

In FY18: Twenty-six (26) funded tribes reported a total of 5 fatalities of drivers 20 or younger fatalities on their reservations during the project year.

C-10 Core Measure: To reduce the number of pedestrians involved in fatal crashes on reservations from 2014 FARS number of 54 to 45 in 2018. Current FARS data from 2015 shows an increase in pedestrian fatalities on reservations at 58 since FARS reported 23 in 2012. Pedestrian fatalities continue in an upward trend according to FAR data from 2012 to 2015.

In FY18: Twenty-six (26) funded tribes reported a total of 9 pedestrian fatalities on their reservations during the project year.





SUMMARY:

The Shoshone Bannock Tribes did not fully expend grant funding awarded in FY18. The Police Department did not hire a full-time HSO but purchased all equipment awarded (1 Radar/Lidar; 2 PBT's, 1 Speed Trailer).

The Shoshone Bannock Tribes Patrol Division stepped up and were able to meet all their goals for FY2018 with the exception of speeding. Increasing speed citations goal was not met due to Officers having to respond to other calls as well as enforce traffic. The Police Department met their targets in reducing MVCF, along with fatalities in crashes involving a driver with a BAC of 0.08+, MVC's, and exceeded DUI arrests by 9 during the FY18 grant year.

Officers participated Summer Jurassic Kids Day event in August where they discussed traffic safety tips such as seatbelts, dangers of texting and driving, drinking and driving, etc.





SUMMARY:

Red Lake Band of Chippewa Indians was originally awarded \$272,085.00 and requested an additional amount of \$100,906.65 for a total of \$392,383.90; inwhich they expended \$291,477.25 during the FY18 grant year. The Tribal Police Department did not meet their goals because the Tribe experienced a computer virus that affected the entire Tribe along with the Police Department records along with highway safety statistics. The virus also affected mobile ticket writers installed in police units. The department was forced to hand write tickets and assign cad numbers. The entire Police Department engaged in a search for a missing fishermen on the lake, which took Officers off the road for several weeks. Therefore, the two incidents affected traffic safety/enforcement statistics. Officers were also not able to work grant funded overtime due to these issues.

The RLPD also had another year of reaching Zero Deaths, which is a huge accomplishment. This proves grant funding is assisting the HSO's and RLPD in making a difference in the community. The Red Lake Police Department (RLPD) participated in 3 mobilizations, provided 2 traffic safety presentations, issued 282 safety belt and 30 child protection seat ciations. The RLPD plans to work with Officers in the department to conduct more traffic stops, in order to increase the number of DUI arrests. The RLPD also noticed Patrol Officers rely on the HSO's to conduct most of the traffic stops. This issue will be corrected as the RLPD realizes overall participation in traffic Safety is required to make a bigger

difference within the community. Another highlight is the distracted driving law which was passed through the RLPD's participation with the Red Lake Tribal Code meetings. The highway safety grant is making a safer driving environment for the Red Lake Indian Reservation, due to the enforcement from the HSO's.

The RLPD was granted additional funding to purchase a SIDNE, and 2 Dodge Durangos with equipment. The RLPD purchased a SIDNE, with grant funding, which is a mobile go cart, that is utilized to teach teens on the effects of impaired driving. The SIDNE machine has been a huge success as teens line up to test out the machine and has generated community involvement. Grant funding also assisted the RLPD in purchasing two 2018 Dodge Durango's with equipment (2 radars, in car video, speakers) due to a shortage of police units. Three radar/lidars, and traffic cones were also purchased for the grant program.



SUMMARY:

Leech Lake Tribal Police Department (LLTPD) was unable to expend wages and overtime because they had 1 HSO vacancy for 3 months due to human resource issues. The LLTPD was also short staffed at the same time the HSO position was advertised.

LLTPD met their targets for reducing MVCF and pedestrian fatalities, and MVC's. They did not meet their goals to increase DUI arrests and speed citations for the grant year. The LLTPD issued 1,404 written and verbal warnings in FY18. The grant program participated in 3 mandatory mobilizations, issued 14 seat belt citations along with 1 child passenger safety seat citation, and conducted 16 saturation patrols during the grant year.

The Prodject Coordinator, HSO, and Crime Data Analyst attended the LifeSavers Conference under grant funding. They

also provided the LLTPD with new knowledge and approaches on testing individuals under the influence of drugs/alcohol. LifeSavers Conference also allowed them to network with other agencies on different tactics and how to curb traffic crime. HSO's provided traffic presentations in the community emphasizing the dangers of texting while driving and under the influence of drugs/alcohol to teenagers and parents. LLTPD held it's annual National Night Out with over 500 community members. HSO's teamed up with the National Guard and created an obstacle course using Go-Karts and fatal vision goggles to show the different effects of driving under the influence of alcohol/drugs. Grant funding allowed the HSO and another Officer to attended DMT certification training.

LLTPD also purchased a radar trailer which assisted in reducing speeding in rural areas and at Powwow locations. They also purchase a new Getac and Toughbook for HSO's along with 2 signal boosters.





SUMMARY:

The Upper Sioux Community did not fully expend FY18 grant funding due to delays in hiring a HSO and the loss of 3 Police Officers who worked grant funded overtime shifts.

The Upper Sioux Community met all targets for the FY18 grant year. The Police Department also issued 257 traffic citations, 275 speed citations, 49 safety belt citations, and 5 child passenger safety seat citations. They also conducted 94 saturation patrols and provided 2 traffic safety presentations to the community.

Grant funding allowed Officers to attend and complete standardized field sobriety testing, advanced roadside impaired driver evaluation, DMT-G breath testing for alcohol impairment and Drug Recognition Expert Training. With these enhancements to the Upper Sioux Community Police Department traffic's safety program they have improved overall traffic safety in their community. Grant funding also assisted the tribe in purchasing 1 police unit with a light bar, and digital citation software.







SUMMARY:

The White Earth Nation was originally awarded \$271,560.00 and requested an additional amount of \$227,015.52 for a total of \$498,575.52; inwhich they expended \$309,225.56 during the FY18 grant year. They increased their statistics, educational presentations, training, and other activities, but did not expend funding in other line items.

The White Earth Nation Police Department (WENPD) did not meet all of their goals for the grant year despite the amount of traffic citations, media releases, and proactive measures they took on traffic safety and enforcement. There were 6 MVC fatalities of which 4 were alcohol related, 197 MVC's and 875 speed citations issued. They also issued 2,219 traffic citations and gave 3,605 written and/or verbal traffic warnings during the grant year. The large number of warnings could have kept the grant program from reaching their goals.

One of the Tribes biggest accomplishments was their seatbelt usage went from 82% to 86%. The White Earth Police Department provided a lot of educational presentations during the FY18 year; along with conducting a successful mock crash.

WENPD was granted additional funding for a 3rd HSO position 1 Chevy Tahoe with radar, and in car video. Grant funding also assisted the tribe in purchasing a digital camera, 2 laptops, and 2 lidars.





SUMMARY:

The Turtle Mountain Band of Chippewa did not fully expend grant funding for FY18. The HSO was hired later in the grant year and the Chief of Police retired. In order to reduce tribal budget shortfalls the Tribal Council did not allow tribal employees to work overtime; this affected expending the overtime budget awarded for the FY18 grant year.

Turtle Mountain Band of Chippewa Police Department (TMBCPD) reduced MVCF to 0 by the end of the grant year. The MVC target was not met along with increasing DWI arrests and traffic citations. The HSO also suffered some work related injuries and was assigned to light duty, which took the HSO off the road. TMBCPD staffing shortages, within the department also kept them from reaching their goals. Aside from the shortfalls, the TMBCPD issued 33 safety belt citations, participated in 2 saturation patrols and conducted 1 traffic safety presentation.

Under grant funding the Project Coordinator attended Program Management training in Albuquerque, NM along with the HSO. The HSO networked at the Introduction to Injury Prevention training at Sky Dancer Casino in Belcourt, ND, and was able to give a brief overview of the grant and talk about observations on seatbelt use in the Turtle Mountain community. TMBCPD's biggest achievement was 0 traffic related fatalities on the reservation during the grant year.



The program also purchased a Buckle Up Bear from Safer New Mexico to put on traffic presentations within schools and local community.





SUMMARY:

The Pueblo of Isleta (POI) was orignally awarded \$444,800.00 and requested an additional \$147,831.00 for a total of \$592,631.00; inwhich they expended 549,583.16 for the grant year. They did not expend all their funding due to patrol officer shortage, traffic officers were used to assist on short shifts for coverage which resulted in increased disallowances for salary. During the FY18 grant year the Pueblo of Isleta Police Department (POIPD) purchased 4 new 2018 Chevy Tahoes with lightbars, siren speakers, radar and in car video cameras for the Highway Safety Officers to use to for traffic safety and enforcement.

The POIPD did not reach their projected goals for the FY18 grant year. The POIPD did not maintain MVCF's at 0 and ended the grant year with 3 fatalities. Two (2) of the 3 MVC fatalities were pedestrian vs. vehicle crashes on the freeway that involved pedestrians and the fatalities were alcohol related. The POI Governor sent out a directive that did not allow Traffic Officers to patrol the interstate which may have possibly led to an increase in traffic crashes. The POIPD was not able to reach their targets due to the lack of man power. One of the HSO's vacated their position in July and the tribe was not able to fill the position before the FY18 grant year ending.

Although the POIPD was short staffed and directred not to patrol the interstate, they issued 591 safety belt citations and 40 child passenger safety seat citations during the grant year. Three (3) of the 4 HSO's are child safety seat certifed. Grant funding also made it possible to rent a billboard with a Buckle Up Message to be posted during the Gathering of Nations. Four (4) of the HSO's are lidar/radar certified and of the 5,297 speed citations issued 4,700 were issed by the HSO's; therefore this certification assisted in making valid citation stops. The HSO's also made 4,161 of the 4,694 DUI arrests made by the Police Department during the grant year.



SUMMARY:

The Pueblo of Jemez Police Department (POJPD) was not able to expend all their funding due to the Santa Fe National Forest and all recreational areas being closed for the month of June, which greatly affected the amount of traffic on NM State Road 4. This resulted in a drop in overtime and saturation patrols. The POJPD did not expend the \$4,000.00 for the software E-Citation invoice because the support and maintenance was received after the closing date of the FY18 grant year; therefore the invoice was not paid from FY18 grant funding.

The POJPD met the their target of maintaining MVC fatalities and speed related fataliaties by 0 during the FY18 grant year. The POJPD has one Highway Safety Officer but they began their grant year with three less officers which reduced patrol coverage and as a result also reduce the number of citations issued. The reduction in manpower effected the number of officers who signed up to work the special saturation patrols and overtime assignents.





SUMMARY:

The Pueblo of Laguna expended approximately 96% of grant funding awarded in FY18, despite the resignation of one HSO. One less HSO did not keep the Tribal Police Department from meeting their targets or coming close to meeting them. The Police Department worked diligently in exceeding their goal to reduce MVC fatalities by ending the grant year with 0 fatalities. They also met their goals in 108 DUI arrests and 3,665 speed citations issued during the grant year. The Police Departement almost met their goal of reducing MVC's by 189 for the grant year but ended with 190 missing the target by 1. Missing the MVC target by 1 can still be considered a success for the department because high visibility enforcement is making the Pueblo's roadways safer for their community. High visibility enforcement could also be attributed to the decreased number of traffic citations issued, the department ended the grant year with 1,185 traffic citations which was 104 less then their project target for FY18. The Police Department also issued 1,117 traffic warnings during the FY18 grant year. The Police Department also had 1 checkpoint and 39 saturation patrols.



SUMMARY:

The Oglala Sioux Tribe (OST) almost expended all their grant awarded funding. The Oglala Sioux Tribe Police Department (OSTPD) did not meet their DUI/DWI arrests goal because they discovered the vehicles stopped had designated sober drivers with impaired passengers. Reported drunk drivers or suspected drunk drivers failed to stop, resulting in a pursuit with suspect vehicle fleeing into another jurisdiction and driver was unidentifible. Speeding citations were also not met because Officers issued too many speed warnings instead of citations because they thought the warnings and citations would all be counted as tickets. Inclimate weather conditions also kept drivers from speeding during the winter months.

The OSTD HSO's have been conducting traffic crash investigations/reconstructions with the Leica Robotic Total Station. HSO's attended training and now do all the fatal motor vehicle crash investigations and reconstructions of

MVC's that occur within the reservation boundaries. The OSTPD no longer request the assistance of the State Highway Patrol. The OSTPD has 1 Federal court conviction stemming from a fatal MVC involving alcohol. 1 HSO is a Crash Reconstructionist, and all HSOs have attented Advanced Accident Investigations and Crash Data Recorder training. The HSO's designed the Tribes own seat belt/car seat road signage and l sign is presently up along BIA 41 and working on getting 7 more signs up. The HSO's partner with the Indian Health Service Office of Environmental Health & Engineering in conducting seat belt surveys in Pine Ridge Village. FY18 driver seatbelt use rate is 70%, which is an increase by 9% from FY17 and the passenger use rate is 58% which is a 2% increase from FY1 7. HSO presentations include a television news video to stress the importance of seat belt use and child safety seats in saving lives.

All HSO's and Officers now have equipment in their units and received training to complete and issue electronic traffic tickets. The Oglala Sioux Tribe, Department of Public Safety, Highway Safety received the "2018 Excellence in Public Safety" award, and the "2018 Administrative Excellence" award to the Project Coordinator/ Data Clerk.



The grant program also participated in 3 mobilizations and put on 2 traffic safety presentations.

CRSTPD purchased a radar trailer with grant funding and used it to collect data during the Labor Day Fair & Rodeo. The CRSTPD also used the BAT mobile during their largest checkpoint.





The Sisseton Wahpeton Sioux Tribal Police Department (SWSTPD) expended more than 75% of their FY18 grant budget. The SWSTPD's did not reach a majority of their targets for the FY18 grant year. MVC fatalities increased instead of decreased. Officers issued 2272 verbal/written warnings which may have kept the SWSTPD from reach their traffic citation goal. The SWSTPD also did not meet their DUI target which could have been the result of the jail shutting down in October 2016 which forced the SWSTPD to transport detainees to jails in the surrounding agencies. There were many instances in which the jails were full. The SWSTPD did meet their target in reducing MVC's. Grant funding assisted the SWSTPD in purchasing 2 radars and 1 intoxilyzer. The radars assisted in detecting speeding vehicles. The intoxilyzer assisted with DUI stops in detecting alcohol impaired drivers.





SUMMARY:

Confederated Tribes and Bands of the Yakama Nation did not fully expend their funding for the FY18 grant year. The HSO's and Patrol Officers engaged in unallowable non-traffic related activity during the grant year. The grant program also had difficulty generating ledgers and other supporting documentation to support reimbursement claims which resulted in disallowed costs. The grant program also puchased equipment at prices that were lower than the amount awarded in the grant budget.

Confederated Tribes and Bands of the Yakama Nation Police Department (CTBYNPD) met 3 of their 4 targets. CTBYNPD was not able to reduce the number of MVC's on the reservation ending the grant year with a total of 442 MVC's. During the grant year the CTBYNPD responded to a high number of motor vehicle collisions and has increased jurisdiction within the reservation boudaries.

CTBYNPD gained better understanding of the IHSP and its requirements during the grant year, along with the importance of participating in all mobilizations. The CTBYNPD was successful in hiring an HSO who was fully dedicated to traffic enforcement.



SUMMARY:

Three Affiliated Tribes Police Department (TATPD) did not fully expend their grant funding because they did not have a full-time employee dedicated to properly providing assistance for the Highway Safety Program. The Project Coordinator is located off the reservation more than 50 miles and is currently working through a satellite office with little to no contact with law enforcement staff. Poor documentation, untimely submission of RFR reports did affect the reimbursement status for TATPD. Highway safety positions were not filled immediately at the beginning of FY2018.

TATPD met 2 of their 5 goals during the FY18 grant year. They reduced the number of MVC fatalities along with unrestrained occupants all seat position fatalities by 0. They came short, by 1 citation, in achieving 529 speed citations issued for the year. TATPD did not decrease the number of MVC's and increase DUI arrests. Due to the oil field traffic that currently affects the Three Affiliated Tribes. DUI/OWI arrests were not properly documented throughout the year due to the lack of knowledge of the data system currently utilized the TATPD.





SUMMARY:

Menominee Indian Tribe of Wisconsin did not fully expend their FY18 grant budget because they experienced a cost savings in salary and fringe, during the grant year. The HSO was terminated early in the grant year and the HSO position was vacant for a few weeks. The new HSO had lower health insurance coverage which led to a cost savings in the fringe line item.

Menominee Indian Tribe of Wisconsin Police Department (MITWPD) achieved 2 of their 3 goals for the grant year. They reduced MVC fatalities by 75% when their goal was a 25% reduction. They also reduced motor vehicle crashes by more than 18%, when their goal was a 10% reduction in MVC's. The MITWPD did not reach the goal of increasing their DUI/OWI arrests. The goal was to increase DUI/OWI arrests by 29% but they were only able to increase arrests by 12%. Reduced crashes, fatalities and arrests are indicative of positive efforts being made to ensure the safety of the motoring public. Enforcement and education are paying dividends for the tribes citizens. The MITWPD will continue to be vigilant in their efforts to remove unsafe drivers from their roadways.

MITWPD's biggest accomplisment of this fiscal year was utilizing grant funding to replace the police departments records management system with the Zuercher Records Management System.





San Carlos Apache Tribe did not fully expended FY18 grant funding due to the department being under staffed and being a full-time grant program. The San Carlos Apache Tribe Police Department (SCATPD) hired a lateral officer. Being understaffed with Patrol Officers forced us to use the HSO to assist with everyday emergency incidents that were not traffic related. Understaffing in SCATPD also kept the grant program from meeting their targets. Although the SCATPD was short staffed it did not keep the HSO from providing traffic safety presentations to the community and in the schools.

The highlights of the year was the SCATPD participating in the "Drive Sober or Get Pulled Over" mobilization event even though the SCATPD was short staffed. They conducted 2 checkpoint and 9 saturation patrols. SCATPD also partnered with San Carlos Healthcare to conduct a child carseat checkpoint. In this carseat checkpoint Officers issued 14 citations for seatbelt violations and made 1 DUI arrest.





SUMMARY:

Fort McDowell Yavapai Nation almost expended their full grant award for FY18. Fort McDowell Yavapai Nation Police Department (FMYNPD) did not achieve any of their targeted goals for the FY18. MVC's increased because the Officers responded to private property crashes in the tribes Casino parking lot and surrounding area. The FMYNPD did not meet their DUI arrests target but they increased their overall arrests from the previous year. High visibility enforcement and mobilizations might have kept impaired drivers off the roadways. FMYNPD also did not meet their target goal on speed citations as well. The FMYNPD issued 364 warrings, with 90% of them being speed related.

FMYNPD participated in all three mandatory mobilizations and also conducted other impaired and distracted driver mobilizations. Over a 12 month period they had Officers enforcing traffic an extra 2,300 hours during the grant year.







SUMMARY:

Chippewa Cree Tribe did not expend all of the grant funding awarded in FY18. The Police Department was not able to account for 100% traffic activity in the requests or reimbursments. The Tribal Police Department made changes and understands the grant program, what is required and has made improvements for the success of the program in the future.

The Tribal Police Department met 4 of their grant targets for the grant year. As overtime grant officers were aggressive in exceeding their targets in speed citations, traffic citations, and maintained MVC fatalities and unrestrained (all seat positions) fatalities at 0 during the grant year. The Tribal Police Department did not meet the goal of reducing MVC's but there are multiple factors to consider with this target. The goal was not met because of the harsh winter months and icy and snowpacked road conditions. Aside from not reaching the MVC target Officers were agressively patrolling the roadways and enforcing traffic.

FY18 highlights are the increased participation and effectiveness of overtime mobilizations and check points conducted.

This helped the Department not only meet most of all their goals but exceed them with high numbers compared to previous grant years.

FY18 achievements are the number of DUI arrests and citations issued by the Police Department. Within these areas we exceeded our goals and the Police Department took a more aggressive stance on traffic safety and enforcement. Futhermore, the police department and officers achieved a better understanding of the grant as a whole, allowing for more effective and efficient reporting for the RFR. Data collection is being enhanced and more data is being gathered on speeding and other citations in order to do assessments on the roadways within the reservation.

The Saint Regis Mohawk Tribal Police Department did not achieve any of the targets for the grant year. Saint Regis Mohawk Tribe had their first MVC fatality in April during an early spring snowstorm. Weather, speed and alcohol were the contributing factors for this fatality. A majority of the MVC's occurred at the local casino parking lot. Increased DWI arrests, traffic and speed citations targets were not met but this could be attributed to the loss of 4 Officers, which resulted in a lower number of Patrol Officers. The shortage of Officers has affected the traffic enforcement, Officers are covering shifts in order to respond to other calls not allowable under grant funding.





SUMMARY:

The Lummi Nation Police Department (LNPD) did not fully expend funds awarded in the FY18 grant year. LNPD is still recovering from a high turn over in Officers for the past three years. The LNPD achieved all their targets with the exception of MVC's. Lummi Nation suffered harsh winters and rainy seasons which results in an increased number of MVC's.

The LNPD conducted a SIDNE presentation at the Lummi Nation School and educated high school juniors and seniors on the dangers of distracted driving and drunk driving. They also held a SIDNE presentation for Lummi Elders, Law and Justice members and the community; in which about 30 adults and children attended. The LNPD put on a car seat safety presentation in conjunction with the Lummi Head Start and were available for Q&A despite not having an experienced CPS technician. The grant program also purchased 3 radar/lidars during the grant year.





SUMMARY:

Lac Courte Oreilles Band of Lake Superior Chippewa Police Department did not fully expend the FY18 grant award. They attribute this to a change in policy, in which all personnel are required to use their accrued PTO or they would lose it at the end of the fiscal year. This caused many of the Officers to use their accrued PTO. This new policy prevented Officers from working as many traffic shifts as they normally would have.

The Police Department did not reach two of their 5 goals during the grant year. MVC's increased due to inclimate weather. The grant program did not achieve their DWI goal because Officers discovered 75% of their traffic stops, involving alcohol, had a designated driver.

FY18 highlight for the Police Department resulting from 2 traffic stops. One (1) traffic stop resulted in 7 charges for 3 gm bags of THC, 3 bags of meth residue, 1 bindle of crushed prescription drugs, 1 meth pipe, 7 needles, 27 gm bags and

straw. Second traffic stop led to the discovery of partially loaded needles with meth, narcotics, 66 unused gm bags (some with residue) empty needles, scales and grinders resulting in 10 charges from the traffic stop.

The Police Department sent Officers to Lifesvers Conference and exceeded their goal for total citations, exluding OWI's. By attending BIA IHSP Program Management training the Police Department was successful in managing their 2018 overtime grant.

SUMMARY:

The 21 law enforcement agencies reported a total of 2,307 hours on traffic enforcement during the mobilization. One (1) fatality was reported during this mobilization.

MOBILIZATION AND MEDIA ACTIVITY

In FY18 the BIA IHSP reimbursed funded projects for media activity expenses totaling \$19,816.26. This included billboard rentals, radio and other media outlets. Posters and flyers were displaced in communities, schools and bus stops. Newsletters and e-mail were sent out to tribal community and staff. Highway signs were also posted.

LOOKING TO THE FUTURE

In summary, FY18 was a challenging and successful year for the Tribes funded by the IHSP. We will continue to be dedicated to working closely with the Tribes and strive to remain in close partnership with all our traffic safety partners.

2018 has disclosed several issues that will be reviewed and addressed in 2019. They include:

- Maintaining tribal project monthly and annual reporting
- Officer productivity must be encouraged to change behavior on tribal roads
- Traffic data collection must become a priority for tribes
- The utilization of BAT Mobiles must increase significantly
- Continued efforts for the IHSP outreach to tribal youth through educational programs.

Motor vehicle crash fatalities have decreased within the projects funded by IHSP from FY16 (79) to FY18 (51). The percentage of Alcohol involved is noted to be 50.9%, excessive speed at 39.2% and non-seat belt use is at 45.0% in the fatal crashes reported. Continuing to increase enforcement efforts in all of these areas will be made in FY19.

Fulltime and overtime grant programs worked aggressively on traffic safety/enforcement and impaired driving laws in FY18. Although the IHSP collectively didn't achieve the targets and goals in some areas for FY2018, it must be noted the tribal programs reported 23,237 verbal and written warnings. The warnings are generated by vehicle stops The Highway Safety Officers funded under this grant often work in difficult political, economic and physical environments and we will continue to support and encourage their efforts throughout the year.

The IHSP plans to continue to work toward meeting and surpassing the Performance Measures/Targets outlined in our FY19 HSP. The IHSP is prepared to meet the targets and challenges in the coming year. The IHSP will continue to provide technical assistance to each tribe when requested.

The IHSP will renew its efforts in FY19 to improve the collection of traffic data and to make it the cornerstone of the highway safety program. Sharing of traffic statistics among all stakeholders will enable tribes to improve performance and save lives.

Police Traffic Services and Enforcement is currently the main focus. The IHSP would like to focus more on behavior change through education and treatment in DWI court programs, community educational programs and youth programs with the implementation of Tribal Student Drivers Education Programs.

In FY19 the IHSP will continue to offer Occupant Protection Grants to the tribes and will follow through on positive working relationships with the tribes whom have received grants.

As always, we appreciate the guidance and assistance of the NHTSA Region 6 Staff and acknowledge and thank all of our traffic safety partners.
