## Harmonization Activities -Preliminary Implications for NHTSA

Dummy Harmonization Task Group Meeting November 2011

## Background

- As a customer NHTSA is monitoring the Global Task Group's recommendations for harmonization of the FT and DN brands.
- NHTSA acknowledges that differences in component details sometimes exist between the brands, however they have always been required to meet the specifications in the Code of Federal Regulations.
- We have preliminarily identified a few harmonized parts that have known implications to our dummy fleet.

# Harmonization's Implications for NHTSA

- Dummies and replacement parts for use in FMVSS testing are procured through contracts with Humanetics. Dummies and replacement parts must meet CFR Part 572.
- NHTSA uses inspection and qualification tests to verify the dummies meet the CFR.
- Our process will be no different for harmonized parts applied to our FT and DN dummies.
- NHTSA does plan to run testing where issues are known and will perform additional testing if necessary.
